

This Resolution will simply establish a Commission of 6 people from the General Assembly & 3 appointed by the Speaker of the House, and 3 appointed by the Minority Leader to have some hearings this summer and take testimony from people who wish to give us the information that they have in regard to activities by cults in Illinois. Now, we are trying to keep this totally in the gray area so that we don't confuse the Constitutionality of the project. No religious organization operating legitimatly in Illinois has anything at all to hear from this legislation. We hope to simply look for the possibilities of illegal operation by cults in Illinois. The people of Illinois have a right to be informed so that if we have a religion for personal profit situation, the people of Illinois may be forewarned. The Commission will operate without compensation, holding the hearings and making a report back to this General Assembly in October. We have absolutely no basis for the Attorney General's Office in Illinois to investigate operation of cults other than the accounting of funds. Lying in Interim-Study is a vehicle that could be used should we find that we are actually being overrun in the State of Illinois by cult activities that border on illegal operation or operation by a coercion. What they are using to coerce young people to join their organization is a question. And all we want to do is hear the testimony and evalute it for what it may produce. Τ would ask you to cooperate with me and the people of the State of Illinois to bring forth facts for our considera-I would ask you for a favorable Roll Call." tion.

But once we give the authority for a Commission, and I frankly think this is blatantly Unconstitutional Resolution anyway, but once we give the authority to a Commission, or any other group of people that go out and have the discretion to bring in witnesses and subpoena witnesses and so forth, we really have created the groundwork for something that just flies in the face of freedom of religious association in Illinois and around the country. And I think before you vote on this, you'd better realize what the potential ramifications are.
