Speaker Redmond: "House will come to order. Members please

be in their seats. Be led in prayer by the Reverend

Krueger, the House Chaplain."

Krueger: "I want to apologize for my appearance, but I can't get my shirt and tie on because something!shhappend to my arm. In the Name of the Father, the Son, and the Holy Ghost. Amen. O Lord, bless this House to Thy service this day. Amen. Henry Ward Beecher said, 'Though the world needs reproof and correction it needs kindness more. Though it needs the grasp of a strong hand it needs, too the open palm of love and tenderness'. Let us pray. Eternal Lord God, we thy loving servants, do give Thee praise and thanksgiving for this day in our lives. Speaker Redmond: "Representative Taylor Pouncey, Pledge of Allegiance."

Pouncey: "I pledge allegiance to the flag of the United

Liberty and Justice for all."

Speaker Redmond: "Ther regular Session will stand in recess
till the call of the Chair. Now the third Special
Session will come to order. Representative...Father
Kruger will announce the benediction."

Krueger: "In the Name of the Father, and the Son, and the Holy Ghost. Amen. O Lord, bless this House and thy service this day. Amen. It was Nikolai Lenin who said, 'The way to crush the bourgeoisie is to grind them between the millstones of taxation and inflation. Let



us pray. Lord God almighty, of Thy good providence do Thou guide the Members of this House of Representatives now assembled in Special Session. Enable them, O Lord, to seek goals that are not transitory or illusive; to enact such legislation that will serve, protect and extend the democratic process and thus prosper human rights and dignity within the framework of constitutional government. Let none suffer for the benefit of others, that peace and abundance may be freely earned and freely served; through Jesus Christ our Lord. Amen."

Speaker Redmond: "Representative Polk, Pledge of Alliegance."

Polk: "I pledge alliegance to the flag of the United

States of America, and to the republic for which it stands, one nation under God, indivisible, with Liberty and Justice for all."

Speaker Redmond: "Third Special Session stand in recess till

the call of the Chair. We had a Rules Committee meeting

standard of the attendance is rather scarce and sparse

so we adjourned that till 5:00. Representative Friedrich."

Friedrich: "I presume it's your... not your intention to call it till after Rules Committee adjourns. Right? I thought the Members would like to know if they know it's not going to be called."

Speaker Redmond: "Well, we don't have enough people here to
do very much of anything. If all of a sudden they
should come in here and there's something noncontroversial
we could pass, I'd just as soon do it."

Friedrich: "Well, Mr. Speaker, this is the thing that does on. Your office is right behind your podium. Mine's across the street and about the time I get over there you'll call the Session. It's kind of a distrubance and I should get this to you before. This running back and forth about the time you get over there you call us back. Now it would be helpful if we knew we weren't going to be back till after the Rules



Committee meeting."

Speaker Redmond: "Well, what's the pleasure of the Body?

Those that want to... Those that want to recess until after the Rules Committee say 'aye'. Those that would rather wait to the call of the Chair say 'aye'. It would seem to me that they just want to hang loose now Representative Friedrich. I can't tell you.

They seem to be streaming in there now. We may be able to get some business. You got a Calendar Jack? Representative Pierce, do you have any further word from Samantha? Any further word from Samantha Representative Pierce?"

Pierce: "Samantha was unable to meet with the Democratic tax and spending limitation task force this week.

Just when we went to meet with her, they said she had to go usurate. Something to do with usury... unsurate.

And the people got it again and I think that we should very... be very proud of our record. In one fell swoop, we're raising the mortgage rate from 11 to 14% and I was happy to participate in that. Thank you Mr. Speaker. That's the last action of our tax and spending Democratic task force."

Speaker Redmond: "Representative Boecek."

Boecek: "Mr. Speaker, Representative Winchester's secretary is going to take a flight today at 5:00. She is so scared, I wonder if the Chaplain could have offered a special prayer for her for the plane to arrive safely. She says she's going down to some town by the name of Muddy."

Speaker Redmond: "Who was that Representative Boucek?"

Boucek: "Representative Winchester's secretary, JoAnne."

Speaker Redmond: "Is he piloting the plane?"

Boucek: "Well, then I would be a little afraid."

Speaker Redmond: "Representative Deuster."

Deuster: "Mr. Speaker, I thought there were some important
people on your side of the aisle flying back from
Massachusettstoday and I thoughtwe might want to have



a prayer for them too. I don't want to suggest which way we'd be praying."

Speaker Redmond: "It's now one minute after five and the Rules
Committee will be meeting in 114. Then when we get
through down there, we'll be back up here and go
through pages one through seven of the Calendar.
And if anybody doesn't get an affirmative vote don't
blame me because it will have been called. Welcome
back Representative Oblinger. Representative Madigan,
will you answer the phone. Representative Conti.
Who are you pointing to? Are you pointing to the
Gentleman who led us in the pledge of alliegance
and who received the applause of the Membership?
Everybody was on the floor at the time? Representative
Madigan. Representative Madigan."

Madigan: "Mr. Speaker, Ladies and Gentlemen of the House,

I move that the appropriate rule be suspended to allow the Rules Committee to consider the Conference Committee Report on Senate Bill 1320. That would be the posting requirement. I don't know."

Speaker Redmond: "Representative...."

Madigan: "This is the Conference Committee Report relative to the pay scales for the Clerks of the Circuit Courts.

Mr. Darrow withdraws his objection."

Speaker Redmond: "Hasn't Tom Duffy seen you, Representative

Conti? Question is on Representative Madigan's motion
that the rulesbe suspended to submit the Rules Committee
to hear... which one is it? 1320? Is there any objection? Hearing no objection, unanimous consent has been
given. Now we'll go down to Rules. House will come to
order. Members please be in their seats in the regular
Session. Roll Call for Attendance. Messages from the
Senate. Is that what you have? No messages. Introduction First Reading."

Clerk O'Brien: "House Bill 2833, Bullock. A Bill for an Act making an appropriation to the Agricultural



Premium Fund for the Comptroller. First Reading of the Bill."

Speaker Redmond: 'Senate Bills, Third Reading on page two appears Senate Bill 1438. Representative Johnson."

Clerk O'Brien: "Senate Bill 1438. A Bill for an Act making a supplemental appropriation to the Board

making a supplemental appropriation to the Board of Trustees at the University of Illinois. Third Reading of the Bill."

Speaker Redmond: "Representative Johnson."

Johnson: "Mr. Speaker, what I'd like to do with this is to return it to Second Reading for purposes of a..."

Speaker Redmond: "Gentleman have leave to return it to the order of Second Reading? Hearing no objections, leave is granted. 1438 will be returned to the order of Second Reading. Mr. Clerk."

Clerk O'Brien: "Amendment #2, McClain. Amends Senate Bill
1438 by deleting the title and inserting in lieu thereof
a Bill for an Act making appropriations and amending
appropriation Acts and so forth."

Speaker Redmond: "Representative Johnson are any Amendments...

I know but... Is this compatible with the Amendment that
you have on there now? Do we have to table Amendment
1?"

Johnson: "I think we ought to move to table Amendment 1 because it just simply varies the amount. Do you want
to move to reconsider the vote by which Amendment 1
was adopted Mike? I would so move."

Speaker Redmond: "Representative Johnson moves to table

Amendment #1. Those in favor say 'aye' aye, oppose
'no'. The ayes have it. The motion carries. Amendment
#1 is table. Amendment #2, Representative McClain."

McClain: "Thank you very much Mr. Sepaker. Ladies and

Gentlemen of the House, if you recall, Amendment #1

informed the Membership that the Illinois State Scholar
ship Commission feared that they were four million dollars

shy in needed appropriations for grants to deserving



for grants, and the Membership agreed and we placed on Amendment #1 which was our best estimate at that time that the matter would be four million dollars.

Since that time, the Illinois State Scholarship Commission has come in and a hard figure now is four and a half million. Hence, Mr. Johnson's motion to table Amendment #1 and provide for Amendment #2 which is a 4.5 million dollars which is now the same issues as last week. It's just now this is the hard figure rather than an estimate.

I move for the adoption of Amendment #2."

Speaker Redmond: "Representative Schneider."

Schneider: "Speaker, Members of the House, I'd like to know from the Sponsor. Mike, this isn't the merit stuff is it? Has that already gone out?"

McClain: "No, just pure grants."

Schneider: "Alright. Now this is for the junior college kids that were denied because the Commission did not accept requests for community colleges?"

McClain: "Some of them are junior college kids. Most of it:..

is a great influx of kids going to four year colleges."

Schneider: "I'm supportive of this. I just think maybe you or someone else ought to bring to the attention of the Commission the staggered dates with which the students must enter university and community college applications. I think it's a shame that they blundered this one so badly and I would hope that you would bring it to their attention. I support it and I would move also that we adopt Amendment #2."

Speaker Redmond: "Anything further? Representative Wikoff.

Representative Lechowicz, 1436. Representatiave Wikoff."
Wikoff: "Thank you Mr. Speaker and Members of the House.

I, too, am going to support this and I think it should be adopted, but, Mike, you and I have had some problems with this Scholarship Commission before and I think

that it would be wise for this group to go on record that



this may be the last time that they come in. If they can't count ahead of time, I don't think I'm going to be too willing to deal with them next time. But I think this Amendment should be supported this time, but I think their day of reckoning may come on appropriations next year."

Speaker Redmond: "Anything further? Johnson."

Johnson: "I concur with the Amendment."

Speaker Redmond: "Representative Peters."

Peters: "No, Mr. Speaker. That's alright. I'll just vote."

Speaker Redmond: "Questions on the Gentleman's motion for the adoption of Amendment 2. Those in favor say 'aye' aye, oppose 'no'. The ayes have it. The motion carried.

The Amendment's adopted. Any further Amendment?"

Clerk O'Brien: "No further Amendment."

Speaker Redmond: "Third Reading. Representative Johnson."

Johnson: "Can we vote on that now? Third Reading."

Speaker Redmond: "Not unless we suspend some rules. We'll be here tomorrow anyway."

Johnson: "Well alright. The Senate has to concur with the

Amendment. I just want to make sure we get it all done."

Speaker Redmond: "1444. Representative Van Duyne. Senate

Bills, Third Reading."

Clerk O'Brien: "Senate Bill 1444. A Bill for an Act making appropriations certain federal funds to the State

Board of Education. Third Reading of the Bill."

Van Duyne: "Thank you Mr. Speaker and Ladies and Gentlemen.

That's exactly what the Bill is. It's all federal funds. There is no state match to it. The total Bill originally was 22,000 for handicaps under Title 6D and 140,000 roughly under Title 3 for the library resources reimbursement. And then there was two Amendments adopted One for 50,000 dollars to the Junior College Board Vocational Education and 20,000 dollars for Special Education which makes a total of... I don't think addition is proper here. 231,896 dollars. So, I ask



for a favorable Roll Call."

Johnson: "Yes. Yes, it's correct."

Speaker Redmond: "Representative Peters."

Peters: "Mr. Speaker and Ladies and Gentlemen of the House, for our side I just rise to support the motion made

by Representative Van Duyne and to indicate that the House has voted on the funds that he had talked about in terms of the Amendments which were offered. And they are as had he had indicated to the House and I would join Representative Van Duyne in asking for

a favorable vote on this appropriation."

Speaker Redmond: "Question is shall this Bill pass?

Those in favor vote aye, oppose vote no. Have all voted who wish? Clerk will take the record. On this question there's 120 aye and 4 no and the Bill having received the 3/5 Constitutional Majority is hereby declared passed. 1445."

Clerk O'Brien: "Senate Bill 1445. A Bill for an Act
making supplemental appropriation to the Board of
Higher Education. Third Reading of the Bill."

Speaker Redmond: "1445, Representative Kane."

Kane: "Mr. Speaker and Ladies and Gentlemen of the House, this Bill, as it came over, was an appropriation for 50,000 dollars to the Board of Higher Education.

There are a number of Amendments added to it which were federal funds and supplemental appropriations and some transfers all approved by the... both sides by the Minority Spokesman on the Appropriations Committee, and I would urge the passage of Senate Bill 1445."

Speaker Redmond: "Any discussion? Representative Peters."

Peters: "Mr. Speaker, Ladies and Gentlemen of House, again

for our side just to join an agreement with the comments

made by Representative Kane. The Amendments to the Bill

were offered and discussed and voted on by the House

when we were here last week. There was ample, I think,

discussion on them. They're all federal funds and I would



urge that you join with Representative Kane indvoting yes on this appropriation."

Speaker Redmond: "Question is shall this Bill pass? Those in favor vote aye, oppose vote no. Have all voted who wish? Have all voted who wish? Clerk will take the record. On this question there's 122 aye and 3 no and the Bill having received the Constitutional Majority hereby declared passed. 1436, Representative Lechowicz."

Clerk O'Brien: "Senate Bill 1436. A Bill for an Act making a supplemental appropriation for the expenses of the Senate of the 81st General Assembly. Third Reading of the Bill."

Lechowicz: "Thank you Mr. Speaker, Ladies and Gentlemen of the House. Senate Bill 1436 originally asked for a 15,000 dollar deficiency to cover the cost of printing expenses incurred prior to June 30, 1979.

After the Bill was heard by the Rules Committee and was on Second Reading on the floor, ten additional Amendments were adopted by this House in full debate and now the Bill calls for an expenditure of 18,531,458 dollars. Now I ask for your serious consideration on Senate Bill 1436."

Speaker Redmond: "Any discussion? Question is shall this Bill pass? Those in favor... Representative Kane."

Kane: "Mr. Speaker, would the Sponsor itemize where the 18,000,000 dollars is going?"

Speaker Redmond: "Representative Lebhowicz."

Lechowicz: "Yes Mr. Speaker. I'd be more than happy to. In fact, as I pointed out in my presentation that there were actually 12 Amendments that were filed with the Clerk, two were withdrawn and ten were adopted after full debate on this House floor. Amendment #2 which was adopted added 35,000 dollars for the Land Resources

Study Commission. Amendment #3 which was adopted on the floor added 15,000,000 dollars for the operation of Cook County hospital. Amendment #4 was a transfer



which does not affect the total appropriation. Amendment #5 adopted added 95,000 dollars for the officers of the Attorney General. Amendment #7 which was adopted added 25,000 dollars which was a happier appropriation for the Spanish Speaking Study Commission. Amendment #8 added 597,585 dollars for the Lincoln Developmental Disability Center. Amendment #9 added 851,239 dollars for the Manteno Mental Health Center and 561,634 dollars for the Shapiro Mental Health Center. Amendment #10 added 850,000 to the Illinois Valley Community College. Amendment #11 added 284,375 dollars to the Anna Mental Health Center and 171,625 dollars for the Bowen Mental Health Center. And Amendment #12 added 60,000 dollars for travel... air travel in the State of Illinois.

Kane: "One further question. I wonder if the Sponsor of this Bill would repeat the speech that he made at the end of June about Omnibus appropriation Bills and the remarks he included in House Resolution 455."

Lechowicz: "As I pointed out very carefully in my presentation

I hope that answers the Gentleman's question."

of this matter, "I said this matter originally started out with an appropriation of 15,000 dollars and after full debate on Second Reading, these Amendments were added by the Membership of the House at that time. And for this reason, Mr. Speaker, I now ask that the House do adopt and pass Senate Bill 1436 as presented."

Speaker Redmond: "Is there anything further? Question is shall this Bill pass? Those in favor vote aye, oppose vote no. Have all voted who wish? Representative Lechowicz."

Lechowicz: "Thank you Mr. Speaker and Ladies and Gentlemen

of the House. I don't know, maybe some of the Membership

was not giving this Bill its full attention but this

is a very important Bill. It's a very important Bill.

Not only that it contains the amount of money that is

requested of 18,531,000, but the purpose is that the



Amendments, as they were adopted, are contained in Senate Bill 1436. Now this... my memory serves me correctly, will require 107 votes and I think it would be a very sad day. I really don't know what the opposition is. I would like to hear some debate on this matter because if there is some serious consideration it should be given to a specific Amendment. I think this Body spoke loud and clear on every Amendment that was adopted. I for one, do believe that this Bill should be supported by the Membership. I don't know why... if there's some hesitation as far as providing necessary fundsfor county hospitals 15,000,000 dollars, I believe that was discussed quite adequately on this floor, but if you want me to reinterate some of the comments I'11 be more than happy to do so. I believe this is the institution in the City of Chicago that provides the treatment for 700,000 people. And if you haven't heard the employees of that institution have received a stipend of their existing salary. I believe the county hospital gave... they haven't received their pay checks in over two and half weeks in this passed couple of days ago they received a stirend; of 200 dollars so everybody can get some money within their respective households. Now I thought that there was some compassion and understanding generated in debate on Senate Bill 1436 as it was amended, and I would hope that the people that voted for the respective Amendments would support this Bill. Thank you Mr. Speaker."

Speaker Redmond: "Representative Mahar."

Mahar: "Thank you Mr. Speaker and Ladies and Gentlemen of the House. I also rise in support of this Bill and I'm pretty concerned about the Amendment that deals with the 15,000,000 dollars for Cook County hospital. Now Oak Forest Hospital is in my district. Oak Forest Hospital has 2,000 employees that haven't been paid for



over a week and these are people at the bottom of the line. These are people that go from pay day to pay day. They provide a very important service of 1,175 people that are in that hospital. As of Monday, people were not showing up for work simply because they're concerned about their pay. Now just because we have a problem with the governing commission, just because the top are getting their money because havahton spends his time combing his bangs, why I thinks it's no reason why the people down at the bottom of the row shouldn't get their money. And I would urge that we get enough votes on this Bill to pass it."

Speaker Redmond: "Representative Huskey."

Huskey: "Mr. Speaker, will the Sponsor yield for a couple questions?"

Speaker Redmond: "Proceed.""

Huskey: "There was the newpaper talk was there was to be a reorganization of the governmental body of the hospital. Is there anything before we vote this Bill that is concrete evidence? Is there any effort for reorganizing the ruling body of this hospital?"

Speaker Redmond: "Anything further?"

Huskey: "That was a question. I was waiting for an answer."

Speaker Redmond: "To whom did you address it? Representative Lechowicz?"

Huskey: "To the Sponsor of the Bill."

Speaker Redmond: "Representative Lechowicz. Representative

" Huskey has a question."

Huskey: "You want the question repeated?"

Lechowicz: "Yeah. I'm sorry. Would you kindly repeat the $\label{eq:question} \textbf{question?"}$

Huskey: "According to the news media, before this money was

to be voted on in the House it seemed like there was

some inside backroom deals where there were to be

a reorganization of the ruling body of the institutions



of these monies of 15,000,000 dollars is earmarked for. Has there been any effort made by the state or any of the state officials or either of the legislative Bodyles to help reorganize this hospital?"

Speaker Redmond: "Representative Conti."

Conti: "Mr. Speaker, I don't think the Sponsor heard the question but I think I have the answer Herb. There is a plan... There is a Bill in now to put the county hospital back into the hands of the Cook County Board and the Cook County Board is going to consider some professional services to operate the hospitals. Now that's as far as it's gone. But as far as anything definitive on the subject, I'm not sure if there would be an answer on that for a vote on this Bill today. But before any more money's allocated, any more subsidies given to the state, I was assured that there was a Bill introduced to reorganize the structure of the Cook County Hospital by turning it back into the hands of the county and then the county, instead of making a patronage system out of it, would contract out to professional administrators, hospital administrators."

Speaker Redmond: "Have all voted who wish? Representative Lechowicz."

Lechowicz: "Mrs. Braunand Mr. Peters."

Speaker Redmond: "Representative Braun."

Braun: "Thank you Mr. Speaker and Ladies and Gentlemen of the House. I rise in support of this Bill and I urge an aye vote. This Lagragaent of the employees at the Cook County Hospital is a matter of utmost importance at this time. Those employees have been unselfishly giving health care services in the City of Chicago to sick people all this time on the basis of no money, partial money, and a hope and a prayer that this Legislature will act responsibly and pass this legislation. This legislation is desperately needed. There is

no way that one can run a health care institution that provides services without funding that operation and paying its employees. And for that reason, Ladies and Gentlemen of the House, Mr. Speaker, I would urge an aye vote. Earticularly of my friends from suburban Cook County and downstate. It would be most appreciated if this Bill not be allowed to go down on the basis of misunderstandings about the future of the governance of the hospital. Those matters can be worked out separately. They will be worked out separately and this Bill should be allowed to pass out of this House today without further confusion, without further delay so that the hospital operations will not be impared. I urge an aye vote."

Speaker Redmond: "Representative Daniels."

Daniels: "Mr. Speaker, Ladies and Gentlemen of the House, maybe if we could just take a few minutes just to reflect on the importance of the legislation that we have before us right now, we can consider the fact that the Cook County Hospital and its 22 buildings serve some 42,000 people per year. That is a major training ground for 3,000 doctors in the State of Illinois who receive their training at Cook County Hospital. That is serves 7500 babies throughout a year and is a major institution which receives many people that cannot afford medical care but renders some of the outstanding medical care to these people in the country today. Now those of you from Cook County, we've had problems with you in the past particularly those of you from Chicago when you have not recognized some of the problems that we've had in our suburban area due to the urban growth. But on the same token as we look at the problems that you have today in Cook County and in particular in a hospital as great as the Cook County Hospital has been in the past and we understand that some of the reform packages that you're going to be dealing with at the present time



to clean up the problems Mat the Cook County Hospital we are of a recognition that perhaps, under these circumstances, we don't have much of a choice but to assist you in andethe very problems that you have serving some of our people of this state. I'm suggesting to those of us on this side of the aisle and those of you on the other side of the aisle that we pass this Bill. That we give the necessary votes that this Bill can be passed into law and that we recognize that changes will be made at the Cook County Hospital. But at the same time, we are saying to you on the other side of the aisle and namely to those of you that are from this area that we too need your help in the many problems that we're having out in 'our area due to the urban growth. So Ladies and Gentlemen of the House, I think we ought to pass this legislation. think we ought to give the necessary votes, and I think we ought to enact it in the law."

Speaker Redmond: "Representative Peters."

Peters: "Mr. Speaker and Ladies and Gentlemen of the House,

I am not going to make any reference to what may have happened in the past or what, in fact, may end up happening in the future. This Assembly is a deliberative Body and it would be, I think, all our hopesthat we would vote on each issue as each issue comes up and on the merits of that particular issue. The question of Cook County Hospial has been before us since sometime last spring. Many of you have some serious problems and reservations and probably justifiably in terms of voting on this particular appropriation. Let me just indicate to you that during the last days of the Session and during the course of the summer many discussions have gone on as to the future of County Hospital and what can end up being done. Let messay to you that the first step in that reformation of the problem or that solution



to the problem has been the introduction of legislation

in the Senate. We are assured that it will pass in the Senate in cooperation by both the Democrats and Republican sides, bi-partisan support which will end up returning control of that Board of the Hospital rather to the Cook County Board of Commissioners in order for us then to proceed with what else may be done. is necessary and I think we all recognize that we end up having an obligation in working out this compromise since we are involved in it. There's no way we're going to end up escaping it. Is to provide the funds that the hospital needs to the end of their fiscal year which is to the end of November of this year. With the legislation passing the Senate and the House and the assurances that the Governor will sign it, control then will pass to the County Board and the responsibility for that funding of the hospital will then go to the County Board. I think we have the best situation and the best deal we can up to this point. If legislation is introduced again next year to further make some added or additional changes, that's another kind of problem, but as of right now, let us not get A and B mixed up or peoples votes on other measures. Let us try to solve this one problem we have before us and that is the problem of County Hospital. And it's being done in a bi-partisan manner in the Senate and the House with both sides of the aisle and all of the commissioners in Cook County, Democrat and Republican, agreeing on some kind of program. We appreciate very much your support of this particular Senate Bill so that we can get the program on the road. Thank you very much."

Friedrich: "Mr. Speaker and Members of the House, I'm voting no on this and not because of the Cook County Hospital.

Despite the admonitions of some of my friends on this



side of the aisle that's had any money you pump into
the Cook County Hospital just goes into the Democratic
machine in Chicago. I'm convinced that we ought
to help the hospital this one time and had even agreed
to go along with 30,000,000 dollars. But there's
a lot of other junk in here and I don't like this
Omnibus Bill where you don't have a choice on what
you vote for. And you put us in that box if you either
vote for all or none. And there's some things in here
bad enough I'm going to vote for none."

Speaker Redmond: "Have all voted who wish? Clerk will take the record. On this question there's 112 aye and 36 no. Representative Mulcahey."

My concern about it is that there's some other matter contained within this including a fee for filing expunction petitions and several provisions that I think are probablay not the best interest of the state. Expunction petitions, as everyone recognizes, are ones that are filed after charges have been dismissed against an individual to clear the person of a criminal record. It seems to me that it makes sense that if there wasn't sufficient basis to sustain a charge and have it dismissed it doesn't make sense to require that same individual to pay out of his money to have his record expunceed for something he didn't do to begin with. But unfortunately, we get these Conference Committee Reports and that's part of the system that we have to take in whole or not at all and in balance, I think this Bill is a good one and ought to be supported. But I hope we will readdress ourselves to some of the minor problems that this Bill create in terms of peoples rights and particularly in terms of criminal defendants rights in the matter of expunction in related matter."

Speaker Redmond: "Representative Simms."

Simms: "Would the Sponsor yield?"

Stearney: "Well the Conference Committee Report does not include the language of the Bill. Am I right? It only amends certain Sections."

Madigan: "I presume that the Conference Committee Report

deals with the differences between the two Houses."

Stearney: "Yes. Well, I'm... My remarks are addressed to the original Bill. Well no. Well, then let me speak to the issue. It seems to me rather unfair for the people of Cook County to make... to pay 75 dollars



for a jury demand. And let me also mention that very few of these cases ever go to trial. What is happening is that the consumer in Cook County is having to pay 75 dollars for the payment of a jury demand and that's going to be deducted from any settlement he may receive in the future. Whereas, if it's a case that doesn't involve a personal injury, he's paying 75 dollars for merely the right to ask for a jury when in fact only 2% of these cases ever go to trial. I see no reason for raising the fee from 50 to 75 dollars in Cook County. Because I don't believe that Clerks Office justifies that amount, that necessity, that amount of 75 dollars. Whereas, it's totally unfair to say that the people in downstate need only pay 50 dollars but the people in Cook County have to pay 75 dollars. That's just too much. If anything,it should be 50 dollars across the board and that is the amount that the people in Cook County have been paying for the last few years. This Report should be rejected. Let it go back and put that equality across the board. Vote no on this matter." Speaker Redmond: "Anything further? Representative Pullen." Pullen: "Mr. Speaker, I know there's a lot of bustling

about in the House right now and a lot of Members aren't paying too much attention to what's going on and I would like to point out to them and to everyone here that what this really is is a Bill that has been changed from a fee Bill tothat and a salary increase. This is a pay raise Bill Ladies and Gentlemen, for the Clerks of the Circuit Court. There is nothing mandatory about it but you and I both know what the results of this will be.
