House Resolution 965, Mahar, 966 - Yourell, 967 - Yourell, 968 - Yourell, 969 - Yourell, 970 - Yourell, 971 - Yourell, 973 - Jane Barnes, 974 - Jane Barnes, 975 - Steczo, 976 - Younge, 977 - Steczo, 978 is a death, 979 - Madigan, Beatty, Kucharski, 980 - Younge, 981 is out, 982 - Yourell, 983 - Kosinski, 984 - Yourell, 985 - Madigan, Beatty, Kucharski, 986 - Grossi, 987 - Bullock."

Speaker Redmond: "Representative Giorgi."

Giorgi: "Mr. Speaker, Senate Joint Resolution 927 by Vitek honors the 300th anniversary of the Christian Brothers and Senate..."

Speaker Redmond: "Let's everybody stand up and say Congratulations and then sit down and listen to Representative Giorgi. Okay everybody say Congratulations. Okay, now Representative Giorgi on Agreed Resolutions."

Giorgi: "Senate Joint 129 honors 'Charles Kruse' of Deerfield, Illinois for 25 years of service. 965 by 'Mahar' notes their 125th anniversary of a village. Yourell's 966, 967, 968, 969, and 970 and 971 honors some scouts on achieving Eagle Scout Award. 972 does

the same thing. 973 by Barnes honors 'Evangeline Fahey'. 974 by Barnes tells us about the Oak Lawn community. 975 by Steczo tells about a deputy clerk at Tinley Park. 976 by Younge honor the Republic of Haiti. 977 by Steczo talks about a moving from Tinley Park to Florida. 979 by Madigan honors the..wants the Governor to proclaim January 8th the birthday of Elvis Presley as an Elvis Presley memorial day to honor this great American entertainer's accomplishments in Modern American Music. 980 by Younge tells about a 'Francis Touchette'. 982 by Yourell a 50th anniversary. 983 by Kosinski of the Institution of Marriage. 984 by Yourell telling about a ' Bill Davidson'. 985 by Madigan honors a marriage. 986 by Cole mentions a citizen of the year. 987 by Bullock talks about a fellow who's roasted and toasted and I move for the adoption of the Agreed Resolutions."

Speaker Redmond: "Any discussion? Questions on the Gentleman's motion for the adoption of the Agreed Resolutions. All of those in favor say 'aye', oppose 'no'. The 'ayes' have it. The motion carried. The Agreed Resolutions are adopted. Mr. Clerk, Death Resolutions."

Clerk O'Brien: "House Resolution 978, Younge, respect the memory of Mr. Ernest Calvin Brown. House Resolution 981, Younge, to respect the memory of Mrs. Haddie M. Jordan."

Speaker Redmond: "Who Representative Younge? Representative Younge moves the adoption of the Death Resolution 987 (Sic). Those in favor say 'aye', oppose 'no'. The 'ayes' have it. Motion carried, the Resolution is

adopted. Mr. Clerk, introduction First Reading."

Clerk O'Brien: "House Bill 3633, Catania - Bowman. A Bill for an Act making appropriations to the State Comptroller to pay the claims of victims of unfair employment practices committed by state agencies. First Reading of the Bill."

Speaker Redmond: "Representative Borchers. Representative Borchers."

Borchers: "Fellow Members of the House I would like to have a little attention this time. I want to tell you of a good lesson in politics. If you want to know I fell victim to struggle for the chair of the House and don't think I'm angry or mad about it, it's just one of those things. But I think it's a good lesson in politics to you all and myself though a little late. Every poll including the poll of the State Central Committee of the Republican Party in Decatur, Taylorville, everywhere clearly show that I was running around 2 to 1 ahead of everybody else. So Sunday before the election, all of the Republican Precinct Committeemen nearly all went out into the district and said now Borchers is bound to be re-elected. We want control of the House. Now what do you think about that, Mr. Speaker. So they said vote for Mr. Tate. He needs it. We'll get control of the House. We will want the critical areas. So all of you fellows want to remember for the future this lesson in politics. Watch yourselves and be careful. Don't get into a fight for the control of the chair. You might get hurt. Anyway, I thought it would be interesting for you to know about this so thanks

alot."

Speaker Redmond: "Representative Pierce. Please sit down.
Representative Swanstrom, Donovan."

Pierce: "Mr. Speaker, you missed the Gentleman's stalk from Macon and so did the Gentleman from Kankakee up there. He said he sacrificed himself to elect a Republican House and I wonder whether the Minority Leader and I hope future Speaker who's on the stand there has agreed to give Representative Borchers part of his extra salary as Speaker and if you knew the sacrifice he made in Macon County for his running mate, voting for his running mate trying to elect a Republican House and I think as long as we have a Gentleman from Kankakee up there, he ought at this time confirm the fact that half the Speaker's salary will go to Representative Borchers."

Speaker Redmond: "He came up here to tell me that's precisely what he's going to do."

Ryan: "Starting now."

Speaker Redmond: "The Members please, pay attention. The Members please pay attention. There will be a Rules Committee meeting after adjournment which will be at 1:30 so anyone that has a Bill that they want to be considered for exemption please get your..do we have unanimous consent to waive the posting rule on the hearing of the Rules Committee. Representative Madigan. First thing we better do here is take a roll call for attendance I guess. We haven't done that yet. Representative Madigan."

Madigan: "Mr. Speaker, would the records show that Representative Getty and Vitek are excused because of

illness?"

Speaker Redmond: "Are there any objections? Hearing none the record will so show. Representative Friedrich."

Friedrich: "Mr. Speaker, will the record also show that Representative Winchester absent because of.."

Speaker Redmond: "Representative who?"

Friedrich: "Winchester."

Speaker Redmond: "Oh, Winchester. Any objection? Hearing none the record will so show. Now Representative Carol Moseley Braun. Representative Braun. Mr. Davidson, Davidson. Braun's microphone. Representative Braun."

Braun: "Thank you Mr. Speaker. Will you please record me as present. My key is missing and I can't get on the machine."

Speaker Redmond: "Put Representative Braun on the roll call. Representative Collins."

Collins: "Mr. Speaker, will you let the record show that Representative Schoeberlein is excused because of an illness?"

Speaker Redmond: "Any objections? Hearing none the record will so show. Representative Laurino. Laurino."

Laurino: "I often have trouble with my switch, it's been permanently locked."

Speaker Redmond: "Representative Laurino got caught in the switches. Please record him on the record..Quorum Roll Call. Representative Friedrich. Friedrich."

Friedrich: "Mr. Speaker, in connection with the Rules Committee meeting I have no objection to calling it but I would hope that we'd have some chance to look at those Bills which will be heard prior to the meeting."

Speaker Redmond: "Parliamentarian suggests that there's objection we'll continue the meeting until tomorrow. This is to accommodate the Members that have relatively non - controversial matters if anything doesn't fit that category we can take care of it by having another meeting tomorrow. Representative Collins."

Collins: "Mr. Speaker, I just learned that Representative Molloy should be excused because of illness also."

Speaker Redmond: "Any objections? Hearing none let the records so show. Representative Klosak. Why is Margalus'..Representative Klosak that you Representative.."

Klosak: "Mr. Speaker, I can't put my light on, I'm missing my key. Would you see that I get on the roll call please?"

Speaker Redmond: "Yes. Put Representative Klosak on the roll call. Representative Madigan."

Madigan: "Mr. Speaker, in response to the comments of Mr. Friedrich, there had been discussion between you and I and Representative Ryan, to provide for a Rules Committee meeting, to allow Members who have a Bill that they wish to have considered in the Veto Session approved by the Rules Committee as soon as possible so that they can start to move the Bill through the process. I know of one Bill sponsored by Representative Terzich that he would like to get considered by the Rules Committee today and begin to move it through the process. And I would suggest, Mr. Speaker, that we defer the cancellation of the Rules Committee meeting just for a few minutes to see if

there are others who wish to have the Committee consider a Bill."

Speaker Redmond: "What was your suggestion?"

Madigan: "I thought I heard you cancel the..."

Speaker Redmond: "No, no. No, no. I didn't cancel it. It's scheduled for 1:30. I said that in the event there was any problem that we could set it off till tomorrow. At the meeting itself. But it was not cancelled and unanimous consent was given. Representative Madigan."

Madigan: "Mr. Speaker."

Speaker Redmond: "Representative Madigan."

Madigan: "Mr. Speaker, I have a motion to offer regarding the Bills which were approved by the Rules Committee this morning for consideration during this Session. Those are House Bill 3621 by Mr. Friedrich, House Bill 3622 by Mr. Lechowicz, House Bill 3623 by Mr. Redmond, House Bill 3624 by Mr. Jaffe. All of these Bills are not controversial in nature. There was bipartisan support in the Rules Committee for consideration of the Bills during this Session and my motion, Mr. Speaker, is to move these Bills to the order of Second Reading without reference to Committee. And I so move."

Speaker Redmond: "Representative Skinner. Representative Skinner. Oh, Catania. Representative Catania... Representative Skinner. Catania's switch."

Skinner: "Yes, Mr. Speaker I wonder if we could have something more than the numbers of the Bills. Something that might have bipartisan support and might be considered controversial by some of us lowly back

benchers."

Speaker Redmond: "Representative Madigan. Please, please, please be in order."

Madigan: "Mr. Speaker, is Mr. Skinner a lame duck?"

Skinner: "He is a ruptured duck, I think."

Speaker Redmond: "I'm not so sure that was the right follow. What's the pleasure of the body?"

Skinner: "Mr. Speaker, could I have the content of the Bills?"

Speaker Redmond: "Representative Friedrich do you want to explain to Representative Skinner the content of 3621."

Friedrich: "Yes I do. 3621 is a Bill which was introduced at the request of the Auditor General. His car was stolen and wrecked so totally they turned it over to Administrative Service. This is a transfer of funds from another portion of his appropriation. There's no new money."

Speaker Redmond: "Representative Skinner. No problem. I can..3622, Representative Lechowicz. Representative Yourell, for what purpose do you rise? Yourell."

Yourell: "Yes, Mr. Speaker may I have leave to be recorded as present on the Quorum Roll Call?"

Speaker Redmond: "May Representative Yourell be recorded on the Quorum Roll Call. Hearing no objections..Quorum Roll Call. Representative Lechowicz."

Lechowicz: "House Bill 3622 is the supplement appropriation to the Secretary of State's office for one million, three hundred thousand dollars for the repayment for the Constitutional Amendments that were offered to the voters and adopted November 4, 1980."

Speaker Redmond: "3623, this is a little bit unusual but I put this Bill in as a request to the new Page County Board to avoid a special election on November 29 talked about five million dollars which is not..five hundred thousand dollars. No objection. 3624, Representative Jaffe."

Jaffe: "Mr. Speaker, House Bill 3624 removes the requirements of a referendum on home rule status of a municipality after its population falls results below in twenty - five thousand if such a referendum is had in the two preceeding calendar years."

Speaker Redmond: "Any objections? Questions on Representative Madigan's motion that the rules be suspended in order that House Bill 3621, 3622, 3623, 3624, the Committee be bypassed and they can put on the order of Second Reading without reference. Those in favor vote 'aye', oppose vote 'no'. Have all voted who wish? Representative Laurino. What's the matter? Doesn't the switch work there? Have all voted who wish? The Clerk will take the record. I'll get back to you. On this question there's 132 'ayes' and no 'nays'. Now Representative Erzur for some reason or other the Doorkeeper has stolen her switch. Who else is in that same category? Representative Skinner. Representative William Walsh. Representative Klosak. They be added the affirmative roll call. Anyone else? Be careful. Somebody is counting these absentees. Representative Katz. Affirmative. What's the total, Mr. Clerk? Representative Willer, the same request? Representative Willer, the same request. On this question there's 139 'ayes' and no 'nay' and the

motion carries. The Committees are bypassed and they'll be put on the order of Second Reading without reference. Introduction, First Reading."

Clerk O'Brien: "Introduction, First Reading of Bill. House Bill 3634, Taylor. A Bill for an Act making appropriations of certain claims against the State of Illinois in conformity with awards made by the Court of Claims, First Reading of the Bill. House Bill 3635, Terzich. A Bill for an Act to amend the Illinois Pension Code, First Reading of the Bill. House Bill 3636, Giorgi - Simms - Hallock. A Bill for an Act to amend sections of the Revenue Act. First Reading of the Bill."

Speaker Redmond: "Any Member, any motion. Representative Katz. Representative Katz."

Katz: "Mr. Speaker, for any Member who plans to be before the Rules Committee upon adjournment here in Room 114. They should be advised that we will need copies of the Bills. We have no way of knowing what Bills are coming up and so it will be their responsibility of that Member to bring fifteen copies of his or her Bill so that the Members of the Rules Committee will know what the Bill is if they seek exemption on. So I've just been giving a little advanced notice that they should be sure to have copies of their Bill when they appear in Room 114 immediately after adjournment today for the House Rules Committee."

Speaker Redmond: "Representative Terzich."

Terzich: "Yes, Mr. Speaker, I would like to suspend the appropriate rule and House Bill 36..I believe it's 3625. I mean 16.. 1565 to be heard in the Rules this

afternoon what happened is on the pensions on the age discrimination.."

Speaker Redmond: "Those have been suspended Representative Terzich."

Terzich: "Alright, fine. Then I want to discharge the Committee. The Bill is in Committee and I want to discharge Committee so we can hear that Bill in Rules this afternoon."

Speaker Redmond: "Well, that's alright isn't it? Well, Representative Terzich where is it? Is this in Rules?"

Terzich: "It's in Interim Study. In the Pensions Committee."

Speaker Redmond: "Okay, the question is on Representative Terzich's motion to discharge Committee Personnel and Pensions with respect to House Bill 1565. Any discussion? The question is on Representative Terzich's motion. Those in favor vote 'aye', oppose vote 'no'. Discharge Personnel and Pensions. 1565 be put on the order of Second Reading. Have all voted who wish? It goes to Rules Committee instead of Second Reading. I'm in error on that. Have all voted who wish? The Clerk will take..I didn't say it yet. Representative Laurino. Laurino 'aye'. What's the matter with the switches on these desks? Have all voted who wish? We need 13 more votes. Representative, is that Walsh or is that Ebbesen? Representative Ebbesen. I didn't know whether it was Representative Walsh or not."

Ebbesen: "Yes, Mr. Speaker, as the spokesman on the Pension Committee I'd like to know what this..what the purpose

of this is. Maybe the Representative Terzich could explain this a little bit more."

Speaker Redmond: "Representative Terzich."

Terzich: "Yes, Mr. Speaker, what happened is on House Bill 3482 got tied up in the Conference Committee report which contained age discrimination changes for a number of municipal pension plans and what this is, I need this Bill as a vehicle to put in the age discrimination and these other systems. We enacted in approximately ten different systems already and we have to bring in the other ones into compliance. I need the Bill for this reason."

Speaker Redmond: "Representative Ebbesen."

Ebbesen: "Yes, is that the only subject matter that will be on this Bill before the House?"

Terzich: "Well, Representative Ebbesen, that's my intent to present this at the Rules Committee and that's the intent of the Bill."

Ebbesen: "Well, I'm still voting 'no'."

Speaker Redmond: "Have all voted who wish? Have all voted who wish? Representative Ryan."

Ryan: "Mr. Speaker and Ladies and Gent...I wonder if the sponsor would take this Bill out of the record until we can get it straightened out here."

Speaker Redmond: "Representative Terzich, what's your pleasure?"

Terzich: "Out of the record."

Speaker Redmond: "Now, Representative Ryan."

Ryan: "Mr. Speaker.."

Speaker Redmond: "Please come to order."

Ryan: "I'd like to have Representatives Winchester and

Molloy excused today due to illness."

Speaker Redmond: "Representative Friedrich did that already or Collins or somebody."

Ryan: "That's good. They're both in the hospital, Mr. Speaker."

Speaker Redmond: "Now for the purpose of..."

Ryan: "Mr. Speaker, it's my privilege today to introduce one of our new Members. Could we have a little order?"

Speaker Redmond: "It's kind of doubtful. Representative Ryan is going to divulge to his colleague, his future plans. So would everybody sit down, be quiet. The press is precluded from carrying this on their wire service or writing anything about it. Representative Ryan is going to tell us his plans. Representative Ryan."

Ryan: "Well, Mr. Speaker, we have seated today on the Republican side the widow of our colleague, our former colleague David Jones, and I thought it would be appropriate that we introduce her and her daughter that are with her today and her son, her son is not here but Marjorie Jones and her daughter are both here and I would like to have Marjorie stand up and welcome her to the House. Mr. Speaker, I'd like to add that Marjorie is seated in Dave's seat to fulfill the unexpired part of his term. And we're certainly glad to have her here. I think that she's honored to be here to be able to continue the work that Representative Jones had started and Mrs. Jones is going to be with us until the end of this Session. And so I would like to welcome her on behalf of all of us here and I'm sure you would too."

Speaker Redmond: "Representative Oblinger. You seeking recognition."

Oblinger: "Has the Death Resolution been introduced yet? I did not put this on. It was put on from up there."

Speaker Redmond: "We're going to adjourn on the Death Resolutions. I was under the impression that you wanted recognition. Maybe I was wrong on that. Anyone else? On behalf of the Speaker's office and the Democratic party I welcome you Mrs. Jones. Good Luck! If there is any way we can help you just let us know. Mr. Doorkeeper there's a..there's a lobbyist in Representative Meyer's seat. Will you please remove him from the floor. It's unusual but the lobbyist in Representative Meyer's seat, are you seeking recognition?"

Meyer: "Mr. Speaker I wish to report that I am now a radical Republican in the true tradition of Representative Epton and Kucharski I might add now."

Speaker Redmond: "Kucharski is head of the..Yourell too. Representative Yourell do you welcome him to the group? Anything else? Any Member that has any motion addressed to a veto either Total veto or amendatory veto that wants called today? They appear on page 3 of the calendar. 426, Representative Oblinger do you want that called? Not today she says. 1221, Representative Ralph Dunn. Out of the record 2845, Henry. Out of the record. I think it would be easier if any Member wants one called to just let us know. It would appear that nobody wants a motion called today. Am I correct? Representative Henry. I don't quite interpret your signal. Representative Henry."

Henry: "Mr. Speaker will you take it off the record please."

Speaker Redmond: "Yes, we've done that. Anything further? Any motion with respect to a Amendatory Veto, Total Veto, Reduction Veto, Implied Veto. Representative Katz, it looks like we're about ready to wind out here. Do you want to change the time of your Rules Committee."

Katz: "Yes, Mr. Speaker, there'll be a meeting of the House Rules Committee immediately upon adjournment in Room 114. Members having Bills that they want exemptions on should bring copies of the Bills so that the Members of the Committee will have the copies of the Bills in front of them. Immediately upon adjournment, Mr. Speaker, at 1:00 it will be right downstairs Room 114."

Speaker Redmond: "Representative Terzich, for what purpose do you rise? Representative Terzich."

Terzich: "Okay, Mr. Speaker again I would like to renew my motion on House Bill 1565 to discharge the Personnel Pensions Committee so that this Bill could be utilized and adjust in the age discrimination rulings of which is a mandate by the Federal Government."

Speaker Redmond: "Representative Ebbesen."

Ebbesen: "Yes, Mr. Speaker and Ladies and Gentlemen of the House. The basic thrust of intentions of Representative Terzich are certainly well intention and should take place but I for one will watch the Bill very carefully that nothing else is put on there and I think we have to look at it in that way. But the request is legitimate I would suggest that the House support the motion."

Speaker Redmond: "Question's on the Gentleman's motion. All those in favor vote 'aye' and oppose vote 'no'. I understand that this then go to Rules Committee. Is that what you understand Representative Terzich? Representative Katz are you aware of that? 1564, on the passage of this motion, 1564 would go to Rules and we have generally moved to suspend the posting."

Katz: "Yes, Mr. Speaker, we don't have to act separately on the individual Bills here on the House floor. A general motion was made suspending the requirement so that any Member can bring any Bill to the House Rules Committee when we meet today in Room 114 requesting suspension without any further action on the House floor."

Speaker Redmond: "He's discharging Interim Study. This is a little different. Representative Yourell."

Yourell: "I don't have my key, Mr. Speaker. May I have leave to vote 'aye'."

And the motion is to take it from the Interim Study Personnel and Pensions and put it before Rules. So that the Rules Committee may hear it. Have all voted who wish? Have all voted who wish? On this question there's 109 'aye', 28 'no' and the motion carried. He is discharged. Any other business? Agreed Resolutions, I think we better start.."

Clerk O'Brien: "Agreed Resolutions. House Resolution 992 - Johnson, 991 - Johnson, wait a minute. Okay, Agreed Resolution 998 - Kornowicz."

Speaker Redmond: "Any others?"

Clerk O'Brien: "994 - Peters, 995 - Peters, 996 - Peters, 997 - Peters, and 998 - Yourell, Kelly."

Speaker Redmond: "Discussions. Representative Giorgi."

Giorgi: "Mr. Speaker, 994, 995, 996, and 997 by Peters honors the Eagle Scout awards and 998 by Yourell honors Bill Davidson. I move the adoption of Agreed Resolutions."

Speaker Redmond: "Any discussion? The questions on the Gentleman's motion for the adoption of the Agreed Resolutions. Those in favor say 'aye', oppose 'no'. The 'ayes' have it. The motion carries. Agreed Resolutions are adopted. Anything further. Death Resolutions. Representative Ryan. 11:00 tomorrow morning. Representative Ryan on the Death Resolution."

Ryan: "Mr. Speaker, would you ask the Clerk to read the Death Resolution?"

Speaker Redmond: "Read the Death Resolution, Mr. Clerk."

Clerk Leone: "House Resolution 993. Whereas our esteemed colleague in the House of Representative and our good friend, J. David Jones passed away on October 2, after a prolonged bout with cancer and whereas Dave was in the midst of the campaign for his ninth term in the House. And whereas his constituents always found him available and eager to listen and help with their questions, their concerns, their needs, and their opinions. And whereas much of his work in the

Legislature was devoted to the needs of Senior Citizens particularly in the area of tax relief. And whereas his dedication to public service included not only eight terms in the House of Representatives but service to the Springfield area that spanned five decades. Including nineteen years on the Springfield Airport Authority, founding the Illinois Public Airport Association, thirty years as Precinct Committeeman, ten years as Sangamon County Chairman, Charter Member on the Springfield Junior Chamber of Commerce, and a Jaycee of the year, and Director of the Illinois Division of the American Cancer Society. And whereas his community interests also included ~~memberships in the Shrines, Elks, Eagles, Masons,~~ Consistory, and Community lodges and board memberships for the YMCA, Boy Scouts, Girl Scouts, and the Community Fund. And service on many committees and councils of the Methodist Church both locally and nation wide and whereas Dave's wife, Marjorie, has resumed his legislative responsibilities for the remainder of his term. And the same deep concern of the people of the fiftieth district that her husband always exhibited. Therefore, be it resolved by the House of Representatives of the Eighty-first General Assembly of the State of Illinois that we recognize J. David Jones in numerable legislative contributions over the past sixteen years. And his outstanding record of community concern as a lifelong Springfield resident and be it further resolved that we offer our deepest sympathy to his wife, Marjorie, to their children, and to his four sisters on the loss of a

Ryan: "Thank you, Mr. Speaker. I would ask to leave to have the entire membership added as Cosponsors."

Speaker Redmond: "Any objection? Leave is granted and the entire membership will be added as Cosponsor. The question is on the adoption. Representative Ryan."

Ryan: "Mr. Speaker, I think that the House Resolution pretty well spelled it out as far as our former colleague, Representative Jones, was concerned. He was a loyal dedicated public servant and those of us that worked with him and knew him knew how excited he was about every project he got into and how much time and effort that he put into it. It's truly a loss for the people of this district and to the people of the State of Illinois and Dave Jones was just a great American and it's certainly a loss to this body. And with that, Mr. Speaker, I would defer to Representative Oblinger."

Speaker Redmond: "Representative Oblinger."

Oblinger: "Mr. Speaker and Members of the General Assembly, that the real treat for me to have Marjorie Jones share her husband's seat with me. He had alot of plans and hopes for the future. Today she is assuming those hopes and plans and will carry them out. At this time I would like to give her the plaque for the door."

Speaker Redmond: "Question's on the motion for the adoption of the Death Resolution. Those in favor say 'aye', oppose 'no'. The 'ayes' have it and the motion carried. Representative Jones."

Jones, M.: "Mr. Speaker and Members of the House. Thank you from the bottom of my heart. I shall endeavor to carry out the wishes of my late husband and will appreciate your assistance at..assistance at all times. I am honored to be here again..to be here and again I want to thank you."

Speaker Redmond: "The motion included adjournment until tomorrow morning and the time will be 11:00 a.m. tomorrow. Questions on the adoption of the resolution. Those in favor say 'yes', oppose 'no'. The 'ayes' have it. The motion carries. The House now stands adjourned until 11:00 tomorrow morning."
