- Speaker Ryan: "Roll Call for attendance. Take the record, Mr. Clerk. 153 Members answering the Roll. A quorum of the House is present. Representative Madigan, do you seek recognition?"
- Madigan: "Mr. Speaker, will the record show that Representative McGrew is excused because of a death in the family?"
- Speaker Ryan: "Representative Collins."
- Collins: "Mr. Speaker, may the records show that Representatives

- Speaker Ryan: "The record will so indicate. I might add that I spoke with Representative Conti this afternoon. He's out of the hospital and will be here attending to business tomorrow. It's the intention of the chair to go to the calendar on the Order of Motions, call all of the Motions pertaining to rule 66% which there are discharge Motions. If everybody cooperates and we hold down the debate, the discussion, we should be out of here by somewhere around 7:30 or 8:00. We're going to take them in order. Representative Friedrich, do you seek recognition?"
- Friedrich, D.: "Yes, Mr. Speaker, I want to report to the House that Harold 'Stedlin', a long time Member of this Body died over the weekend. The funeral is in Centralia tomorrow. I think some of you would remember Harold having been here ten years."
- Speaker Byan: "On the calendar on page 32 under the Order of Motions appears House Bill 8, Representative Pechous. Is the Gentleman on the floor? Out of the record. House Bill 9, Representative Laurino. Representative Laurino on the floor? Out of the record. House Bill 87, Representative Deuster. Did you want to call your Motion, Representative? Read the Motion, Mr. Clerk."
- Clerk Leone: "Motion I move pursuant to rule 66A to discharge

Speaker Ryan: "Representative Deuster."

Deuster: "Mr. Speaker and Ladies and Gentlemen of the House,
House Bill 87 has to do with an educational mandate. I am
a Member of the Education Committee. This Bill was heard
before the Committee. I had a full and fair hearing.
However, we did not get enough votes and I think this is an

important enough subject that I'd like to have this Bill brought to the floor and on the Order of Second Reading if any of you have any better ideas for how to relax or soften the daily physical education mandate I would be delighted to let you offer your Amendments. The way House Bill 87 reads now as amended, it says that a local school in Illinois may, may exempt a student from daily physical education is that student is participating for an average of two hours a day in some athletic endeavor or organized amateur or professional athletic endeavor. Let's say a football player who spends two hours a day playing football, or in my district..."

- Speaker Ryan: "Representative Schneider, do you seek recognition?"
- Schneider: "I think there's always a problem with the Nembership.

 If we're going to go through Motions he ought to address the Motion and not the issue."
- Speaker Ryan: "I think your point is well taken, Representative Schneider, and I might add that it's the intention of the chair to call on the Chairman of the Committee and the Spokesman of the Committee in each instance. And you should confine your remarks to the Motion. Representative Deuster."
- Deuster: "Yes, I'll try to be brief. It's always been a tradition since the Members quite often want to know what they're voting on to have a brief reference to the substance. I have briefly described the substance. This allows our local schools to exempt a student from daily physical education where that student is spending two hours a day in athletic endeavors such as a football team or a hockey team or something else. I think it is a subject that needs to get to the floor of the House and I would appreciate your affirmative vote so that House Bill 87 can

get to the floor and we can deal with this mandate. I might briefly say that forty percent of our schools are under waiver so the law is unworkable and unreasonable. Something needs to be done and I would appreciate your affirmative vote to bring this Bill to the floor. Thank you."

Speaker Ryan: "The Gentleman from Morgan, Chairman Reilly."

- Reilly: "Thank you, Mr. Speaker. Just briefly I would oppose the Motion to discharge Committee. We did have a hearing on this Bill. It is an important subject and it is before the Mandate Subcommittee of the Education Committee which has, a matter of fact, recommended a Bill of 'Do pass' on this subject in which we will be trying to bring to the floor of the House. There's no question that Representative Deuster agrees there was a fair hearing. I respect his right to make this Motion but I would hope as part of the Committee process that we would leave this Bill in Committee and work through that process. Thank you."
- Speaker Ryan: "Alright, the House will be in Order and the Members will be in their seats. We'll now hear from the Minority Spokesman on the Committee, Representative Schneider."
- Representative Reilly has been a decent and generous chairman in regard to issues that come before us in various kinds of forms. Physical education is one of those, driver's education is still another. Special Ed mandates is still a third. All of those require substantial hearings. This particular Bill, 87, received adequate full blown testimony early in the Session when we didn't have the Committee pinch. I don't see any reason why this Bill ought to be discharged had it received passage on the merits, I think, we would of course have had it on the

floor. It lacked the merit, it does not fall into the category of those Bills that did not receive substantial hearings. I would ask that we defeat the Motion."

Speaker Ryan: "Representative Mulcahey, did you want to speak on this issue?"

Speaker Ryan: "Well, it was my intention, Representative, to only have the chairman and the Minority Spokesman of the Committee speak but if you insist I'll... The question is,... the question is, shall House Bill 87 be discharged from the Committee on Elementary and Secondary Education?

Speaker Ryan: "Representative Deuster, on the Motion on House Bill 90."

Deuster: "Mr. Speaker, once again as a Member of the House Committee on Elementary and Secondary Education this Bill deals with the same subject but has a slightly different approach and I believe the approach is one that is more generally supported by the educational community. deals with the physical education mandate. As you know we have no requirement in Illinois law that children have reading, writing, arithmetic, mathematics but we do have a requirement that they have physical education every must be relaxed. House Bill 90 provides that every local school in Illinois may exempt students from physical education or adopt a physical education program consistent only with guidelines set forth by the Illinois Office of Education. This Bill respects our philosophy of local control of the schools and yet it guarantees that the State Office of Education will set forth some reasonable quidelines for the local schools to follow. This means that perhaps a local school, an elementary school offer physical education three days a week for longer hours or it might be that the local school will do as some in my district have done to adopt some policies for exempting a football player for those days that he's playing football or for the ladies who are playing tennis for any of the I think this is a good Bill that reflects the students. concept of local control of the school and also relaxes a mandate. Everybody is talking about mandates. This is an

opportunity for us to do something. I would appreciate your affirmative vote so our local schools may adopt their own policies of physical education just as they do with other academic subjects. Thank you."

There seems to be some kind of assumption that the process we're going through with the Mandate Subcommittee, headed by Representative Kustra, is not going to work in favor of those who want to reduce the mandate. The record is that the one and only specific mandate reduction Bill that they considered they reported favorably and we're going to try to get that to the floor of the House. I would ask that this Motion be defeated so that we can go on with that process which is working."

Speaker Ryan: "Representative Schneider."

- Schneider: "Thank you, Mr. Speaker. The same opposition as earlier. The Mandate Subcommittee as well as the full Committee will, well the full Committee already addressed this measure. The Mandate Subcommittee will address it later. I see no need again to pursue so brusquely an issue that needs so much in depth study. I would again ask for a 'no' vote."
- Speaker Ryan: "The question is, shall House Bill 90 be discharged from the Committee on Elementary and Secondary Education advance to the Order of Second Reading? Just circumstances prevented us from hearing House Bill 113 but this is so necessary to law enforcement agencies throughout the entire State of Illinois that we know when prisoners are being released especially in view of the early release program that it's imperative this Bill be heard on the House floor. The Committee adjourned prior to our assembling all the witnesses and the Department of Corrections. I think it important we hear it."

I first would like to say that I come to a Motion discharge very, very with great trepidation. I do not favor Motions to discharge as a rule. I have only once before in eight years of service in this House asked for this for the House to discharge a Bill from Committee. Only once. At this, this Bill 163 represents a response to the Bill that we opted out in the Bankruptcy Act last year. You will recall that the Governor of Illinois said in signing the opt out provision under the Bankruptcy Exemption Bill that it was his intention that we would work on exemptions, a series of modern exemptions for bankruptcy and for judgments in Illinois. As we stand now we have no modern exemptions in Illinois. Bills have been filed the Senate and another Bill in the House by Members across the aisle that I would, that I joined in, as a matter of fact. Representative Watson has a Bill. However, the Bill did not get called and as a consequence the Governor's committment to deliver modern bankruptcy exemptions will be frustrated if we do not discharge this Bill. I have taken essentially the Watson-Weaver Bill and amended it to my House Bill 163. I'm not interested in who gets the credit or anything like that but I think that this House must debate modern bankruptcy exemptions. Exemptions which we all acknowledged two years ago that the prison exemption are out of line that they must be changed. They must be modernized. So that we must, if we are to at all bring the Governor's committment into being we must discharge House Bill 163. I had a hearing, a short hearing in Committee and received eight votes and then one of the Members

changed their mind so it got seven votes just one short of getting out. There were about five Members that were absent who would have supported it and as a consequence I would ask that we discharge House Bill 163 in order to give us an opportunity to consider modern bankruptcy exemptions and to fulfill the mandate in agreement of the Governor when he signed the opt out Bill last year."

Speaker Ryan: "The Gentleman from Will, Representative Leinenweber."

If you recall the Governor's message on this particular subject matter. He said that we should be doing stuff with this particular subject matter at this particular time. I really think it would be a folly of the General Assembly not to act upon the Gentleman's Motion. I think it would be a sure act of folly not to move ahead and put it on Second Reading. It's something that everyone in the state realizes that we need. The Governor realizes that we need it and in his message he said we should act on this subject matter. I would therefore, urge an 'aye' vote."
- Speaker Ryan: "The question, is shall House Bill 163 be discharged from the Committee on Judiciary I?

 Representative Greiman."

Greiman: "Closing, Mr. Speaker?"

- Speaker Ryan: "Well, you'll be the only one but if you want to close go ahead, Representative."
- Greiman: "Hell, I want to close only because of certain statements that the chairman made as to the bringing the Bill promptly. I did not bring this Bill before the Committee initially because Representative Watson had filed a Bill of similar subject matter and I certainly understood that he was more likely to pass his. And that's simply what it does. think this issue needs to be brought to the floor. I think it needs to be discussed and even though I had a fair hearing with the seven to six vote, I think this is an

If you would recall for the last two years we reduced that sales tax a percentage a year. This Bill was assigned to the Revenue Committee on Pebruary 19. I appeared before that Committee and the chairman indicated that it would be assigned Subcommittee and that they would work on that legislation and that I would get an opportunity to have it heard Subcommittee and passed out. I'm still waiting for the Subcommittee to meet. I'm still waiting to hear from the Committee Chairman. I've not received any other hearing and therefore, I file this Motion. It's my intention if we act favorably on this Motion tonight to amend the Bill Second Reading to put an effective clause in stating that this percentage should come off July 1, 1982.

for that is at the present time the State of Illinois cannot afford to lose this Revenue. However, if we put a new effective date in the Governor can plan in his budget for next year this removal of the sales tax on food and drugs. I feel it's well thought out. Currently the Illinois obscenity statute applies only to sex and in 1977 in a U.S. Supreme Court decision of ward versus Illinois that Judicial Body not only upheld the did Illinois obscenity statute but they sado-masochistic publications would be included as being obscene under the Illinois statute and not under the Constitution. This transgression, ladies and Gentleman in my opinion, gives the various Legislative Bodies an opportunity to define violence as being obscene and that's exactly what it is. In many ways in my opinion, the violence that we see at the theaters and on television is even more obscene than the sex which is demonstrated. And to go on further, we are entering a new area of cable television and I am very concerned, especially with the young people that are very impressionable that the cable television programs will not be monitored at least to provide sensibleness and to prevent violence from being shown across the State of Illinois. I don't have any objection to consenting adults who want to see violent or sexual perversions. But when it goes beyond that boundary to children, I say that is the end and there are a number of organizations, I know the PTA organization in Illinois. I know everybody in this House and in the Senate received a

letter from a group over in Decatur calling themselves the National Group Against Violence. Now, there was a recessed hearing that evening however, I am Minority Spokesman on the House Appropriations Subcommittee on Human Services and we were taking up all Amendments to the House 588 that night which is all the Human Service Departments and as Minority Spokesman I had to be at that hearing during the evening and I could not come to

Executive. House Executive Committee. Normally, I would ask someone to handle my Bill for me. However, this particular piece of legislation I wrote by myself from the ground up and frankly there was nobody that I could turn to who could handle the legislation on my behalf. All the Bill does is to set up a House Senate Sub. Committee, rather, to try and get our laws in shape with respect to the use of Senate data, to accept certain things like salaries of municipal officials and county officials and so forth. I move to discharge."

- Swanstrom: "Thank you, Mr. Speaker, Ladies and Gentlemen of the House. I would respectfully request that the Members of this House suppose the Gentleman's Motion. The Sponsor is absolutely correct when he states that he was in Committee all morning. We did have ninety Bills plus a few others posted for that day. We tried to move as expeditiously as possible. We were recessed. We went back in. We met until 7:30 or quarter till 8:00. The fact of the matter is the Sponsor did not show up. If he had shown up the Bill would have been heard. And I would hope that the House would reject this Motion."

- Bowman: "Well, yes, Mr. Speaker. In closing I'd just to say that I was with Representative Reilly all during that time. We were working on legislation in another Committee. I am Minority Spokesman on the other Committee and I had responsibilities there. I think that Representative Swanstrom was trying to imply that I was shirking my responsibility far from it. I was doing what my constituents sent mе down here to do. I told

- Speaker Ryan: "Out of the record. House Bill 881, Representative Yourell. Out of the record. 908, Yourell. Out of the Record. 974, Representative Steczo. Read the Motion."
- Clerk O'Brien: "Pursuant to rule 66A, I move to discharge the Committee on Elementary and Secondary Education from further consideration of House Bill 974."
- Speaker Ryan: "The Gentleman from Cook, Representative Steczo."

 Steczo: "Thank you, Mr. Speaker and Members of the House. House

And then once a month the state library will send each of us a form showing what new reports they've got during the month and if we want them we'd check it off and send it back to them. - Speaker Peters: "Any further discussion? Representative Swanstrom."

If he was so busy that he couldn't be there himself, he could have authorized any other Member of this Assembly to handle that Bill for him. If it has such bipartisan support that could have easily been done. I would urge the Membership to reject his Motion."
