Senate Bill 1021 is amended transfers general revenue funds from several operation lines to contractual and travel lines for medical management information systems and from various lines to distribute as grant lines for aid to families with dependent children, aid to the aged, blind and disabled, the Indo-Chinese program, funeral and burial expenses and hospital in-patient services. It repeals one and a half million dollar allocations to the child support enforcement division and adds 9.9 million to income assistant grants to balance the 9.9 million reduction in nursing home grants accomplished in Senate Amendment #1 to House Bill 538. There's no changes in the bottom line. It is strictly a transfer only. No additional money. No changes in the bottom line. I would ask for your favorable support in the passage of Senate Bill 1021."

Speaker Peters: "On that question, Representative Matijeich."

Matijeich: "So that I only have to rise once the Members on this side of the aisle all for the Senate Bills. We've worked them out and they're all a-okay."

Speaker Peters: "Representative Wolf, to close."

Wolf, J. J.: "No further closing, Mr. Speaker. As the Minority Spokesman said they are all agreed Bills. They are all for transfer Bills. This one plus the next three coming up. I ask you favorable vote."

Again this Bill is a transfer supplemental. No additional funds will have to be appropriated. An identical situation took place last year when large budget cuts in the FY '80 personal services line items were replaced by a transfer from the Circuit Breaker Fund. This Bill, as others like it, pass unanimously 54 to nothing out in the Senate and I would appreciate your favorable vote."

Senate Bill 1163 adds the total of \$20,000 in federal agriculture marketing service funds to the FY '81 appropriation for the Department of Agriculture. What that goes for is to set up a trade referral program computerized. It also transfers \$23,000 from a special service line in the contractual service line to services for the hiring contractually of a federal employee in the area of agricultural soil and conservation service. I urge your favorable vote."

Speaker Peters: "On that question, Representative Giorgi."

Giorgi: "Mr. Speaker, according to the legislative synopsis the \$23,000 is from gambling tax. What are they going to use \$23,000 gambling dollars for? Do you know?"

Speaker Peters: "Representative Ropp."

Ropp: "Well, we need to take care of paying this employee. That's one reason."

Giorgi: "You're going to pay an employee totally with \$23,000 in gambling dollars? Is that what you're going to do?"

Ropp: "Actually, it's a transfer within that particular line item it was under personal services and is taken from already authorized money to contractual services."

Giorgi: "Who's the beneficiary of that contract?"

Ropp: "A guy by the name of Gary Wood who's a federal employee."

Giorgi: "Why would we be using local, you know, state gambling dollars for this job? What's this job going to do for us?"

Ropp: "Okay, this fellow is a federal employee and the Federal

Clerk O'Brien: "House Joint Resolution Constitutional Amendment #2, resolved by the House of Representatives of the 82nd General Assembly of the State of Illinois the Senate concurring herein, there shall be submitted the electors of the state of adoption or rejection of the general election next occurring at least six months after the adoption of this Resolution and proposition to amend Section 4 of Article IX of the Constitution to read as follows: Article IX, Section 4, Real Property Taxation. A) Except as otherwise provided in this Section taxes upon real property shall be levied uniformly by valuation ascertained as the General Assembly shall provide by law. B) Subject to such limitations as the General Assembly may hereafter prescribe by law, counties with the population of more than 200,000 may classify, or continue to classify real property for purposes of taxation. Any such classification shall be reasonable and assessment shall be uniform within each class. The level of assessment or rate of tax of the highest class in a county shall not exceed two and one half times the level of assessment or rate of tax on the lowest class in that county. Real property used in farming in a county shall not be assessed at a higher level of assessment than single family residential real property in that county. C) Any description in the value, any depreciation in the value of real estate occupied by a

public easement may be deducted in assessing such property.

D) The General Assembly may by law authorize counties to suspend or abate taxes upon real property. E) Rehabilitation growth incentive option; any municipality may designate certain specific areas within its boundaries in which the real property is to be taxed on the basis of site value without regard to the value of improvements thereon. The tax rate of taxing districts a... holds such designated areas shall be adjusted annually to prevent loss of revenue received by such taxing districts from such designated areas. Taxation of designated areas under this option shall continue for twelve years, but may be extended without limit as long as any such extensions are not are for no less than twelve year periods. I think that we ought to adhere to them except in an emergency. I don't think this is an emergency. The Bills can be heard next week and I would object."

Speaker Peters: "Representative Stearney, according to the rules if there's not unanimous consent your request cannot be put."

Neff: "Thank you, Mr. Speaker. I'd like to have permission to postpone the posting of three Bills to hear in Study Commission tomorrow. They've just been reassigned. That is Senate Bill 138, 215, and 853 and I'd like to hear them tomorrow morning at 9:00 at the regular meeting."

Speaker Peters: "The Gentleman asks leave to waive the posting rules to have Bills heard in the Committee, the next meeting of the Committee on Transportation. Is there, Representative Kane."

Kane: "What's the nature of the emergency for this?"

Speaker Peters: "Representative Neff."

Neff: "Representative Kane, we have a limit of amount of time. We have more Bills we will have to hear. I've only got two Bills posted for tomorrow and we'll have the time to hear the three more. I can't even tell you what the Bills are because I just got them assigned to me and haven't looked them up yet but I see no reason why we shouldn't go ahead
