There being nothing further, the Chair recognizes Mr. Matijevich for the purpose of the Adjournment Motion to February 1 at twelve noon."
- Matijevich: "Mr. Speaker, Ladies and Gentlemen of the House, I move the House stand adjourned until February first at noon to hear the Governor."
- Speaker Madigan: "The Gentleman has moved that we stand adjourned until February one at twelve noon. All those in favor say 'aye', those opposed say 'no'. The 'ayes' have it, the House does stand adjourned until February one at twelve noon. Strike that...we will convene at 11:30 on February one. February one at 11:30 and there will be a Perfunctory

House Bill 118. offered by Representative Johnson et al, a Bill for an Act to repeal the Compensation Review Act. First Reading of the Bill. House Bill 119, offered by Representative Anthony Young, a Bill for an Act to add Sections to the Illinois Purchasing Act. First Reading of the Bill. House Bill 120, offered by Representative Terzich et al, a Bill for an Act to restrict smoking in public places and providing penalties for violations thereof. First Reading of the Bill. Introduction and First Reading of House Joint Constitutional Amendments. House Joint Constitutional Amendment #1, offered by Representative Bowman.

'RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE EIGHTY-SIXTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that there shall be submitted to the electors of the State for adoption or rejection at the general election next occurring at least six months after the adoption of this resolution, a proposition to amend Section 9 of Article IV and Section 2 of Article VIII of the Constitution to read as follows:

ARTICLE IV

SECTION 9. VETO PROCEDURE

(a) Every bill passed by the General Assembly shall be presented to the Governor within 30 calendar days after its

2nd Legislative Day January 12, 1989 passage. The foregoing requirement shall be judicially enforceable. If the Governor approves the bill, he shall sign it and it shall become law.

(b) If the Governor does not approve the bill, he shall veto it by returning it with his objections to the house in which it originated. Any bill not so returned by the Governor within 60 calendar days after it is presented to him shall become law. If recess or adjournment of the General Assembly prevents the return of a bill, the bill and the Governor's objections shall be filed with the Secretary of State within such 60 calendar days. The Secretary of State shall return the bill and objections to the originating house promptly upon the next meeting of the same General Assembly at which the bill can be considered.

(c) The house to which a bill is returned shall immediately enter the Governor's objections upon its journal. If within 15 calendar days after such entry that house by a record vote of three-fifths of the members elected passes the bill, it shall be delivered immediately to the second house. If within 15 calendar days after such delivery the second house by a record vote of three-fifths of the members elected passes the bill, it shall become law.

(d) The Governor mav reduce or veto any item of appropriations in a bill presented to him. Portions of a bill not reduced or vetoed shall become law. An item vetoed shall be returned to the house in which it originated and may become law in the same manner as a vetoed bill. An item reduced in amount shall returned to the house in which it originated and may be be restored to its original amount in the same manner as a vetoed bill except that the required record vote shall be a majority of the members elected to each house. If a reduced item is not 50 restored, it shall become law in the reduced amount.

(e) The Governor may return a bill together with specific recommendations for change to the house in which it originated.

(b) The General Assembly by law shall make appropriations for all expenditures of public funds by the State. Appropriations for a fiscal year shall not exceed funds estimated by the General Assembly to be available during that year. <u>The General Assembly</u> by law shall provide for enforcement of this subsection.
