(d) A Bill should be read by title on three different days in each House. Bill and each Amendment thereto shall Α be reproduced and placed on the desk of each Member before final passage. Bills except Bills for appropriations and for the codification, revision or rearrangement of laws shall be confined to one subject except as otherwise provided in Sub-Section E-2 of this Section. Therefore be it resolved by the House of Representatives of the 86th General Assembly of the State of Illinois, the Senate concurring herein that there shall be submitted to the electors of the state for adoption or rejection, at the General Election next occurring at least six months after the adoption of this Resolution, a proposition to amend Section 8, of Article 14. of the constitution to read as follows. Article 4, section 8 passage of Bills (a) The enacting clause of the laws of this state shall be it enacted by the people of the State of Illinois represented in the General Assembly. (b) The General Assembly shall be enact laws only by Bill. Bills may originate in either House but may be amended or rejected by the other. (c) No Bill should become a Law without the concurrence of a majority of the Members elected to each House. Final passage of a Bill should be by a record vote. In the Senate at the request of two Members and in the House in request of five Members a record vote may be taken on any other occasion. Α record vote is a vote by yays and nays on the journal. (d) A Bill should be read by title on three different days in each Bill and each Amendment thereto shall be House. Α reproduced and placed on the desk of each Member before final passage. Bills except Bills for appropriations and for the codification, revision or rearrangement of laws shall be confined to one subject except as otherwise provided in Sub-Section E-2 of this Section.
