House Joint Resolution Constitutional Amendment #17, offered by Representative Johnson - Keane - Parcells - McGann, resolved by the House of Representatives of the 86th General Assembly the State of Illinois the Senate concurring herein, that there should be submitted to the electors of the state for adoption or rejection of the general election next occurring at least 6 months after the adoption of this resolution. The proposition to add Section 9 to Article VIII of the Illinois Constitution as follows: Article VIII General Provisions, Section 9 Administration of Government. The General Assembly by law has the exclusive authority to provide for the administration of government and the systems, standards, and policies governing an accounting, auditing, procurement, filing, reporting, financial and regulatory controls applicable to state government, units of local government and school districts. Constitution Amendment #20, offered by Representative Johnson - Keane - Parcels - McGann, resolved by the House of Representative the 86th General Assembly of the State of Illinois the Senate concurring herein, that there should be submitted to the electors of the state for adoption or rejection of the general election next occurring at least 6 months of the adoption of this resolution. The proposition to add Section 25 to Article I of the Illinois Constitution as follows: Article I Bill of Rights, Section 25 Regulation of Business. The regulation of any lawful profession, vocation or business activities shall be only as provided or authorized by the General Assembly by law or as permitted by the powers of home rule units. And all regulations shall be only as reasonably necessary for the legitimate protection of the health, safety, and well fare of the people.
