I just rise in support of the Representative's Resolution. I think it's very similar to the College Savings Bond Act that we passed last year with broad based bipartisan support. I think the ability to invest in one's future and save for your retirement is a benefit not only to the individual, but certainly to the benefit of the economy of the State of Illinois. And I would certainly urge an 'aye' vote on House Resolution 221."
