If I could take just a minute, I'll really quick run through my squad. Who did I leave out? That's my squad. Thanks again for having us. Thank you, Bill, I appreciate it."

Black: "Thank you, very much Ladies and Gentlemen."

Speaker Keane: "Representative Young in the Chair."

Young: "Thank you, to the Members of the General Assembly, I'd like to recognize the presence of Reverend Herbert Martin, the Executive Director of the Chicago Commission on Human Rights; Reverend Martin."

Speaker Keane: "Page 2, Second Reading, Short Debate. House

Representative Churchill, for what reason do you rise?"

Churchill: "Mr. Speaker, I'd like to ask a question. I was hoping you could shed some light on something for me. You know this place is an absolute mess. I mean, you know maybe it's not so much of a mess here on the Floor but as you get off the Floor and you go out into the Committees, this place is an absolute mess. You've got Committees meeting all over the place with Sub-Committees meeting. Nobody knows when the Sub-Committees are meeting. Nobody

You've got Sub-Committees where you go and try to pass a Bill out of the Sub-Committee and then you've got to come back and re-present all of your testimony in front of the full Committee. Everybody is just being mistreated in the whole process and my real question to you is this: Is this something that is intentional? Does the Speaker House intend for everybody to be running around like chickens with their heads cut off, not getting anything accomplished? Is this the way of killing Bills so that the Speaker doesn't have to put a down arrow on it some point along the line? I mean is this an intentional act or this something that's not intentional? Is this something that for the Speaker who tells everybody what business person he is and how he runs a business-like House and he allows this confusion to exist? Is this an intentional act or is this unintentional?"

- Speaker Keane: "As a late famous Mayor said, what trees have you planted lately?"
- Churchill: "I've been sitting in the Sub-Committee with you trying to kill the trees that bore the fruit that you didn't want to eat."
- Speaker Keane: "We're going to work on that paper concession, you and I and become millionaires. Representative Matijevich."
- Matijevich: "Yes Mr. Speaker and Members of the House. The Rules

- Clerk O'Brien: "House Bill 98, a Bill for an Act in relation to garbage disposal. Second Reading of the Bill. Amendment #1 was adopted in Committee."

Speaker Keane: "Any Motions?"

Clerk O'Brien: "No Motions filed?"

Speaker Keane: "Any further Amendments?"

Clerk O'Brien: "No Floor Amendments."

Speaker Keane: "Third Reading. House Bill 110 on page 3...on
page 2, Second Reading Short Debate Calendar,
Representative Satterthwaite. Representative
Satterthwaite, take it out of the Record. House Bill 124,
Representative Preston. Representative Churchill, for what
reason do you rise?"

Churchill: "Thank you, Mr. Speaker, I noticed that the real Speaker has appeared on the Floor and I would like to renew my question as to whether the mess οf all Sub-Committees that Chairman hate is vour own an intentional act or whether it's something that is unintentional and whether all the confusion is something that perhaps can be corrected by eliminating Sub-Commitees and eliminating all of the screwing around we're doing and letting Members just present their Bills before the I noticed that the real Speaker is behind you Committees. and I am wondering if you could just ask him to please shed some light on this whole issue?"

- Speaker Keane: "I will take it under advisement and you'll notice that when I'm presiding, I'm the real Speaker."
- Churchill: "Is that with portfolio or without portfolio?"
- Speaker Keane: "Either way. We'll get back to you in a couple of days on that one. Representative Ewing. Representative Ewing, for what purpose do you rise?"
- Ewing: "Well, trying to follow up on Representative Churchill.

 We can't hear a thing in this place. I've never heard it so bad. The velvet hand, let's have it, let's ..."
- Speaker Keane: "Your point is well taken."
- Ewing: "I'm trying to Mr. Speaker. Yes, Mr. Speaker, and I also noticed that there was some applause from the Gallery, we don't allow that but when we talked about our Bills being killed in Committee I think the word is getting around. I think we have to get some order back in this place. We have to move our Bills along. We all have legislative agendas that are important to our Districts and that's important that we have the opportunity to handle them. I would like to see some order in this House and some order in the Committee."
- Speaker Keane: "Your absolutely right Representative, and for your information we did move your Bill to Third, so there is a little movement."
- Ewing: "I didn't say anything until after it was moved."
- Speaker Keane: "We now have Representative McCracken, for what purpose do you rise?"
- McCracken: "Well along the same lines, we had an interesting experience in the Judiciary Committee today. The multiplicity of Committees has forced people to leave in order to be in more than one place at a time, so as to comport with the scheduled Committee Meetings. But rather than cut back the number of Committees, we are now moving toward proxy voting. Today we approved over Republican

objections the use of an Open Roll Call by which Roll Calls can be opened virtually at the discretion of the Chairman the Majority and in effect allowing what amounts to proxy voting and we objected to that. That is the practice that has been discredited and discarded by this institution and it is a direct result of this plethora of Committee People are unable to carry their Committee's assignments. load and be responsible to all of their voting requirements. In effect, what you do by leaving these Roll Calls open is to give the Majority the opportunity to vote as it sees fit and to make all of it's other commitments. In effect, what you do is sanction proxy voting. Something that has been discredited and discarded in the past. think the time has come where we have to make the stand. I don't want the press to think we're crying wolf. important. It goes to the very heart of this matter. It. goes to the very heart of this process and I told the Committee this morning we would not let it stop there. is a problem. It is a question of abuse of power. And I'll tell you something else and I know you're not going to respond. you'll look over shoulder and talk to the real but let me tell you something else, the point has arrived where we are now being told repeatedly that if your Bill amends a certain title of the Illinois Revised Statutes, we'll let a Democrat carry it but you can not carry it. We are seeing also that our targets are being discriminated against for no better reason than they have incurred the wrath of the majority by having the nerve win an election. It happens to our Freshman targets. Ιt happens to our targets no matter how long they've been And the time has come where it has to stop. Now I propose that we take some strong action today. We start putting a freeze on this place and we take a good lesson

from our Brethern in the Senate. We're being treated unfairly and we won't stand for it. Now we want some changes made and we want some commitments to those changes. We want to end proxy voting. We want to end discrimination against Republican target's. We want end discrimination against Republicans because you don't want to vote on the Floor as to a particular issue. And let's be candid about it. it's in the medical malpractice area among others. can not sponsor a Bill which amends the Code of Civil Procedure because you are afraid of a Floor vote. Even though you've got the majority, you're afraid of a vote. You will not let us carry any legislation which could even remotely offend your sensibility. And I'll tell you something, I had an experience with it this morning and the lobbyist who asked me to carry the Bill, a former Democrat was shocked that we have gotten to a point where we are openly and notoriously told that we can not sponsor certain types of legislation. They don't disagree with the Bill; we just aren't fit to be the Sponsors."

- Speaker Keane: "For your information Representative McCracken,

 I'm told the Speaker will take this under advisement and
 will provide a memo on it. There will be ... let's see,
 the next, Representative Hallock, for what purpose do you
 rise?"
- Hallock: "Thank you, Mr. Speaker, Members of the House. On the same point, I also was in Judiciary this morning and when the Chairman of that Committee said he wanted to have an open Roll Call, I objected. At that point and time they deferred until the Parlimentarian came in and they went ahead with the Motion. The Bill at hand you should know about, the Bill happened to be a Gay Rights Bill which has been around this process and this Chamber as long as I have been in the General Assembly. It was a Bill obviously with

very strong ramifications and a very strong issue to many people and there obviously are those on the opposite side as well who feel the same way. But the issue, of course, was what happened there. The Speaker...the Chairman opened that Committee for a vote, allowed two Members to vote about 45 minutes later when they actually took a vote on the Bill itself, those Members were both gone. It seemed to me Mr. Chairman, Mr. Speaker that that's improper. I'll acknowledge that we have in the House have over time as a courtesy off and on, allowed that to occur. I see going on now, is that's going to happen over and over again. The flaw is so much not the diligence and the assiduous nature of the Members, but the fact they have too many Committees to serve on and even the best Member can't be at all places at all times. It's a bad procedure and to allow us now to have a normal occurrence of an open Roll Call is a very very great flaw in this process. It weakens not only the General Assembly, but it weakens democracy as a whole. It's a bad idea, let's not let it happen any more. I urge you to stop that policy."

Speaker Keane: "Representative Dunn."

Dunn: "Thank you, Mr. Speaker and Ladies and Gentlemen of the House. I missed some of the debate but I guess it's about opening Roll Calls and let me set the record straight with regard to Judiciary I Committee at least. Ι comments with regards to other Committees. Ιt indicated by the Chairman of House Judiciary I and I am the Chairman. Early in the Session that the Chairman does not approve of opening Roll Calls. However a number of Members on both sides of the aisle ask that Roll Calls be opened so they could go to other Committee Meetings and with Leave of the Committee that was done House Judiciary I Committee and I didn't object to it;

figuring that's the will of the Committee, I'm the Chairman but whatever the will of the Committee is, is the will of the Committee. This morning there was a request to open a Roll Call and there was an objection. I indicated there no more Open Roll Calls in my Committee. again it is my philosophy, that's my statement of Subsequent to that announcement there was a Motion to open a Roll Call and a majority of the Members of the Committee voted favorably on that Motion. The people on the other side of the aisle who were objecting to the procedure ought to realize that, in effect, what happened in the House Judiciary I Committee this morning was that the net result was a Motion to overrule the Chair and the Members of own party voted on that Motion and overruled me. I'm not bent out of shape by that. The majority of the Committee we opened a Roll Call. I didn't like it at the start of the semester; I don't like it today; I didn't like it yesterday; I won't like it tomorrow; but the majority of the Members of the House Judiciary I Committee voted to open a Roll Call. If they did that, that's their business. The Roll Call was open. It'll stand that way and if there are other Motions, they will pass or fail depending upon how the majority votes on the rule. So in House Judiciary I Committee, if you have a complaint and don't like the way things are run, get a majority of the Members to vote and the procedure will change. If you like the way it's run, then vote with the current procedure and if have a complaint come and see me and we did the very best we could this morning to call Bills for Members parties giving preference to people with out of town witnesses. So I hope that we can put an end to this nonsense about arguing about open Roll Calls. It's a mess, but it's there, let's just get along with our business."

Speaker Keane: "Representative Tate."

Stephens: "Well thank you, Mr. Speaker. It's sometimes hard for me to understand why this is all necessary. I was reminded yesterday in the Insurance Committee when Leave was asked to open the Roll Call and we were told when we objected that we got... the Democrats have the votes, that want to play hard ball, that we'll be taught how to play hard ball. The simple objection to the rules is being called playing hard ball and that we'll be taught a lesson; we'll be showed how to play hard ball and that we should take that message to our Leadership. Mr. Speaker I don't understand: you've got the numbers; you've got the rule book that you wrote; you have everything on your side. When you want to pass your Bills you can do that. Why should you try to extend the rules to benefit your Members and to do injustice to the people in the State of Illinois. I just...it's beyond my comprehension why you want further You have all the advantage you need advantage. tο accomplish whatever it is your goals for the state are. We are sometimes confused by the rules and what your goals are, thank you."

Speaker Keane: "Representative Tate, sorry about that.

Representative Tate."

Tate: "Thank you, Mr. Speaker, I too would like to direct my remarks at Speaker Madigan. Speaker Madigan chose to..."

Speaker Keane: "Excuse me Representative Tate, could we have a little bit of order. Could we have some order please?

Proceed."

Tate: "Speaker Madigan chose to cancel Session in the month of March. We have 2,811 Bills introduced by 118 Members of this process and as Speaker representing the entire state and representing all of our Members, I'm sure that his intent was to have some type of orderly process to this.

But what has happened now is: we have one week left of Committee deadlines, we have close to 500 to 700 Bills that haven't even been printed yet, we don't have analysis on Bills and what this process is turning out to be is a sham because what he has forced his own party to do, he has instructed his Chairmen to open up Roll Calls to Member's Bills out and we have limited public input. don't even have time in some of these Committees to hear testimony for and against the Bills. This is a Democratic process. Everyone of our Members, both Democrat and Republican care about the Bills that they introduce. They want an opportunity to represent people, have their issues heard, have their views heard, have people come from back home and testify on those Bills and do so in an orderly this fashion, this process has been fashion. But circumvented and now what we have is we have a process choas where you're passing your Bills out on a whim and nothing happens. Let's put some order to this process, this Speaker can put some order to that process. Let's sit down with a Member of both sides ... both parties, both sides of the aisle and let's work out some kind of agreement to get some order back in this process."

Speaker Keane: "Representative Black"

Black: "Well thank you very much, Mr. Speaker and Ladies and Gentlemen of the House. Let's put a different spin on this. I don't think this is an partisan issue and far be it from me to try to make it a partisan issue. I sat in on Committee today and will be here until late this evening and I see your Members having just as many problems as we are. They are running from Committee to Committee. They're trying to present Bills. I've seen Committees that have had to stand in recess because we don't have enough Members to conduct the business that we're sent here to

conduct. Now I would simply appeal to the Speakers capabilities and abilities: there has to be, Mr. Speaker a better way to conduct the people's business than this. Either we reduce the number of Committees or we together and figure out a better way to do it. This isn't a partisan issue. All of us are running all over this capitol trying to present our Bills, trying to serve on Committees, doing the best we can to represent the people that sent us down here, trying to conduct state business. I appreciate the fact that you've said he will respond to in writing and I look forward to that memo. But in the words of that great statesman, Mr. Speaker, let us move about the business of this House in a kinder and gentler fashion. All we ask is please, there has to be a way to do this than what we're doing and I look forward to that memo and I look forward to that kinder and gentler way of doing the business that we're sent here to do."

Speaker Keane: "Representative Parke."

Parke: "Thank you, Mr. Speaker, Ladies and Gentlemen of the House. I also support Representative Black's position. We all have the same problems. We all have the same running from Committee to Committee, but there is not a problem with us extending courtesies. I think that we all have to work together to solve problems and we work together as friends to try and solve these problems. What we're talking about is the abuses that we're starting to see. The blatant way of ignoring Republican initiatives, the blatant way of ignoring targeted Legislators, those that you don't know. We're asking for you to just extend the courtesy, live by the golden rule so that we all can get the work of the people of Illinois done. Thank you."

Speaker Keane: "Representative Mulcahey."

Mulcahey: "Well with deference to what we've been hearing from

the other side over there, maybe they should, everybody should take a lesson from the Elementary and Secondary Education Committee. If it weren't for getting Leave this morning to open up the Roll Call there's about 4 or 5 Republican Bills that would not have gotten out, and as a result of that they did get out. So in deference to what we've been hearing in the political diatribe, certainly we've been doing our job in that Committee and I think that everybody that's on that Committee on that side of the aisle can probably agree. So Mr. Speaker, I think you're doing a wonderful job, things are running very smoothly and don't worry about all of this stuff that what we're hearing from over here and I would just ask my colleagues to stay with that policy and that principal because things are moving smoothly in that Committee."

What this Bill does and it does only one thing, the Bill we have before us today is to accelerate the effective date of the School Reform Bill that we passed last year so it would be effective on May

In other words, the only purpose is to accelerate the appointment of the Interim Board and not to accelerate the entirety of the Act in and of itself, is that correct?

Levin: "Again, you are correct."

williams: "With that I have no objection, I thank you for your support and I intend to support it. Thank you."

Speaker Keane: "Representative Davis."

Davis: "Thank you, Mr. Chairman. Will the Sponsor yield?"

Speaker Keane: "He indicates he will."

Davis: "Representative Levin, the Interim Board made up of six or seven people?"

Levin: "Seven people."

Davis: "Seven new people will do the negotiating with these 23 unions?"

Levin: "They would be negotiating."

Davis: "Did someone give you the answer yet, no."

Levin: "Yes, they would be entering into negotiations."

Davis: "Pardon?"

Levin: "They would be entering into negotiations."

Davis: "So in other words, Ellis Levin, we're going to have seven brand new people who will know very little about the

complicated business of the School Board, negotiating contracts with 23 unions."

Levin: "Representative, current Board Members are not precluded from being reappointed to the Interim Board, so that..."

Davis: "You know I could be, I would be more willing to do this if I knew who the Interim Board Members are, but we don't know who they will be do we?"

Levin: "No, that is the prerogative..."

Davis: "Alright Ellis..."

Levin: "...of the new Mayor of the City of Chicago."

Davis: "Will this Interim Board also select the new Superintendent?"

Levin: "It may."

Davis: "But they will not be the Board that works with the Superintendent, is that correct? You know, remember the purpose of having a new Board was in order that the old Board not pick a Superintendent that they won't have to work with."

Levin: "The Interim Board will serve to a date certain, and that date is May 15, 1990. If they select a new Superintendent prior to that time they'll be working with that new Superintendent as long as they continue to serve as Members of the Board."

Davis: "Representative I still do not understand why we want to speed up the effective date of a bad Bill."

Levin: "Representative, the current law that was passed by this Body and the Senate and signed by the Governor provides for a July 1st effective date. If we do nothing, there will be a new Board in place as of August 1st. So you will have a change whether you pass this Bill or not. What this Bill suggests is that we need to get started with those negotiations as quickly as we can. So we need to put into place those Board Members who are going to be making the

decisions in terms of the negotiations with the 23 unions."

Davis: "So, in other words we are going to have an Interim Board whose sole function it will be, to negotiate with the union, hire a new Superintendent and then that Board is gone. They don't have to live with any decisions that they make because they are not permanent. So whatever decisions they make, they will not have to be there to accept the criticism or whatever from the community because then they won't be there any longer. They'll be gone."

Levin: "Representative..."

Davis: "You know, don't you think that this is much to important a task to leave to a temporary group of unknown citizens?"

Levin: "Representative, it is going to happen anyway. If we do nothing, we will have an Interim Board. It will be two months later before we have it."

Davis: "If we don't do this, you'll have an existing Board who has experience, who has experience in negotiating with these hard-nosed unions. But you don't want this experienced group of people to negotiate, you want new inexperienced people to do the negotiating and to select a new Superintendent. It's a bad Bill. I voted no and why should we vote to speed up a bad Bill."
