Homer: "Well, thank you, Representative McCracken and thank you, to all of you who have...through your kindness and notes and expressions of sympathy. It certainly gives support in a time like that and I thank you."

Speaker McPike: "Alright, the Attendance Roll Call will be used and Representative Homer's Motion carries. The second Motion is on Senate Bill 1916 by Representative Phelps."

Phelps: "Thank you, Mr. Speaker, Ladies and Gentlemen of the House. I move to discharge Judiciary II from further consideration and advance to the Order of Second Reading.

This...I must clarify that I did have a fair hearing, a short time in Judiciary II. Representative Homer, Mr. Chairman there was very open about hearing our Bill. This passed out of the House with 84 votes, I believe, identical Bill that went to the Senate, and we feel like...the votes and support was there, we didn't have the time. I would appreciate the consideration."

Speaker McPike: "Representative McCracken."

McCracken: "Yes, this...really what we're considerating at this point if I move to divide the question is the Calendar requirement which takes 71 votes for you to suspend. We have seen this type of Bill before, we're familiar the merits of the issue, we are in opposition to the merits of the issue. I ask my colleagues to join me in resisting the Motion to suspend the Calendar requirement."

Speaker McPike: "Representative Olson."

Olson, M: "Thank you, Mr. Speaker, Ladies and Gentlemen of the House. I'd join Representative Phelps in his request for a favorable vote on this discharge Motion. We've addressed the issue here one time before, and now we can put it in a good form."

Speaker McPike: "Representative Wennlund."

Wennlund: "Thank you, Mr. Speaker, Ladies and Gentlemen of the House. I rise in opposition to the Motion to discharge. It had more than a fair hearing in Judiciary II. What this Bill does is..."

Speaker McPike: "To the Motion, Sir."

Wennlund: "Rise in opposition, I urge all the Members and colleagues to vote 'no' on this side of the aisle."

Speaker McPike: "Representative Regan."

Speaker McPike: "The...the Parliamentarian is going to check on this and...Representative Williams...Representative Homer."

Homer: "Thank you, Mr. Speaker. By the way, if the electrician would check my light, it doesn't seem to work, my speak light. Actually the...the Bill was called and voted on twice in committee, it failed on both Roll Calls, I would ask the Parliamentarian to consider, in fact, whether our rules there by automatically table a Bill that is called a second time in committee, a second Roll Call. And therefore, I would submit that the Bill is currently on the table and that the correct Motion for the Gentleman would be a Motion to take from the table, and not a Motion to discharge."

Countryman: "Well, thank you, Mr. Speaker. In the seven years I've been here, I've never been more confused about a Bill than this one. I'm the Minority Spokesman in this committee, I was there...Representative White came in, asked to put an Amendment on the Bill which I opposed, that's Amendment #1. Amendment #1 was adopted, there are

two subsequent Amendments, Amendment #2 and Amendment #3 which were adopted I think without objection, which dealt with the substance of the Bill. After that failed, then the reconsideration was given and Amendment...Amendment #1 was supposedly withdrawn. Then we voted on the Bill and it failed again. Anyway you look at it, this Bill ought to die right here, right now. Vote 'no'."

Regan: "Mr. Speaker, please. I have to know...it has to be verified whether Amendment #1 is still on the Bill or not on the Bill before we can vote. Is there anyway to tell that?"

Santiago: "It is my belief that Amendment #1 is not...on the...on the Bill. But I ask for your support on this Bill, this is a good Bill. The Bill should have been reported as tabled, pursuant to Rule 26(d). The House will remain in Perfunctory Session until call of the Chair. Perfunctory Session will be back in Session. Committee Report, Representative Rice, Chairman of the Committee on Elections, to which the following Bills were referred, action taken June 7, 1990 reported the same back with the following recommendation: 'Do pass', Senate Bill 1990. Being no further business the House now stands adjourned."
