I suspect no one really gets aggravated more when they see individuals that (sic - who) are not handicapped, that do not handicapped license plates, or that do not have the proper authorization from the Secretary of State's office for a handicapped parking permit that (sic - who) parks in facilities like this. It certainly takes the ability of handicapped people to park near businesses and doctors' offices so they have better access to reach and do their business, and I ask you for your support."

Speaker Turner: "Is there any discussion on this Bill? The Gentleman from Will, Representative Wennlund."

Wennlund: "Thank you, Mr. Speaker. Will the Sponsor yield?"

Speaker Turner: "The Sponsor indicates he will."

Wennlund: "Is there a phase-in time to allow municipalities to

Novak: "Pardon me?"

Wennlund: "Where...Does the fine money go to the circuit clerk...or?"

Novak: "The fine money goes strictly to the municipalities."

Wennlund: "To the municipalities."

Novak: "The fine money goes strictly to the municipalities, Representative Wennlund."

Novak: "Well, I think it's an excellent Bill. The only recommendation I would have is just to give municipalities in Illinois an...an opportunity to phase it in, and to change all their signs, and to remake all their signs."

Novak: "That...that is a good point, well taken. Should this

Bill become law, I'm certain that we will allow the local

authorities the proper time to phase this in."

Wennlund: "Thank you very much."

Speaker Turner: "Representative Novak, to close."

Novak: "Yes, yes, Mr. Speaker, Ladies and Gentlemen of the House.

I certainly ask for your support to pass this worthwhile legislation."

So they are noticed prior to the cutting, and they're liened within 30 days after."

Lang: "And is that the only change?"

Balthis: "Yes."

Lang: "When the lien is sent. Thank you."

Speaker Turner: "The Gentleman from Washington, Representative Deering."

Deering: "Thank you, Mr. Speaker. Will the Sponsor yield?"

Speaker Turner: "Yes."

Deering: "Representative Balthis, do we not have a similar Bill

Balthis: "We have a similar Bill on the books. This changes when the lien would be sent out."

Deering: "Instead of before, it will be after, is the only change we're making?"

Balthis: "Yes."

Deering: "Okay. Thank you."

Speaker Turner: "The Gentleman from Effingham, Representative Hartke."

Hartke: "Thank you very much, Mr. Speaker. Representative, I read this Bill before it was amended, and I tried to listen to Representative Lang, but I was unclear on exactly what that Amendment does. What is the practice now, and what are you trying to do?"

Balthis: "The practice now is that the property can be liened without the notice, and we simply feel that the property owner should be noticed (sic - given notice) prior to the cutting of the weeds, so that when the lien comes, they've already been noticed that the lien will be there if the Bill is not paid."

Hartke: "Right now, the community decides that this property owner has not cut his weeds or his grass. What you're saying to me is that the city goes in, cuts the weeds and then sends the homeowner the bill, correct?"

Balthis: "Yes."

Hartke: "If they don't pay that bill, in what period of time,
then you put a lien on the property?"

Balthis: "They notify the property owner prior to cutting the weeds...that the..."

Hartke: "How much notice do they have to have?"

Balthis: "I think in the Bill, it's 60 days prior."

Hartke: "Sixty days prior to the city going and cutting the

Balthis: "Yes."

Hartke: "Well, I think that's kind of ridiculous. You know, being from an agriculture (sic - agricultural) community, weeds will grow two, three, four feet, and if you require the city a 60-day notice before they can go on the property to cut those weeds, the place would be a jungle. I simply...object to this piece of legislation and would urge my colleagues to vote against it."

Balthis: "Mr. Speaker, the 60-day notice is in the current law.

That is not an addition."

Speaker Turner: "The Gentleman from Clinton, Representative Granberg."

Granberg: "Representative Balthis, would the Gentleman yield?"

Speaker Turner: "Yes."

Granberg: "Representative Balthis, let's just make this clear:

What is the current law, what is the Bill, and then what is
the Amendment? It's my understanding the Bill was 30 days,
and your Amendment deletes that provision, so notice is
given after."

Balthis: "The...the notice to the property owner that they're going to cut the weeds and bill them is still...is still the...current law, and it will remain the law if this is passed. The...the notice of lien has to come within 30 days after the service. Currently, that lien could come at any time. Now it has to come within 30 days after incurring the cost. So it is a...it is a benefit to the property owner, and not to the municipality."

But it is that their 17th state championship that they have

(Where are you, Dan?) here...will become a student at West Point; to Indiana University, which I think has a basketball team, if I'm not it's...it's mistaken. I know hard to take. but occasionally we... Remember this, we send our people out all over the country so they can represent Illinois and come back and protect our interests. - Frias: "I'd like to be on record as voting... having voted 'aye' on House Bill 230, please, for the record. Thank you."
- Speaker Turner: "The transcript will so reflect. House Bill 290.

 Representative Steczo. We're on page 4 of the Calendar.

 House Bills, Third Reading. I'm sorry, I skipped over a
 Bill, Representative... House Bill 232, Representative

 Balthis. We'll get back to you, Representative Steczo, on
 290, we're... Currently we're hearing House Bill 232.

Representative Balthis."

Balthis: "Thank you, Mr. Speaker, Ladies and Gentlemen of the House. House Bill 232 clarifies..."

Speaker Turner: "Excuse me...Mr. Clerk, read the Bill."

Clerk Rossi: "House Bill 232, a Bill for an Act to amend the Illinois Municipal Code. Third Reading of the Bill."

Speaker Turner: "Mr. Balthis."

Balthis: "Thank you, Mr. Speaker. House Bill 232 amends the annexation process to clarify who can sign a petition, and also what property would be annexed in the process and I would ask for its favorable adoption."

Speaker Turner: "The Gentleman has moved for passage of House Bill 232. Is there any discussion? The Gentleman from Clinton, Representative Granberg."

Granberg: "Would the Representative yield, please?"

Speaker Turner: "He indicates he will."

Granberg: "Representative Balthis, this only applies to persons owning land under a highway?"

Balthis: "Yes."

Granberg: "Is that right?"

Balthis: "Yes, and under the old system of laying out highways and...and subdivisions, they owned property to the middle of the road, and so you had to...you had to get that person to sign the petition, even though they were not being annexed or their property that they could utilize was being annexed. So this just simply claries that those people would not be apart of the annexation process."

Granberg: "Okay. Representative, would that apply... Are you talking about mineral rights, not surface property, since that would have already been taken."

Balthis: "No, we're simply talkin' about annexation of property so that those people are not involved in the process."

Granberg: "Okay, and this would also apply that... You change the provision that would be a majority of the electors would be in favor of the annexation?"

Balthis: "Yes."

Granberg: "And the electorate is defined as 'anyone registered to vote'."

Balthis: "Yes."

Granberg: "Okay. Thank you."

Speaker Turner: "Representative Balthis, to close."

Balthis: "Thank you, Mr. Speaker, Ladies and Gentlemen of the House. I would ask for your favorable vote on House Bill 232. Thank you."

Speaker Turner: "The question is, 'Shall House 232 pass?' All those in favor vote 'aye'; those opposed vote 'no'. Voting is open. Have all voted who wish? Have all voted who wish? The Clerk shall take the record. On this question, there are 113 voting 'yes'; 0 'noes', 0 'presents'. This Bill, having received the required Constitutional Majority, is hereby declared passed. House Bill 290, Representative Steczo. Read the Bill, Mr. Clerk."

Clerk Rossi: "House Bill 290, a Bill for an Act to amend the Public Funds Investment Act. Third Reading of the Bill."

Speaker Turner: "The Gentleman from Cook, Representative Steczo."

Steczo: "Thank you, Mr. Speaker, Members of the House. House
Bill 290 is a Bill that addresses the way that
municipalities can currently invest their...their funds and
money. We in the Legislature have provided in current
statute, five different ways that municipalities can invest
their funds, and a number of years ago we allowed police
and pension... police and fire pensions to invest their
funds in...in the debt notes of other municipalities and
local governments. House Bill 290, is the... is a...a Bill

which allows municipalities to do the same: to be able to invest in the public funds and interest-bearing bonds, to invest its public funds or interest-bearing bonds, bonds of any county, township, city, village, incorporated town, et cetera. The purpose of this is to give the municipalities another attractive investment opportunity. ... This Bill was around in the Legislature last year, it was...it was held because there was a problem, perhaps potentially, with safeguarding. This Bill in its current form addresses those safequards by providing that there has to be... there is (sic - are) only certain kinds of bonds, and there has to be one οf the highest classifications that bond houses give. So these are only the good investments that can be provided for with these dollars, and, Mr. Speaker, I would answer any questions with this Bill, ...or would ask for a favorable vote."

Speaker Turner: "The Gentleman from Vermilion, Representative Black."

Black: "Yeah, thank you very much, Mr. Speaker. Will the Gentleman yield?"

Speaker Turner: "He indicates he will."

Black: "Representative, I certainly appreciate the fact that there are some safeguards in this legislation that we didn't see last year, but I think a point needs to be raised. Are there any limits? Generally speaking, if you use a bank as your depositor with public funds, you are limited to the amount of...dollars you can put into that bank as to their capitalization. Is there anything in this legislation, or is it in your intent that these investments be limited to any percentage of the total dollars to be invested, or does it say if you want to put 100% in a county highway project bond, you can do so?"

Steczo: "Representative Black, I think if you would look, if you would look at the language in the Bill as it relates to other investments that can be made by those municipal governments, ...only in one instance does it provide for any kind of limitation of that type. I think we would like to limit that to the...to the...to the...to the wise authority of the investing...the investing local government to be able to determine what is best for them. It pretty much follows...follows the language of the rest of the Act."

Steczo: "Correct. That is correct."

Black: "Is there anything in the Bill that would indicate that this financial instrument ah...be negotiable, in other words, traded, have a market or would you allow an entity to enter into a private agreement? 'I will invest 'X" number of dollars in the township building bonds.' In other words, what, I guess...what I'm getting at: Is there a market? Could...could the entity investing then sell that bond on the market, or are we creating a quasi-private investment pool here?"

Steczo: "Mr. Black, I didn't hear the last part of your question, but I think that the whole purpose of this Bill is to do what we did for police and fire pensions a number of years ago, and allow them one other option. As you're aware, many of the... much of the interest, or a lot of the interest of levels have decreased over the last year, so sometimes what...what was considered a good investment five, or six or seven years ago, may not be now. This is an opportunity for municipalities and...and local

governments, actually, to be able to look and be able to maximize the money that they...that they invest in, so there is less reliance on property taxes and things like that to be able to fund projects."

Black: "All right, thank you very much."

Speaker Turner: "The Gentleman from McHenry, Representative Skinner."

Skinner: "Mr. Speaker, would the Gentleman yield for a couple questions?"

Speaker Turner: "He indicates he will."

Skinner: "What are the four highest classifications? The bond ratings? What are they?"

Steczo: "Depending on the rating service, Representative Skinner, it could be AAA, Aa, A, A-, depending on what the...on what the rating services provide as...as their classifications, but that is...that is there to prevent the investment into high risk bonds and notes, like the Cs and the Ds and the others."

Skinner: "All of the other instruments that are now allowed for investments seem to be short-term... or readily marketable...vehicles. This does not sound like something one could sell quickly. Is that correct?"

Steczo: "I'm not sure I understand your question."

Skinner: "Well, a money market fund you can get your money out the next day; a short-term obligation of a corporation would be 180 days, it says in paragraph four. ...Savings accounts you can generally take out the same day, and U.S. Bonds and notes and agencies, can be sold on the secondary market within a day. I see a vast difference...in liquidity between those which are... the investments which are currently allowed and the investment that you are suggesting in this Bill. Why do you want long-term

obligations?"

- Steczo: "Representative Skinner, to the fact that all these are long-term obligations, I'm not certain. ...I'm sure that in these...in these different obligations there are...there are probably short-term obligations in there, as well. The fact is that the local governments, including the Municipal League and others, ...had this as their...their idea and their thought to provide them for a more diversified opportunity to invest and maximize on those investments, which helps...which helps their bottom line and their necessity to go...their property taxes. So, I think that in terms of the...the ability for them to...to look at investments, they would take...they would take the liquidity under consideration."
- Skinner: "Well, I served as a county treasurer in the beginning of my political career, and I can't imagine why anybody would wanna invest in a low rate...in a low rate of return and long-term instrument like this. What is the reason for this Bill?"
- Steczo: "To...to provide additional options, Representative
 Skinner, for those municipal governments, or those local
 governments to consider."
- Skinner: "How are you gonna..."
- Steczo: "There may be some that are attractive than some of the investments that are out there now."
- Skinner: "How are you going to prohibit conflict of interest between related governmental entities?"
- Steczo: "Representative Skinner, I think in terms of the kind of investments that one makes, ...you would...you would hope that the investments that they do make are in the best interests of the entity that...that they serve. There is no specific conflict of interest language in this Bill, but

- I think that...that we all know that...that we would hope that would not happen."
- Skinner: "But what happens if the same people who control the park district control the village, the same faction, and they start self-dealing?"
- Steczo: "Then you call the state's attorney."
- Skinner: "Well, it won't be illegal under this Bill. It will just be bad judgment. Thank you very much."
- Speaker Turner: "Seeing no further discussion, Representative Steczo, to close."
- Steczo: "Thank you, Mr. Speaker. I'm not so sure this Bill should have been engendered the debate that it did, because the...the debate in committee and the debate last year, actually, in the Legislature, actually was quite clear that we should allow local governments the...the opportunity to be able to diversify their portfolios. The one question that did arise last year was that they...there was some more safeguard that was needed by making certain that those investments were top quality investments. That seemed to be agreeable to everybody, that was the safeguard that that was necessary, because we do need to provide those municipalities the opportunity to be able to invest... to invest more wisely, and to maximize their benefits. House Bill 290 is a good idea, and I would ask for everybody's favorable support in the passage of House Bill 290."
- Speaker Turner: "The question is, 'Shall House Bill 290 pass?'

 All those in favor vote 'aye'; those opposed vote 'no'.

 The voting is open. Have all voted who wish? Have all voted who wish? The Clerk shall take the record. On this question, House Bill 290, there are 99 'ayes', 6 'noes', and 3 'presents'. The Bill, having received the required Constitutional Majority, is hereby declared passed. House

Bill 377, Representative Currie. Read the Bill, Mr. Clerk."

Clerk Rossi: "House Bill 377, a Bill for an Act to amend the Liquor Control Act. Third Reading of the Bill."

Speaker Turner: "Representative Currie."

Currie: "Thank you, Mr. Speaker and Members of the House. is a Bill that arises out of a circuit court ruling in the City of Chicago, having to do with efforts to vote precincts dry. What happened in that situation, is that there were community members who tried to put that question a referendum at the next general election, but, at apparently, the opponents of the proposal, also filed a set of petitions with the clerk. That set of petitions did not meet statutory requirements, so the questions was not on the ballot, and the court ruled that the second set of petitions, (that filed by the proponents of the referendum) could not be considered; since the first set did not meet eligibility requirements. This Bill, which, again, only applies to the City of Chicago, clarifies that if a first set of petitions filed by whomever, does not meet the threshold's statutory requirement, that the clerk may look at a second set of petitions. The effort here is just to make sure that people in the local community, at the local level, have the opportunity we thought we gave them, to petition to put that question of voting a precinct dry on the ballot when they have adequate numbers of signatures to I'd be happy to answer your questions and would appreciate your support for what we thought was already the law."

Speaker Turner: "The Gentleman from Will, Representative Wennlund."

Wennlund: "Thank you, Mr. Speaker. Will the Sponsor yield?"

Speaker Turner: "She indicates she will."

- Wennlund: "This...this applies to any city with a population of over 200,000?"
- Currie: "This is the... It's my understanding that it's the City of Chicago, and this...this is the... The Bill amends the statute that governs how local communities can address the question of voting precincts wet or dry in the City of Chicago."
- Wennlund: "This represents a change? I... Did the prior law apply to cities over a million, or over 3 million?"
- Currie: "The population is the same in the Bill as is current law. There's no change. My Bill doesn't change that."
- Wennlund: "Would it apply to any cities in Illinois, other than the City of Chicago?"
- Currie: "I don't believe so, Representative, but remember, I'm not amending the population requirement; I'm not amending the population threshold. I'm only dealing with current law in respect to a clarification of the procedure."
- Wennlund: "And...and how does this clarify the existing procedure?"
- Currie: "It clarifies it in the way that I thought we all thought that it operated. That is, there is a procedure for gathering petitions from people, registered voters living within a precinct, to put a question on the ballot, and what happened in this particular instance in the County of Cook was that the opponents of the referendum question filed faulty petitions with the clerk before the community petitions were filed. The clerk threw out the first set of petitions and said current law did not permit consideration of the set of petitions that were filed by the proponents of the referendum in the community. So, this change would only clarify that if somebody, in effect, tries to beat you

to the courthouse by filing petitions that aren't going to meet requirements, that you still have a chance to file your own and have those petitions considered on the question whether they do meet the threshold requirements."

- Wennlund: "Mr. Speaker, we have some order, please? This is

 Third Reading and final action, and the noise level here,

 it's very difficult to hear Representative Currie."
- Speaker Turner: "The Gentleman is... request is in order. Could we please have some order in the chamber?"
- Wennlund: "Thank you very much. Thank you, Mr. Speaker."

 Representative Currie, I'm sorry the noise level is so terrible, it was difficult to hear over the noise level and hear your answers. So, as I understand it, this Bill is to prevent someone from bringing in faulty petitions to keep a precinct with liquor in it prior to the time the petitions can be correctly filed to prohibit the sale of liquor. Is that correct?"
- Currie: "To...to offer that question at referendum, yes."
 - Wennlund: "Okay. Thank you very much. Thank you, Mr. Speaker."

 Speaker Turner: "The Gentleman from Coles, Representative

 Weaver."
- Weaver: "Thank you very much, Mr. Speaker. Apparently the Bill is out here somewhere, but most of us, on this side of the aisle, do not have a copy of the Bill. Has this Bill been printed and distributed?"
- Speaker Turner: "Mr. Clerk. Representative Weaver, we don't distribute Bills, just Amendments. It has been printed.

 The Gentleman from Vermilion, Representative Black."
- Black: "Thank you very much, Mr. Speaker. Will the Sponsor yield?"
- Speaker Turner: "She indicates she will."
- Black: "Representative, just to clear up a point or two that some

people have come up to me and I...I think you've cleared this up in committee, but let's go through it again. There's nothing in this Bill that could be used to vote Wrigley Field, Sox Park, Chicago Stadium et cetera, dry - Soldier Field - after the fact. Is that your understanding?"

Currie: "You are correct. This has nothing to do with voting precincts dry at Wrigley Field, or at Sox Park."

Black: "So, those facilities are already exempt under some kind
 of current law. Isn't that the fact?"

Currie: "That's right."

Black: "Okay."

Currie: "That's right. This Bill doesn't do anything to change what's covered; it only clarifies that the... how the procedures operate within those territories in the City of Chicago in which that ballot question can be addressed."

Currie: "That is correct."

Black: "And as I recall the discussion in committee, it only has to do with the filing of petitions."

Currie: "In the effort to vote on questions of precinct wetness or dryness."

Black: "In other words, as I recall, this simply stops some form of chicanery that might be occurring in the City of Chicago, as unusual as I find that."

Currie: "Absolutely, Representative."

Black: "Thank you."

Speaker Turner: "No further discussion. Representative Currie, to close."

Currie: "Thank you, Mr. Speaker and Members of the House. This

Bill only clarifies a procedure we thought was already

clarified, but by virtue of a court decision, we would, without this Bill, be denying communities the opportunity to vote on those kinds of questions, opportunities that we thought we already had offered them in the statute. The Bill has the support of the Department of Alcoholism and Substance Abuse, and it really is a technical cleaning-up kind of Bill, that merely guarantees rights that we thought we'd already given to residents of these precincts. So, I would appreciate your 'yes' votes."

Speaker Turner: "The question is, 'Shall House Bill 377 pass?' All in those in favor vote 'aye'; those opposed vote 'no'. The voting is open. Have all voted who wish? Have all voted who wish? The Clerk shall take the record. 'aye'. Representative Prussing, Vote Representative Prussing 'aye', Mr. Clerk. This Bill, having received 103 'yeses',... 103 'yeses', 4 'noes', 3 'present'. This Bill, having received the required Constitutional Majority, hereby declared passed. On the Order of Third Reading. House Bill 430, Representative Balanoff. Clerk, read the Bill."

Clerk Rossi: "House Bill 430, a Bill for an Act to amend the Illinois Municipal Code. Third Reading of the Bill."

Speaker Turner: "Representative Balanoff."

Balanoff: "Yes,... Mr. Speaker, Ladies and Gentlemen of the House. House Bill 430 does nothing more than change the term 'alderman' to 'alderperson', in making the term gender neutral. It's because of... I was at an event, and I asked a person who happens to be a member of the City Council in Chicago how to introduce her as an 'alderman' or alderwoman', and she says, unfortunately, the term is 'alderman', and I said, Why don't you change that in the City Council, and she says because it is state law."

Speaker Turner: "The Gentleman from Vermilion, Representative Black."

Black: "Yes, thank you very much, Mr. Speaker. Could we have a little order in the House on Third Reading? I guess that's about as little order as I'm going to get."

Speaker Turner: "Please give the Gentleman your attention."

Black: "Ladies and Gentleman of the House, this Bill is certainly politically correct. There's no doubt about that, but do you really want to put in state statute that an 'alderman' must now be called an 'alderperson'? Now, if any of you, as I do, come from a city that uses the aldermanic form of government, the city can change whatever name they (sic it) want (sic - wants), 'alderperson', 'chair person', 'representative person', 'senator person'; I don't care. But if you start this in state statute, where does it end? Where does it end? Ι mean, should we refer to Speaker' or 'Neuter Speaker'? Should we use 'chairman' or 'chairperson'? I mean, I'm not, seriously, Mr. Speaker, I am not trying to denigrate what the person is doing. I simply question whether it's necessary - when we already have seven volumes of state statutes - whether you wanna get into bringing every political (sic - politically) correct term to Springfield, and embody that term in state statute. If the City of Chicago, or any other Chicago (sic - city) wants to call them 'alderperson', 'alderthing', or, as I'm often called, 'hey you' (or worse), let it But I really implore you, let's not continually clutter the statutes with every political (sic - politically) correct term that comes with the 'Ying and the Yang' as society evolves over the years. I intend to vote 'no' on this, not because I think it's a bad idea; I just don't think it needs to be embodied in state statute. Let's, for once in

a rare moon, use a little common sense. Let those people be referred to or called by whatever they want, by whatever body they represent. I implore you not to clutter the state's statutes. I urge a 'no' vote."

Speaker Turner: "The Lady from DuPage, Rep. ... Cowlishaw. I was just trying to think whether's it's... Go ahead, Representative."

Cowlishaw: "Thank you very much, Mr. Chairman."

Speaker Turner: "Madam or Mr. or ..."

Cowlishaw: "I recognize that the English language, unlike certain other romance languages, is one that does not lend itself well to being gender neutral, and I realize we have faced for years the problems of calling a woman the 'chairman' or the 'alderman' or the 'congressman', for example. But, I have a suggestion that I think is even better than this, and that suggestion came to me from a woman named Lynn Martin, who is a former member of Congress; who was about to deliver a speech at a luncheon, and the person who was to do the introduction, asked her, during the lunch, 'When I introduce you, do I call you 'Congressman' or 'Congresswoman'?', and she said, 'Just call me "Your Highness"; that's not sexist."

Speaker Turner: "Representative Balanoff, to close."

Balanoff: "Yes. Just for everybody's clarification, the reason that this is introduced is because, indeed, it cannot be done by city council action. It is in state statute already, and the official ballot designation is 'alderman'. It was, as I said, because it was particularly disturbing to an alderman in the City of Chicago, who happens to be a woman."

Speaker Turner: "The question is, 'Shall House Bill 430 pass?'

All those in favor vote 'aye'; those opposed vote 'no'.

Black: "An inquiry of the Chair. Did the Gentleman have enough votes for Postponed Consideration? Wasn't he one short?"

Speaker Turner: "Forty-seven is the required number. He received over that."

Black: "Oh, I...I thought I saw somebody raising their (sic his/her) hand to change their (sic - his/her) vote."

Speaker Turner: "No."

Black: "All right."

Speaker Turner: "Page 4 of the Calendar, Third Reading. House Bill 186. Representative Morrow. Representative Morrow? House Bill 186. Clerk, read the Bill."

Clerk Rossi: "House Bill 186, a Bill for an Act to amend the Real Estate License Act. Third Reading of the Bill."

Speaker Turner: "Mr. Morrow."

Morrow: "Thank you, Mr. Speaker, Ladies and Gentlemen of the House. What House Bill 186 is doing, is to include mayors or presidents of a city, a city councilmens (sic -councilman), or trustees of a village, or town, or city councilmen; we're trying to exempt them from the continuing ad clause for renewal of a license brokership for real estate. What...what we're trying to do here, or with House Bill 186, three years ago when we passed the rewrite of the Licensing Act, at that time, we included to...people who are on the...state government. They were...exempted from getting their license renewed or going through the CED program, and all we're trying to do is bring locally

elected officials on par with what we've already done three years ago. I'd be glad to answer any questions on House Bill 186."

Speaker Turner: "The question is, 'Shall House 186 pass?' All those in favor vote 'aye'; those opposed vote 'no'. The voting is open. Have all voted who wish? Have all voted who wish? Have all voted who wish? The Clerk shall take the record. On this question, there are 93 'yeses', 21 'noes', 1 'present'. This Bill, having received the required Constitutional Majority, is hereby declared passed. Representative Jones, for what reason do you rise?"

Jones: "Mr. Speaker, I pushed the wrong button. I meant to push
'yes' on House Bill 186."
