Skinner: It's a Bill that raises the speed limit of trucks on interstate highways throughout Illinois from 55 to 65 miles an hour. During the last two weekends, I've spent probably 800 to a thousand miles on interstate highways in Illinois; and I'm here to report they're already driving 65 miles an (sic-per) hour. What this Amendment does is suggest that even if you think every truck in the state ought to be allowed to drive 65 miles an hour on every interstate highway, that you're not quite sure that those trucks that are carrying two trailers behind it (sic-them), will be safe at 65 miles an hour driving on interstate highways State of Illinois. This throughout the Amendment exempts...that is, this Amendment takes out the authority double bottoms...to drive 65 miles an hour. They would of still be restricted to 55 miles an hour. Now, if you are in favor of faster...trucks, you'd definitely want to vote against this Amendment; but if you're a little worried that your compact...car might get in an accident while passing one of these trucks when there's a big wind, you oughta vote in favor of the Amendment. I ask for your support."

- Speaker Dunn: "The Gentleman from Jefferson, Representative Hicks, on the Amendment."
- Hicks: "Thank you, Mr. Speaker, Ladies and Gentlemen of the House. I would stand in opposition to the Gentleman's Amendment. The reality of what we are trying to do with this Bill is simply to look for a uniform speed of all vehicles on the interstate highways... In the report that was presented at committee, a study was done this past year by the Safety Foundation of AAA, which said...said that the...uniformity of speed was in the best interests of...of

safety. By having...by again exempting somebody else out of this, we are back to the same position we currently are, which is, not allowing all the vehicles to continue at the same speed, so for that reason I would stand in opposition to the Gentleman's Amendment and request a Roll Call Vote, Mr. Speaker."

Speaker Dunn: "Representative Skinner, do you wish to close? Representative Skinner."

- Skinner: "Well, the Sponsor of this Bill may be correct. It may be safer to have every truck in the State of Illinois on interstate highway going 65 miles an hour. We just don't know. The study in question did not ask...answer the question of whether double bottoms going at a...at 65 miles an hour was safer than having them going at 55 miles an hour. What it suggested was that a uniform speed limit was safer than not having a uniform speed limit. I should to you that when we get to the Bill, to the final suggest Third Reading on this, there is countervailing evidence from the Illinois Department of Transportation that you'll wannna take into consideration. But here what we are talking about is one, one Amendment only, and that is, 'Shall double bottomed trailers that are on interstate highways be allowed to increase their speed legally from 55 to 65 miles an hour?' I would suggest that right now, they are going almost 65 miles an hour when the speed limit is 55 miles an hour. It's definitely a question of safety. Both the Sponsor and I agree upon that. I leave it to your judgment as to, as which shape the Bill should reach Third Reading. Thank you."
