refuses to post a Bill; it provides an option for an alternate way of posting, but whichever way the posting happens, it's still the six-and-a-half day rule that would apply, and you're too late. But it was a good try."

Black: "But...wait...what rule...what rule..."

Speaker Currie: "See, in effect, if you look at House Rule 20, 20(b), 'the time of the posting may not be later than 12:00 noon on the day following the regularly scheduled meeting day for the committee, but not less than six-and-a-half days prior to the meeting'. And, House Rule 27, the one that you were...asking about, really just provides for an alternate way of posting before the six-and-a-half-day notice provision must be met."

Black: "Well, ...in all due respect, Madam Speaker, it was...it was...it was understood that all Bills would be posted. Now, Rule 20, I believe, can be suspended by...by what vote?"

Speaker Currie: "Seventy-one votes, Sir."

Black: "Why am I not surprised?"

Speaker Currie: "And that would be in Rule 20(k)."

Black: "Yes, I see that. Well, I...I...I see no reason to keep us here on what you have, obviously, already decided is a moot question, but I just simply say to the Chair, and I simply say to those Members who wanna go wherever it is you wanna go, rather than practice inherent fairness, this'll come back to haunt every Member of this chamber. When you can't get a Bill posted and heard before committee, under the machinations (no matter what you call it - a manipulation of the rules) and ignoring basic rights of both parties, then woe be to you, Madam Speaker. This will come home to roost; I tell you that."

Speaker Currie: "Thank you, Representative. The Chair would just

like to point out that this Bill was posted three or four times during committee hearings. The Sponsor failed to appear to present...his...legislation. No further business to come before the House... No, wait a minute. We think there's no further business to come before the House... Just a moment. No further business to come before the chamber, Representative Giorgi moves the house stand adjourned until the hour of 2:00 tomorrow, Wednesday, March 31. On that Motion, all in favor signify by saying 'aye'; opposed, 'no'. The 'ayes' have it. The Motion is adopted, and this House now stands adjourned."
