And I cannot be responsible, Representative Ryder, because you didn't to get to have all of your Bills heard. There were many Bills that I also did not have heard in committee, and I am not asking for a discharge Motion on those Bills. I'm merely asking for one on this one because it did get to be heard but it was a great deal of confusion in reference to the content based upon the Amendment being filed."

Speaker Steczo: "Representative Cowlishaw."

Cowlishaw: "Thank you very much, Mr. Speaker. Ladies and to me that Chairman Gentlemen of the House, it seems Brunsvold runs one of the fairest committees we have in the House, and I really believe that there is Illinois practically no one who can come away from Representative Brunsvold's committee and claim that they did not have a fair hearing and an adequate opportunity to present The opposition of the city colleges of Chicago to this Bill was not removed by the Amendment. The had a full hearing. It failed. I stand in strong opposition to this discharge Motion and would ask anyone who cares about the city colleges of Chicago to join me in voting 'no' on this Motion."

Davis: "I want to say to you that I talked to Ben Israel; talked to the chancellors of the city colleges. They have removed their opposition of this Bill, and the only concern they have, of course, is an effective date and some other things we're going to work out on...on the Second Reading of the Bill. This Bill asks that those people who adults, they have four-year college degrees and they teach GED programs, that they take two or one class in the ability to teach adults. How do you teach people who have dropped out of school ten years ago and who are finally going back? Do you need the ability to teach them or do you merely need subject matter? We're not asking this for those who teach college classes, we're asking this for those who teach the GED program. There is a vast dropout rate of that GED program. The success rate is abysmal. need people who can relate to those adults who have low self-esteem, who need a great deal more motivation, and you need to present basic material to them in a very adult fashion, and you need to learn how to do that. The success rate of the GED program is very low, and the reason it's low is not based upon the student's desire to finish, based upon our ability as teachers and adults to impart the information to them in a way in which they can retain it and pass the test. I urge you to vote 'aye' on legislation. It doesn't mean you have to vote 'yes' on the Bill. We can talk about the merits of the Bill later."
