Mr. Brown has an extensive background in criminology and law enforcement. He holds a degree in criminology from Fresno State University, degree in sociology from San Jose State University in California. He began as a patrolman with the San Jose Police Department,

and has held a variety of ranks in law enforcement in different places in the country. He has come to Illinois today to deliver a very special message. We're very pleased to have him, and would you all please give him a very appropriate welcome. Mr. Brown."

Lee Brown: "Thank you, Speaker Madigan and distinguished Members of the General Assembly. It's my great privilege to be with you today to talk about a subject that is a paramount concern, not only here in your great state, but throughout the nation; that's drugs and violence in our communities. know, last February, the President released his As vou national drug control strategy to deal with the drug That's what I want to discuss with you briefly problem. this afternoon. The first point I would like to make is this; despite its focus on federal agencies and federal programs our national drug program strategy is a national strategy, not just a federal one. Ιt is a national strategy because drugs and crime are having an impact on virtually every town and every city, and every county and every state in America. It's not a Republican problem or a Democratic problem. It's not a problem just for our cities, it's not a black or white problem. It's not just my problem as the Director of the Office of National Drug Control Policy. Drugs and violence are everyone's problem, they are America's problem. And that is why the Federal Government alone can't make progress against drugs and violence without the active engagement of concern and committed citizens and public officials at the state and local levels. I'm talking not only about State Legislators, such as yourself, but also business people, educators, local officials, clergy, and above all, the ordinary men and women who live in ordinary neighborhoods.

Because drugs and violence affect us all, our strategy is also a community-based strategy. Indeed, we chose to title the 1994 strategy, 'Reclaiming Our Communities from Drugs and Violence'. If I were to single out one overarching principle of our strategy, it would be this, that we believe, the President believes, I believe, that every citizen in every community from the most impoverished inner city neighborhoods to the wealthiest suburb has a right to be safe and secure in their home and in their neighborhood. And to that end, we want to empower towns and cities and local neighborhoods across this nation. We want to give them the tools to seize control of their own destinies, to take back their streets, their parks, and their schools from the gangs and the drugs and the guns. Allow me to sketch for you the dimensions of the drug problem in Nearly 80 million Americans have tried illegal America. drugs, and over 11 million are current drug users; chronic, hard-core, addicted drug use continues unabated, especially in our urban areas. Two weeks ago the Department of Health and Human Services released new data showing that drug related admissions to our emergency hospital rooms were up by 9% over the first half of 1992. Most of the increase was caused by a significant rise in heroin related emergencies. which are up by 44%, and recently we also received the bad news from the 'University of Michigan Monitoring the Future survey', that after years of overall declines and casual drug use more of our young people have either used drugs or think it might be okay to use them. But even these numbers don't tell the real story about the drug abuse, and the violent crime it spawns and what it's doing to this They don't tell you about the fear, the fear country. of citizens as they walk the streets in their own

neighborhoods. The fear of children as they walk to school or even when they're in school. As the President said, 'This fear is crippling our society, limiting personal freedom, and fraying the ties that bind us'. As you may know the President has asked the Congress to provide \$13.2 billion for drug control and prevention programs. the largest budget ever, increase of \$1 billion over the an current year. But even more important than the amount of money is how these funds will be spent. Our new strategy departs from previous strategies in a number of important respects, and it challenges all Americans to view the drug problem in a whole new way. The strategy rejects the false dichotomy between programs that reduce the demand for drugs and those that reduce the supply. We need both, working together in an integrated fashion, the strategy recognizes, I believe most law enforcement professionals recognize, as that demand reduction programs cannot succeed if drugs are readily and cheaply available. Likewise, drug law enforcement cannot succeed unless this nation's appetite for illegal drugs is curbed. And, unlike previous strategies, which concentrated on reducing casual drug use, the new strategy also focuses on hard-core drug use, the toughest aspect of the entire drug problem. And, although not as numerous as the casual drug users, the chronic drug user causes a disproportionate share of the violent crime and the human misery that afflict our communities. especially our disadvantaged communities. It has been estimated that only 20% of the cocaine users in this country are responsible for using up to 80% of all the cocaine sold on the streets of our cities. We know that effective drug treatment is key to breaking the cycle of hard-core drug use, and that is why we're asking additional

funds in this area. Our strategy emphasizes treatment, not only because it is the compassionate thing to do, but also because it is a smart thing to do. Each dollar we spend on drug treatment is repaid seven-fold, in the form of reduced crime and lower public expenditures. I would add also that although it's not as widely recognized, drug abuse contributes greatly to the nation's rise in health care study estimated that drug cost. Α recent use is responsible for \$3.2 billion annually in medical costs. If you add the cost of alcohol abuse, the figures grow dramatically larger. Our strategy is requesting \$355 million in new targeting fund to treat an additional 74,000 hard-core addicted drug users; and in the crime Bill, soon to be conferenced in the Congress, is fundings sufficient to treat another 65,000 drug users through the criminal As the President put it recently, 'When justice system. you look at the percentage of people who commit crimes, who have a drug or alcohol abuse problem it does not make any sense to put them back on the streets without adequate drug treatment'. Another good idea in the crime Bill is support for drug courts, a very promising initiative pioneered by Attorney General Janet Reno in Dade County, Florida when she was the State's Attorney. Drug courts have proven to be effective in several cities in helping nonviolent drug offenders obtain the treatment they need to get off drugs and put their lives back on track. In Illinois you've made a serious commitment to criminal justice drug treatment. Last fall I visited the Violence Interruption Program in Chicago, which is run jointly by Cook County Sheriffs Office, and the Illinois Treatment Alternative to Street Crime, and which tries to get young drug offenders off drugs, and keep them out of further trouble. And on the

subject of drug treatment, I should add that when the Presidents Health Security Act becomes law every American will gain access to treatment for substance abuse programs...problems through the new substance abuse benefit. And that's a very important aspect of legislation pending before our Congress, because not only will every American have the benefit of quality guaranteed health care that cannot be taken away from them, but also every American would have substance abuse treatment as part of the national health care system. Of course, I think we all could agree that the best anti-drug program is prevention. Stopping drug use before it starts, to that end, we would increase our efforts to instill in America's youth, a set of values that will inoculate them against the allure of drug trafficking, and the escape of drug addition. The strategy proposes a \$191 million increase in funding for safe and drug free schools programs, and it calls on all adults to let their children know in no uncertain terms that drugs are not only dangerous, they are also illegal. Some have criticized our strategy's high priority on prevention. Well, as someone who has been in law enforcement for over 30 years, I've learned that a little effort paid up front to prevention can hit off a lot of criminal activity down the line. Others say that our strategy's new emphasis on demand reduction means that law enforcement is now a lower priority. That is absolutely false. Overall the strategy calls for increase of assistance for state and local government by more than 300%. The President remains committed to making good his pledge to put a 100,000 additional police on the streets of American cities. As you know, we made a down payment with grants to 108 local law enforcement agencies under the

Police Hiring Supplement Plan. Over the next several months, grants will be awarded to another 100 additional You should also police departments. know that the President's pledge that if the Congress passes the Crime Bill without further delay, he will cut through the bureaucracy and the red tape to make sure that 20,000 of the new police officers are hired, trained, and ready to go to work within a year. These new officers will make a real difference in communities throughout your great state. The strategy proposes a dramatic increase in community policing initiatives to help neighborhood residents take back their streets. This concept of the police entering into genuine partnerships with the citizens to prevent crimes before they occur, and arrest offenders when they do occur, is absolutely basic to our strategy. You know and I know that when it is done right community policing works. When we initiated it in Houston, Texas when I served as police chief there, we saw the crime rate go down; when we implemented it in New York City, when I was that city's police commissioner, the crime rate declined there as well. And community policing is making a real_difference here in Illinois. As part of the President's \$150 million hiring supplement, our administration awarded grants to Carbondale, Carol Stream, Chicago, Country Club Hills, East St. Louis, and Moline to put more police officers on the streets in this state for community policing. And with the \$9 billion program included as part of the crime Bill, we'11 be able to help communities implement community policing on a much larger scale. One area in which our strategy departs from previous drug strategies is advocacy of gun control and its recognition of the close link between drugs and violence. Too many guns get into the

The problem's even worse in the minority community. In fact, leading cause of death for young black males. We all should hang our heads in shame over the fact in this country, a child dies from qunshot wounds every two hours. The President is committed and I am committed to ending this senseless slaughter. We find ourselves in a unique position that for the first time in the history of this country, if not for the history of this world, our children are killing our children. In November, the President 'Brady Law', and already there are only two sianed the months since it has been implemented thousands of felons and fugitives have been stopped from purchasing handguns, and this very week the House of Representatives in Washington will begin to consider an issue that has been contentious here in Illinois, an assault weapons ban. Ι don't know the specifics of your own proposal, but the President's is as simple as it is straightforward. Specifically, it bans 19 of the deadliest assault weapons, but exempts more than 650 legitimate sporting and hunting weapons. We're not asking anyone to take the government's word on these, on what weapons will or won't be banned, 50 we're writing it right into the law. Interdiction and international programs will continue to play an important role in our drug strategy, because what happens in Peru and Colombia and Bolovia affects the availability of deadly

drugs on the streets of Chicago and in Rockford and Peoria. Under our strategy we will shift the emphasis of our international programs to strengthen the ability of source and transit countries to combat their own drug trafficking organizations, intensify our tact on international drug kingpins, and step up efforts to interdict drugs and eradicate drug crops at their source. Recently, I named the Commandant of the Coast Guard, Admiral Kime to be the Federal Government's first interdiction coordinator. Admiral Kime will help me to ensure that the several federal agencies responsible for interdiction of drugs at our border, work together smoothly and efficiently and avoid wasteful overlap and duplication. Finally, I'd like to touch briefly on one additional way in which our strategy departs from previous strategies. In the past, drug policy was seen as totally separate from other policy areas, both domestic and international. We think that's the wrong approach because the drug problem won't be solved by drug programs alone, no matter how effective they may I'd be. understand that in Illinois the Illinois Alcoholism and Drug Dependence Association has mounted an educational campaign to better inform policymakers and the public about the relationship between crime, drugs and violence and education and health care and other social problems. It's important that we all recognize these linkages. To make real progress over the long term we're going to have to confront not only the symptoms of crime and drugs, but also their underlying causes. We must address the problem of poverty in our country. We must address health care and make health care a right and not a privilege. We must address the lack of affordable housing. We must address poor education and poor schools and

weakened social institutions. We must address the problem of racism and discrimination in our country, and that is why we want to empower communities across America to resist and prevent drugs and crime. The President's empowerment and enterprised communities will target 104 of the zones most disadvantaged urban and rural areas of the country, those hit hardest by drugs and crime and violence. often Communities will be able to use their federal grants to expand drug treatment services and drug law enforcement, as well as community-based drug education and prevention programs. Before I conclude, I want to say a word about the legalization issue. As Ι said, I've been in law enforcement for over 30 years. During that time, I've served as an undercover narcotics officer; I've walked the beat, and I've ran some of the toughest cities in this country: Atlanta, Houston and New York City. In that capacity, I've seen what drugs do to men and women, what they do to families, what they do to communities. I've seen what drugs do to our disadvantaged communities. Т know that the struggle against violence and addiction is a very difficult one, costly, and often frustrating. But legalizing drugs will lead to more drug use, not less; more unemployment, not less; more violence, not less; higher health costs, not lower. We say in this administration that we should offer help to those who need help, those who are addicted to drugs and arrest those who sell drugs, but we should never, ever, ever surrender. I'm confident that with our new strategy, this nation will make progress against drugs and violence. But as I said earlier, the strategy can't do it all. The government can't do it all, and certainly I can't do it all. Each of us must take responsibility for our own actions. Parents must take

responsibility for their children, and teach them that using drugs is wrong, that violence is a dead end. Citizens must ban together to take back their neighborhoods, block by block, and each of us must make room in our lives to help a troubled person to get back on the right track. Let me again, Mr. Speaker, thank you for allowing me the opportunity to share this time with you and share with you this administration's approach to addressing what we consider to be one of the more serious, one of the number one domestic problems in this country: that is a problem of substance abuse, and how we believe that working together the Federal Government, State Government, local government, and the people of our great country that we can, we will make a difference, and make our future better for our and children. This Bill, Ladies and Gentlemen, this Amendment simply says that people in your district will not be able to solicit money at traffic intersections, the way many social service clubs have been doing for years and years and years, and it will have a fiscal impact. It appears to me that the municipality will have to enforce this Act, and that it does impose some standards of due process on the municipalities. I think they would regard this as an unfunded mandate. Ι speak against the Gentleman's Motion. I think the fiscal note is, in this fact, applicable."
- Speaker McPike: "House Bill 2601, Third Reading. There was no fiscal note request filed on the Bill, as amended. The Bill is on Third Reading. Representative Currie, House Bill 2691. Ms. Currie? Read the Bill, Mr. Clerk."
- Clerk Rossi: "House Bill 2691, a Bill for an Act amending the Environmental Protection Act. Second Reading of the Bill. Amendment #1 was adopted in committee. No Motions have been filed. Floor Amendment #2 is offered by Representative Wennlund."

Speaker McPike: "Representative, excuse me, Representative Persico, for what reason do you rise?"

Persico: "I was hoping that my Amendment would be called."

Speaker McPike: "Pardon me?"

Persico: "I'm on Amendment #3, I'm sorry."

Speaker McPike: "Representative Wennlund, on Amendment #2."
Wennlund: "Thank you, Mr. Speaker. Amendment #2 basically is a
very simple Amendment and provides that the General

- Speaker McPike: "All right, is there any discussion on the Amendment? Mr. Wennlund, did you move for the adoption of the Amendment? Is there any discussion? Representative Currie."
- Currie: "Thank you, Speaker. Would the Sponsor yield for a question?"

Speaker McPike: "Yes, he will."

- Currie: "Representative, since the Bill itself doesn't say anything about percentages, why did you feel it necessary to specify that no percentages specified in the Bill? I don't understand. I'd like to know what your rationale here is?"
- Wennlund: "The Department of Transportation was concerned that, that the original Bill would mandate certain fixed percentages of the crumb rubber, rubber tires."
- Currie: "But this is a demonstration program, and I don't believe that the Bill itself specifies a percentage. Can you show me where in the Bill there is a specification?"
- Wennlund: "It's my understanding the Department of Transportation felt that it was."
- Currie: "Could you tell me where in the Bill that percentage is specified?"
- Wennlund: "I can't answer the question, I..not without going through the entire Bill."
- Currie: "So, Representative, there's nothing in the Bill that specifies a percentage."

Wennlund: "It's my understanding that the Department of

- 120th Legislative Day April 26, 1994 Transportation, that was their concern, and that's the reason for the Amendment. Just to clarify that the fact that, indeed, there is no specified mandated percentages of used rubber."
- Speaker McPike: "Representative Hartke, for what reason do you rise?"
- Hartke: "Well, I would like just to make comment. I think that Amendment #2 clarifies that it's setting up just two demonstration projects, and it does not say anything about a percentage or whatever. So, I'm not sure that Amendment #2 is necessary at all, Representative Wennlund."

Speaker McPike: "Mr. Wennlund."

Hartke: "Right, so I would urge a 'no' vote on this Amendment, since Amendment #1 just sets up two field demonstrations for the use of crumb rubber on developing a roadway, and so forth. And, it doesn't address the question of percentage at all, because Amendment #1 deletes everything after the enacting clause. So, when you're referring to the percentage, it wouldn't, where would you put it? I think possibly your Amendment is out of order, or it is ill drafted...or something."

Speaker McPike: "Mr. Wennlund, to close."

- Wennlund: "Thank you, Mr. Speaker. Ladies and Gentlemen of the House, the sole purpose of the Amendment is just to make sure that, the concerns about mandated specified percentages of, of rubber tires and asphalt, just is not the policy of this state. I think that's necessary. I don't think it affects Amendment #1 at all, or the programs."
- Speaker McPike: "The question is, 'Shall Amendment #2 be adopted?' All in favor say 'aye'; opposed, 'no'. The 'noes' have it, and the Amendment is defeated. Further

Clerk Rossi: "Floor Amendment #3, offered by Representative Persico."

Speaker McPike: "Representative Persico."

- Persico: "Thank you, Mr. Speaker, Members of the General Assembly. Amendment #3 amends the School Code and Natural Resources Act. It requires the state board of education, and the Department of Energy and Natural Resources to conduct a joint study to determine the feasibility."
- Speaker McPike: "Excuse me. Representative Granberg, for what reason do you rise?"
- Granberg: "Thank you, Mr. Speaker. Point of Order. The Amendment amends a different Act than the underlying Bill, so I would ask the Chair to rule if the Amendment is germane or not. The Amendment."
- Speaker McPike: "Representative Persico, your Amendment is not germane. Further Amendments?"

Clerk Rossi: "Floor Amendment #4, offered by Representative..."

- Speaker McPike: "Just a minute, Mr. Clerk. Representative Persico."
- Persico: "Thank you, Mr. Speaker. Under House Rule 36 (d), the rule states that the Amendment is in order as long as it's related to the subject of the Bill, and since Representative Currie's Bill amends the Environmental Protection Act; my Bill deals with the environment in terms of recycling program, and I do think it is related to her particular Bill. And under 55 (c), and I'm joined by four other Members of this side, we want a Roll Call Vote on this, please."

Speaker McPike: "You want a Roll Call Vote on what?" Persico: "On Amendment #3, to overrule the Chair." Speaker McPike: "So, Representative Persico moves to overrule the

- Speaker McPike: "All right, the Gentleman has asked for a Verification of the Negative Votes. Mr. Representative Wennlund. Mr. Wennlund, it takes 60 votes to pass this Motion. It takes 60 votes to pass this Motion. So, if you verify off all of the negative votes, the Motion still fails. So, the Chair will rule that your request is dilatory. Mr. Wennlund."

There's no reason that the department, in conjunction with the Department of Energy and Natural Resources, could not find funding through that But, I see no reason to limit a demonstration source. project to the sources that are proposed in Amendment #4. This is an effort to kill the Bill. If anyone wants to vote against this very mild, very small demonstration project program on Third Reading, they are of course more than welcome to do so. But I think the effort in this Amendment is to try to gut this small program, this small project and I would strenuously oppose adoption of this Amendment."

Speaker McPike: "Representative Hartke."

Hartke: "Thank you very much, Mr. Speaker. I stand in opposition of this Amendment, too, in agreement with the previous speaker. But I also think that if we decided that any agency could make a demand to the Department of Transportation to use any material and two demonstration projects and fund it, it takes the authority away from the Department of Transportation, and I really object to this concept."

Speaker McPike: "Representative Black."

Speaker McPike: "Representative Hartke."

- Salvi: "Thank you, Mr. Speaker. This Amendment simply allows counties the same flexibility in spending iced tea hours, as the Bill gives to municipalities, and that's the purpose of Amendment #1, and under 55 (c) I would ask for a record Roll Call Vote and I'm joined by..."
- Speaker McPike: "Mr. Salvi has moved for the adoption of the Amendment. Representative Hartke."
- Hartke: "Well, thank you very much, Mr. Speaker. There were several Bills that came before my Transportation Committee, and this piece of legislation is just a little bit different than Representative Pankau's, and I'm in support of Representative Pankau's Bill, but Representative Salvi's legislation didn't get just one vote, it got two votes in committee, and now he's trying to piggyback this on Representative Pankau's Bill. I think it's a bad concept and a bad idea, and I stand in opposition to this Amendment on Representative Pankau's Bill."

Speaker McPike: "Representative Granberg."

Granberg: "Thank you. It seems like it might be up to Representative Pankau if this Bill, if this Amendment is adopted. It's my understanding that the Chairman of the Transportation Committee would then rise in opposition to the Bill, as amended. That is my understanding if that is the case, it certainly might enhance the Representatives' chances to defeat this Amendment, in which case. Representative Pankau might want to speak to Representative Salvi's Amendments."

Speaker McPike: "Representative Pankau."

Pankau: "My understanding of this Amendment, as it was filed, was to allow counties to have the same opportunity as municipalities would have had in my Bill. I have not

spoken to Representative Salvi about the specifics, but that was my general understanding of his Amendment. If that indeed is the case and there wasn't anything else involved in it. I have no problem with this Amendment going on. Speaker McPike: "Representative Hartke."

- Hartke: "Representative Pankau, you were in committee as well as Ι. and heard this piece of legislation. Yours was accepted, and his was not by the majority of that committee. It seems to me now that this adds undue burden and restriction on a wider area than your legislation, and we agreed with you, yes we may want to try this, but the committee as a whole felt that Representative Salvi's idea was not a good idea at this time, and voted it down. Now. it's going to lead to some real problems with vour legislation. There will be fiscal notes, and everything else that must be looked at. For yours, we planned on foregoing that at this time."
- Speaker McPike: "Representative Pankau, did that answer your question? Representative Pankau."
- Pankau: "I believe Representative Salvi will remove the Amendment."

Speaker McPike: "Representative Salvi."

Salvi: "I'd like to make it very clear that this Bill had the same number of votes as Carols, (Representative Pankau's). There was just a couple of Members out at the time of the vote. There was 14 'yes' votes on this Bill, not two, and it does exactly what I said it does. However, in light of the objection of the Representative, I will withdraw my

Speaker McPike: "Amendment #2 is withdrawn. Further Amendments?" Clerk Rossi: "No further Amendments."

Speaker McPike: "Third Reading. Representative Churchill, 3658. Read the Bill, Mr. Clerk."

Clerk Rossi: "House Bill 3658, a Bill for an Act amending the Chain-O-Lakes Fox River Waterway Management Agency Act. Second Reading of the Bill. Amendment #1 was adopted in committee. No Motions have been filed. Floor Amendment #2, offered by Representative Churchill."

Speaker McPike: "Amendment #2, Representative Churchill."

- Churchill: "Thank you Mr. Speaker, Ladies and Gentlemen of the House. This Amendment changes the name of the agency to the Fox Waterway Agency, permits adoption of ordinances to improve the waterway and permits the agency to issue bonds and finance acquisitions, sets limits on the fines and fees that can be charged by the agency, and it permits enrollment of its employees in the IMRF. I would ask you to adopt Amendment #2."
- Speaker McPike: "Representative Granberg, question on the Amendment."

Granberg: "Thank you, Mr. Speaker. Would the Gentleman yield?" Speaker McPike: "Yes, he will."

- Granberg: "Representative Churchill, does the unit, the Fox Waterway Agency, have any taxing powers?
- Churchill: "No, if there's, no taxing powers, no real estate taxing powers, it operates solely on fees which are charged on boat owners who put their boat in the waterways of the agency."

Granberg: "Did the previous entity have taxing powers?"

Churchill: "The previous entity did not, well the previous entity was the State of Illinois, the Division of Waterways had

120th Legislative Day April 26, 1994 control over it. Ten years ago, the voters in this area, by referendum, established this agency. It had a ten year sunset on it. That sunset came due this spring. The voters by a margin of three or four to one voted to allow the agency to continue in existence and the previous agency and the current agency has no general taxing authority."

- Granberg: "What the...is it the normal course, Representative? I saw that it permits the agency to borrow funds, and then to...they have the ability to borrow funds from any financial institution?"
- Churchill: "In the past, the language did not permit them to borrow money at all. Now that they have been put into a permanent organization, they may need, from time to time the ability to go out and acquire a piece of equipment or do something that would require them to pay for that. So, in the language that we're putting into place now, we give them the right to issue bonds, would give them the right to go out and finance these acquisitions from lending institutions."
- Granberg: "This would also give...so they have the right, they will have the right to borrow funds."
- Churchill: "Right, they have not had that right in the past ten years."

Granberg: "This would also give them the right to issue bonds?" Churchill: "That is correct."

Granberg: "What kind of bonds, jail bonds, revenue bonds?"

- Churchill: "It would have to be a bond that would relate to their fees structures since they have no taxing authority."
- Granberg: "So, that would not, when they would issue the bonds, there would be no, no assurance from any state or any other local entity to guarantee the bonds."

Churchill: "That is correct. The bond holders would have to

assume the risk that the fee structure would maintain a sufficient revenue spin to pay back the bonds."

Granberg: "Okay, thank you."

- Speaker McPike: "Representative Hartke. Mr. Hartke, your microphone is on. Mr. Hartke. Mr. Hartke, your microphone is on."
- Hartke: "Thank you very much. Representative Churchill, will you yield for a question?"

Speaker McPike: "Yes, he will."

- Hartke: "In the discussion earlier in the committee, there was some concern about the agency having regulatory rights on the water shed and so forth. Is that correct?"
- Churchill: "That is correct. There was language that allowed them to adopt ordinances that would prevent pollution in the watershed from reaching the waterway. I think it's a specific...language."
- Hartke: "Right, but you don't plan on going up and setting up a requirements for where people spread chemicals and what is allowed and backsetting from, for agriculture and so forth."
- Churchill: "That is absolutely correct, Representative Hartke. It is not the intention of the agency to wander its way up into all the little tributaries, and tell farmers what they can and can't do with their properties. The basic watershed for this waterway comes from the State of Wisconsin, so we wouldn't be able to go in to the State of Wisconsin and do that anyway."
- Hartke: "Okay, I don't have any problem with that. Does this also set up a per diem for the Members of the board which is, hasn't been there in the past?"
- Churchill: "That was in the original Amendment, the Amendment I'm trying to put on now does not contain that language."

Hartke: "This Amendment does not have those provisions in it." Churchill: "This does not have the, the director's fees in it.

This Amendment does not."

Hartke: "Thank you very much."

Speaker McPike: "The question is, 'Shall Amendment #2 be adopted?' All in favor say 'aye'; opposed, 'no'. The 'ayes' have it, and the Amendment is adopted. Further Amendments?"

Clerk Rossi: "No further Amendments."

- Speaker McPike: "Third Reading. House Bill 3691 (sic 2691), Representative Currie."
- Currie: "Thank you, Speaker. I would ask the House to agree with me that the fiscal note request on that Bill is inapplicable. As you remember, this is a demonstration project dealing with chrome rubber; and, in fact, Representative Wennlund had an Amendment which we did reject, but which pointed the way for the Department of Transportation and the Department of Energy and Natural Resources to meet the requirements of the Act without finding any new dollars. So, I think the note request is inapplicable, and I would ask my colleagues to join me in so moving."

Speaker McPike: "And Mr. Black, on the Motion."

- Black: "Yes, thank you very much, Mr. Speaker. I simply rise in pursuant to 55 (c), joined by four of my colleagues, and we ask for a Roll Call Vote."

So, on the point of order, I think the fiscal note is applicable, and would ask the Chair to so rule pursuant to Rule 55 (c) ask for a Roll Call Vote, as I'm joined by a number of my colleagues."
- Speaker McPike: "Wait a minute, wait a minute, wait a minute. Let's not get out of order. Yes. Let's not, let's not go beyond the question. He raised a point of order. You don't have a lot of Roll Call Votes on this point of order. So, there's no point in people raising their hands. He asked for a point of order."

Black: "That's true."

Speaker McPike: "All right, yes he did."

- Granberg: "Thank you, Mr. Speaker. I did not, was unaware the fiscal note had been filed. We will request...I will...file a fiscal note."
- Speaker McPike: "All right, it stays on Second Reading. State and Local Government, Second Reading, House Bill 2704, Representative Tim Johnson. Tim Johnson here? No. Representative Edley, on House Bill 2727. Edley? Mr. Edley here? Mr. Novak, 2754. Mr. Edley, there he is, do you want your Bill read? Mr. Edley, 2727. Read the Bill, Mr. Clerk."
- Clerk Rossi: "House Bill 2727, a Bill for an Act amending the Illinois Vehicle Code. Second Reading of the Bill. Amendment #1 was adopted in committee. No Motions filed. No Floor Amendments, but a fiscal note has been requested on the Bill."

- Speaker McPike: "All right, Representative Giglio, in the Chair." Speaker Giglio: "Representative Edley. Bill has been read. Take it out of the record. Take it out of the record. To some extent I do agree with Representative Kubik, and the last two days in the Chair, I've tried to take that into consideration. When the Republicans filed a request for a fiscal note on a vehicle Bill, I ruled that it was dilatory. The point of the Fiscal Note Act was to tell people on this floor roughly what the Bill would cost in its current shape or its current form, and a vehicle Bill costs nothing. I don't know what it's going to become in the Senate or what it's going to become if it comes back in a conference committee. No one knows. But the fiscal note was to tell us roughly what a Bill costs in its

What has come about actually is not what it's going to cost State Government; there really isn't a cost to State Government in this Bill. It could have a potential impact, but more than that, what is happening is out-of-state horse shows are bumping Illinois horse shows. So, I would like to point out that the impact is actually occurring in the current law, where Illinois owners of horses are losing revenues to out of state owners of horses on our state supported property at the state fairgrounds. So, I again rule that this fiscal note request is inapplicable, that this will actually generate more money for Illinois horse owners. Thank you."

Speaker Giglio: "Representative Black."

Black: "Thank you very much, Mr. Speaker. To the Sponsor's Motion, and the underlying reason perhaps for it. There is a space problem at the fairgrounds, as I understand it from the Department of Agriculture, that will be corrected within a year. She may in fact have some difficulty with this, but the Department of Agriculture is adamant that this may very well cost the State of Illinois revenue. if someone is here with a string of 20 or 30 show horses for a weekend or week long event, and an Illinois breeder who has two horses demands two stalls. Do you really think the person from Iowa or Missouri who has 40 horses is only going to put two of them out in the south 40 and keep the 38 here. That person will leave the show and leave the arena, and the Department of Agriculture is adamant that this could. in fact, negatively impact revenue to the Department of Agriculture and perhaps indirectly to the fair. Remember, you all voted last year to make the state state fair self-sustaining. Now you can't come back here because of a temporary problem that should be resolved in a and say. 'Well, that doesn't make any difference year, because somebody from Illinois ought to get priority'. Ninety-nine times out of a hundred I would agree with you, but some of the horse breeders who bring in dozens of horses and pay the going rate should not be made to leave and they will leave, if you say, 'well you're going to have to take two of your horses out of here, because there are two from Illinois that we want to board'. If we have the space, I would agree with the Sponsor of the Bill that we should give preference to Illinois horses. But, because of some remodeling, that isn't possible right now. So, I would ask you to think very carefully about what you're

doing and I urge you to vote against the Motion. The fiscal note on this Bill is applicable and I for one would like to know how much it would cost."

Speaker Giglio: "Representative Wennlund."

Wennlund: "Thank you, Mr. Speaker, Ladies and Gentlemen of the The liaison for the Department of Agriculture House. explained it to me this way, that if we give priority to the smaller shows, because they are residents of Illinois, then we lose the bigger out-of-state shows, and that's what's going to cost the department money. That's what's going to cost the state money and the amount of money that's spent here in Springfield, and at the fairgrounds. So, it would give priority to an in-state smaller show over an out-of-state larger show that would bring in a lot more revenue. That's the net effect of it and that's why the Department of Agriculture feels that the fiscal note is definitely applicable, and a 'yes' vote, or a 'no' vote on the Motion is a proper Motion and, Mr. Speaker, pursuant to Rule 55 (c) I demand and request, and I'm joined by five of my colleagues, a record vote on the issue."

Speaker Giglio: "Representative Woolard."

you, Mr. Chairman, Ladies and Gentlemen of the Woolard: "Thank House. I think as Chairman of the Agriculture Committee that we have had a fair hearing on this issue. I think that we have discussed this. I think that the real difference between the interpretation of some people and the Sponsor of this legislation is the belief that the intent of the Bill is specific to saying reserve or hold the position that you have. There's nothing that says that the priority in this piece of legislation would kick someone out of a stall who was there for an out-of-state show or from an out-of-state area. What, in fact, it does

say, is that there will be a priority given to those people who pay taxes in this state, and I think that the real issue here is whether or not we believe that taxpayers in the State of Illinois have any special or specific additional reserved rights in an entity such as the state fair. Speaker Giglio: "Representative Olson."

Olson: "Thank you, Mr. Speaker, Ladies and Gentlemen of the Body. Think back a year ago to legislation that came out of this chamber and became law which said the state fair shall be self-sustaining. They depend upon the revenue they generate to operate the following year. They are no longer a general revenue fund appropriation out of the House and Senate. What we're doing here is we're limiting the funds that the fair can generate. We're going to take a higher rate stall fee so you can't come in here because we're going to exempt this for a lower rate stall fee. We're cutting the revenues of the fair, and it's not just the revenues that are raised during the fair, it's to all the other horse events that come into the area. The previous speaker talked about what happened in committee, and said there was no testimony, and he was very correct. The Department of Agriculture was there to offer testimony, had filed a slip to offer testimony, but we passed it out on an Attendance Roll Call. There was no opportunity for the department to offer their testimony against the legislation in which said Illinois horses can preempt out-of-state horses at a lower fee. There is a fiscal impact here, very definitely, and you should vote 'no' on the Lady's Motion." Speaker Giglio: "Representative McPike."

Amendment #1 does a wonderful thing for all the volunteer fire departments in Illinois and all volunteer firemen, because it creates a special category of license plates for the volunteer firemen who have obtained the achievement of a firefighter II designation. They have gone through all the necessary training and they have worked hard and they deserve special recognition because they have put hundreds of hours in saving lives and in saving property and houses in Illinois. And volunteer firemen deserve to have this special recognition by a special license plate that acknowledges their achievement and their life saving abilities; and, Mr. Speaker, pursuant to Rule 55 (c), I'm joined by four other Members on this side of the aisle, to request a record vote on the Amendment."
- Speaker Giglio: "Any discussion on the Amendment? Representative Hartke."

Hartke: "Will the Gentleman yield for a question?"

Speaker Giglio: "Representative Wennlund? He indicates he will." Hartke: "Does this delete everything that's in the original Bill?"

Wennlund: "No, it does not."

Hartke: "Is it germane with the jest of the Bill?"

Hartke: "Excuse me, Mr. Speaker, is it germane?"

- Speaker Giglio: "All right the Gentleman moves the rule, to appeal the ruling of the Chair. All those in favor signify by voting 'aye'; opposed vote 'no'. Representative Hartke."
- Hartke: "I would like to correct Mr. Wennlund. I have absolutely no problem with the Amendment, I just wanted to make sure it was absolutely correct and on the right piece of legislation. That's one, to make sure that it is correct in the statutes. I have nothing against our firemen, I think it's very good idea. However, I was ready to ask another question even though it maybe would have been found germane. And that is, in the past the Secretary of State has been somewhat opposed to any special license plates and I was just going to ask whether the Secretary of State had endorsed this concept for the volunteer firemen?"

If you just simply let us move and advance our legislation in a fair and equitable manner, we wouldn't have to try to find a home for various pieces of legislation. I thank you for your indulgence, Mr. Speaker. We are simply tired of being treated unfairly. We wouldn't have to do this if we simply had a fair and equitable opportunity to hear legislation that we have a right to file, and has a right to be heard."
