HOUSE JOINT RESOLUTION

CONSTITUTIONAL AMENDMENT 12

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-SECOND GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that there shall be submitted to the electors of the State for adoption or rejection at the general election next occurring at least 6 months after the adoption of this resolution a proposition to amend Section 2 of Article X of the Constitution as follows:

ARTICLE X

EDUCATION

SECTION 2. STATE BOARD OF EDUCATION - STATE SUPERINTENDENT OF EDUCATION

(a) There is created a State Board of Education to be elected or selected on a regional basis. The number of members, their qualifications, terms of office and manner of election or selection shall be provided by law. The Board shall advise the State Superintendent of Education concerning goals, policies, planning and evaluating education programs, and financing. The Board shall have such other duties and powers as provided by law.

(b) A State Superintendent of Education shall be nominated at a general primary election and elected by the electors of the State at the general election every 4 years, beginning in 2004. The State Superintendent of Education shall hold office for 4 years beginning on the second Monday of January after his or her

94th Legislative Day February 8, 2002 election. To be eligible to hold the office of State Superintendent of Education a person must be a United States citizen, at least 25 years old, and a resident of the State for 10 years preceding his or her election.

The names of the candidates for State Superintendent of Education shall be printed on the ballot directly below the names of the candidates for Secretary of State.

Any vacancy in the office of State Superintendent of Education shall be filled in the manner provided in Section 7 of Article V.

The State Superintendent of Education shall be the chief educational officer of the State. The State Superintendent of Education shall establish goals, determine policies, provide for planning and evaluating education programs, and recommend financing. The State Superintendent of Education shall have such other duties and powers as provided by law.

SCHEDULE

A State Superintendent of Education shall be elected in 2004 and thereafter. When the State Superintendent of Education initially elected under Section 2 of Article X of the Illinois Constitution takes office, the term of office of the chief state educational officer appointed by the State Board of Education shall expire. This Constitutional Amendment otherwise takes effect when the State Superintendent of Education initially elected under Section 2 of Article X of the Illinois Constitution takes office.
