This Bill will increase the minimum by \$25 for each year of service up to 20 years. For example: a retiree with 15 years of service will receive an increase of \$125, bring it to a total of \$625. The maximum increase

will be \$250 for those who with 20 years service that which would amount to \$750. The same increase will apply to spouses, surviving spouses, who are now receiving a minimum \$500 or a surviving spouse can receive 50% of the deceased retiree's annuity, whichever is greater. are approximately 250 surviving spouses, the average age is Third, the existing child annuity is \$250. This will increase... be an increase of 500 for the first child and 350 per each sibling with a family of a maximum 2,500. And finally, if a child is an orphan, the existing \$350 annuity will be increased to \$1000 for the first child and \$500 each for the sibling with a family of a maximum \$2,500. This legislation's been approved by the Pension Laws Commission, the Pension Laws Committee, the Board of Commissioners, the Water Reclamation Board of Trustees... There are no one against this Bill. I ask for a favorable roll call."

Speaker Hartke: "Is there any discussion? The Chair recognizes the Gentleman from Kane, Representative Hoeft."

Hoeft: "Thank you, Mr. Chairman (sic-Speaker). As the House Republican Chairman or spokesperson for pensions, these are greatly needed. These are gonna help quite a few individuals who, at this particular point, have deficits in their pensions. And I would urge the entire chamber to vote for this needed Bill."

Speaker Hartke: "Is there any further discussion? The Chair recognizes the Gentleman from Vermilion, Representative Black."

Black: "Thank you very much, Mr. Speaker. Will the Sponsor yield?"

On our tax bills downstate, the IMRF tax rate is specifically listed on your tax bill, then you look to the right and you see how many property tax dollars you are paying to help fund the Municipal Retirees Pension Fund. - Capparelli: "I'm not sure of that. I'm sorry. I can't answer that, but I think they do because I remember seeing my tax bill; it's got the line..."
- Black: "Okay. And forgive me, I was talking with a colleague and during your explanation and you probably have already indicated this, how many employees will this impact, 200, 500?"
- Capparelli: "Approximately 50 elderly retirees of age 85 and I don't... and the average... 250 surviving annuitants at age 82."
- Black: "Okay. Is there any category that you're adding in the Bill other than those who have already retired and you're trying to simply give additional service credit? For example, those currently working, when they retire will

they then be eligible for the increased benefit formula?"

Capparelli: "This is a minimum retirement benefit, so some of them will have 20, 25 years when they do retire from now on."

Black: "That's better than ours, I think."

Capparelli: "Beats ours."

Black: "By quite a bit. Thank you very much, Representative."

Moffitt: "Thank you very much, Mr. Speaker, Ladies and Gentlemen of the House. I think all of you've heard about the huge increase in the number of meth labs that have been found around the State of Illinois. When we look at the figures from the Illinois State Police, in the last two years

there's been a 900% increase in the incidents of meth labs at a time when other serious crime was decreasing. Bill allows the court to impose an extended-term sentence any of our emergency personnel are injured. Under current law, if there's a meth lab fire, the ones that caused it could be prosecuted for illegal drug activity, but if a firefighter was killed or injured or police or ambulance there's no other charge that could be brought to them. We had a recent fire in my home county caused by a meth lab. I talked to our state's attorney, he said I'll prosecute them for the illegal drug activity, but there's nothing else I could do if we injured any of our emergency services personnel. The Sheriff's Association indicated a huge increase. Of course, the fire... it's a safety issue trying to protect our emergency service personnel and would allow this extended-term sentence. Be happy to entertain any questions you might have."

I ask for support of this Bill."

Howard: "I certainly know that they would be precluded from holding back and waiting until such a situation occurs. This legislation is not encouraging that and we're just saying that that is not a reason for any kind of action along those lines to be taken."
