Senate Bill 962 would exempt the state's compre... or affects the comprehensive insurance policy for the State of Illinois and says that, basically, in their case where there's been an insolvency of a company, that the preexisting condition would not take effect for that policy. So in the case here in Illinois where we had with Illinois Health Care, where about 26,000 people became uninsured through that bankruptcy and liquidation, those people entering the CHIP Program would not have their preexisting condition applied. It carries a cost of about 400,000. And with that, I'd be happy to answer any questions."

Speaker Madigan: "Mr. Mautino moves for the passage of the Bill.

The Chair recognizes Mr. Black."

Black: "Thank you very much, Mr. Speaker. Will the Sponsor yield?"

Speaker Madigan: "The Sponsor yields."

Black: "Representative, what's the current status of the CHIP Program? Are enrollments still on hold?"

Mautino: "No. Actually, at our board meeting last month we added an emergency board meeting and we opened the roll to allow... There were about 800 people or, actually, close to 900 people on the waiting list at that time. Authorizations were left out to bring our enrollment from the 5,000 up to 5,700. Now, not all the 900 people on that list will accept, but this will take care of a good portion of those and, incidentally, 100 of those people on the list were Illinois Health Care people that it's now been

extended to."

Black: "How much money is in the pending supplemental for CHIP?

I don't recall off the top of my head."

Mautino: "Ten million dollars. The reason that it was closed was because the medical expenses and the cost of the CHIP Program had threatened to totally use up the reserves for that program itself. And so acting responsibly, the board put a cap on enrollment to make sure we could pay the bills for those who are currently in the program. Now, the Governor's Office came to the CHIP Board, and I guess by agreement with the four Legislative Leaders that the money would be there for next year's budget and for this year's budget. That gave the comfort level which reopened the rolls to the people who are in need of the program."

Black: "I certainly do not stand in opposition to what you're attempting to do. But if we waive the six-month preexisting condition for those people who are uninsured because of insolvency, which is certainly a sound reason to let them in CHIP, obviously this is gonna cost money.

And..."

Mautino: "About 400,000."

Black: "... my only concern is... You know, it had a unanimous vote in the Senate, it had a unanimous vote in the House Committee. We can't even get together on passing the supplemental. Now, if we don't add the \$400,000 in next year's budget, my fear is these people will be given false hope that they're gonna be able to waive the preexisting condition, but they won't get in the program because we're not appropriating the money necessary to cover them. I mean, at some point where do we stop and say, look, without the money there's no use to pass legislation like this."

Mautino: "The legislation itself and the money which is figured

into next year's budget is, at this point, in the base line of the budget itself for operating. That's why they went ahead and opened the rolls."

Black: "All right."

Mautino: "With this situation it's limited to the number of people it would apply to. We currently have had three insolvencies which would effect this in the individual fund. And this is also actually parity with the Section 15, which is the federal program."

Black: "Okay."

Mautino: "If you were in a group plan as opposed to an individual plan, this would apply right off the bat."

Black: "All right. So, you're telling me there will not be a trailer Bill in this Session's budget negotiation. The FY02 budget has built into the base line coverage for this waiver of the preexisting condition. Correct?"

Mautino: "My understanding is they... they've asked for a lump sum operating budget and believe that this was workable within that budget, according to the director."

Black: "Well, then I certainly stand in support of your Bill.

The only caveat, shame on us if we don't budget the money because then what we've done is to create false hope. And knowing what it's like to be uninsurable on the open market as I am there's nothing worse than holding out that carrot of potential health care coverage and then the General Assembly, as a Body politic, not following through. I know you'll do your best to make sure the money is there. I intend to vote for the Bill, but I would hope and I would ask you that we not be here next year talking about a supplemental to take care of these people because that's just not fair."

Mautino: "If there were to be that situation, here is what I will

do. The other way to do this without doing Section 15 is to take and change the federal eligibility standards on the group plan. By doing that, we would take people who had lost even from independent policies and put them into Section 15 where this is waived anyway. That is the way they could do it. The difference there is, 15 is funded by an assessment on the industry, 7 is funded by the state tax dollars. And I will do that and I would hope you would join me..."

Black: "Okay."

Mautino: "...as well."

Black: "Thank you, I will. Thank you very much. Thank you, Mr. Speaker."

Requires a county to obtain approval for sewer projects that involves state land from appropriate state agency rather than the Office of the Governor. Designates the last Friday in April as Arbor and Bird Day. Designates the first full school week in May as Illinois Law Week. Removes the requirement that the Governor approve the appraisal of diseased animals whose slaughter results in a claim for reimbursement from the state. Further removes the requirement that the state mine inspectors provide bonds approved by the Governor. Be glad to answer any questions that you have."

Speaker Hartke: "Is there any discussion? The Chair recognizes the Lady from Peoria, Representative Slone."

Slone: "Thank you, Mr. Speaker. Will the Gentleman yield?"

Speaker Hartke: "The Sponsor will yield?"

Slone: "Thank you. Mr. Black, I was interested in the part of this that deals with diseased animals that have to be slaughtered and claiming reimbursement. Given the 'mad cow' and 'foot and mouth' disease epidemics that have occurred in Europe, and there's some concern that that may come to this part of the world, would that have any effect on the financial response in the event that we... that those diseases came to cattle in Illinois?"

Black: "Your point is well taken given the, I think, the current state of heightened awareness of 'foot and mouth' disease and 'mad cow' disease. Checking with the Governor's liaison, the Governor's Office will still be involved
