This came to me because in my district we had some problems with the NICOR situation. And I think this is a step in the right direction to have our citizens not be worried about this anymore. And I'd be happy to answer any questions."

Provides that members of the Illinois National Guard may be ordered to provide funeral honors duties. Provides that funeral honors are subject to the availability of funds. I urge the House to pass it. 'Aye' vote, please."

Clerk Rossi: "Senate Bill 961, a Bill for an Act concerning local government debt. Third Reading of this Senate Bill."

The purpose of this legislation is that to... is designed to limit the provisions allowing the deposit of certain revenues or taxes into an escrow account to those government units meeting the aforementioned requirements. This will allow proper administrative and financial oversight of the interceptor power and this limitation adds safeguards to the state intercept provision. I'd be happy to answer any questions."

I urge an 'aye' vote."

Clerk Rossi: "Senate Bill 1084, a Bill for an Act in relation to counties. Third Reading of this Senate Bill."

Reitz: "Thank you, Mr. Speaker. House... Senate Bill 1084 deals with the board of appeals. It creates consistency now with the members as far as determining any reversal that they may have. This brings in... creates consistency within the various codes of local government. It sets up the same parameters that the Municipal Code has right now. And I'd be happy to answer any questions."

Speaker Madigan: "Mr. Reitz, can we take this out of the record for just a couple of minutes? Mr. Clerk, take the Bill out of the record. Mr. Black, did you wish to call Senate Bill 1113. Mr. Clerk, read the Bill."

Clerk Rossi: "Senate Bill 1113, a Bill for an Act in relation to county law enforcement employees. Third Reading of this Senate Bill."

Speaker Madigan: "Mr. Black."

Black: "Thank you very much, Mr. Speaker and Ladies and Gentlemen of the House. Senate Bill 1113 provides that a Sheriff's Merit Commission may exempt applicants who are graduate law enforcement interns under the Law Enforcement Intern Training Act from one or more of the minimum requirements for appointment as a deputy sheriff. There were some questions that came up in committee. Let me respond to those, specifically. The Illinois Sheriff's Association does stand in strong support of this Bill. And obviously, there are some requirements that the Merit Board could not waive such as a background investigation or a residency requirement, that may be imposed upon that county by its

county board. Some of the items that could be waived would be the agility test, which they had already taken, psychological tests, which they had already... would have already taken as a law enforcement intern, perhaps some of the firearm training courses. And what the Sheriff's Association told me, it makes no sense to hire an intern who may have gone through 80% of what's required to be a deputy sheriff and then have them go through the exact same training program, at a cost of several thousand dollars to the county, when in fact, they may be able to waive some of those requirements that the intern would have already satisfied by going through the program. I'll be glad to answer any questions that you have."

Speaker Madigan: "The Gentleman moves for the passage of the Bill. The Chair recognizes Mr. Hartke."

Hartke: "Yes. Will the Sponsor yield?"

Speaker Madigan: "Sponsor yields."

Hartke: "Representative Black, you know we talked in committee and I appreciate you getting with the Sheriff's Association and it answers part of my question, but this also exempts certain requirements. Is that not correct?"

Black: "The Merit Board could waive a requirement that, in their opinion, the applicant has already passed, such as, things that I mentioned: the agility test, the psychological test, those things that have already been done. It's my understanding, in a letter I received from Greg Sullivan, they could not exempt certain things required by county ordinance or certain exams or training... portions of a training program that that intern had not completed or had not gone through as an intern."

Hartke: "Well, if the Merit Commission has that authority now, why do we need this legislation?"

Black: "Well, they can't waive the requirement on people who have not gone through this program. In other words, the people who have gone through this program have already taken many of the tests and performed many of the duties and had a great many of the classroom instructional hours that you and I would have to go through from scratch if we were to become deputy sheriffs. All they're asking for is if somebody went through the program and was an intern, we don't think we should make them just repeat all of that at a cost to the county. What they've already completed, we can waive."

Hartke: "Can you give me an example of other things that they may be able to waive?"

Black: "If they had already had the sufficient hours of the firearms training... course, they could waive that. Any test that they had already taken, such as the psychological battery. If they've already gone through a background check... criminal background check and it is current, they could waive that, they wouldn't have to go through the cost of having another background check completed."

Hartke: "What about physical fitness exemption, would they..."

Black: "If I can paraphrase, I don't have the exact timeline for you. My guess is that if it had been within a year of their physical test and there were no signs or outward signs or any implications that the person's health had dramatically changed in that 12 months, yes, they could waive a physical exam."

Hartke: "Could they waive an age requirement as well?"

Black: "No, they cannot. That is in State Law."

Hartke: "Okay. Thank you very much."

Mathias: "Thank you, Mr. Speaker. Senate Bill 1297, the purpose of that Bill is to prohibit secret video taping of people with high-tech cameras. And what happens with those pictures is a lot of them are sold under... on the Internet. And it basically prohibits anyone from taking a picture of someone either under or through their clothing. CONSTITUTIONAL AMENDMENT 3

WHEREAS, The Ninety-second Congress of the United States of America, at its Second Session, in both houses, by a constitutional majority of two-thirds, adopted the following proposition to amend the Constitution of the United States of America:

JOINT RESOLUTION

RESOLVED BY THE HOUSE OF REPRESENTATIVES AND SENATE OF THE UNITED STATES OF AMERICA IN CONGRESS ASSEMBLED (TWO-THIRDS OF EACH HOUSE CONCURRING THEREIN), That the following article is proposed as an amendment to the Constitution of the United States, which shall be valid to all intents and purposes as a part of the Constitution when ratified by the legislatures of three-fourths of the several States within seven years from the date of its submission by the Congress:

Section 1. Equality of rights under law shall not be denied or abridged by the United States or any State on account of sex.

Section 2. The Congress shall have the power to enforce by appropriate legislation the provisions of this article.

WHEREAS, The United States Congress has recently adopted the 27th Amendment to the Constitution of the United States, the so-called Madison Amendment, relating to Compensation of Members of Congress; this amendment was proposed 203 years earlier by our First Congress and only recently ratified by three-fourths of the States; the United States Archivist certified the 27th Amendment on May 18, 1992; and

WHEREAS, The founders of our nation, James Madison included, did not favor further restrictions to Article V of the Constitution of the United States, the amending procedure; the United States Constitution is harder to amend than any other constitution in history; and

WHEREAS, The restricting time limit for the Equal Rights Amendment ratification is in the resolving clause and is not a part of the amendment proposed by Congress and already ratified by 35 states; and

WHEREAS, Having passed a time extension for the Equal Rights Amendment on October 20, 1978, Congress has demonstrated that a time limit in a resolving clause can be disregarded if it is not a part of the proposed amendment; and

WHEREAS, The United States Supreme Court in Coleman v. Miller, 307 U.S. 433, at 456 (1939), recognized that Congress is in a

unique position to judge the tenor of the nation, to be aware of the political, social, and economic factors affecting the nation, and to be aware of the importance to the nation of the proposed amendment; and

WHEREAS, If an amendment to the Constitution of the United States has been proposed by two-thirds of both houses of Congress and ratified by three-fourths of the state legislatures, it is for Congress under the principles of Coleman v. Miller to determine the validity of the state ratifications occurring after a time limit in the resolving clause, but not in the amendment itself; and

WHEREAS, Constitutional equality for women and men continues to be timely in the United States and worldwide, and a number of other nations have achieved constitutional equality for their women and men; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-SECOND GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that the proposed amendment to the Constitution of the United States of America set forth in this resolution is ratified; and be it further

RESOLVED, That a certified copy of this resolution be forwarded to the Archivist of the United States, the Administrator of General Services of the United States, the President pro tempore of the Senate and the Speaker of the House of Representatives of the Congress of the United States, and each member of the Illinois congressional delegation.
