Clerk Mahoney: "House Resolution 156, offered by Representative Madigan. Refer to the House Committee on Rules."

Speaker Lang: "On page 10 of the Calendar, under the Order of House Bills-Third Reading, appears House Bill 1263. Mr. Clerk, please read the Bill."

Clerk Mahoney: "House Bill 1263, a Bill for an Act concerning criminal law. Third Reading of this House Bill."

Speaker Lang: "Mr. Farnham."

"Thank you, Mr. Speaker, Members of the House. Farnham: House Bill 1263 automatically imposes a natural life sentence on person who was convicted of one of the following а offenses, if the victim was under 18 at the time of the offense and the offender has previously been convicted of one of the following sex offenders... offenses in the past 20 years: criminal sexual assault, Class I Felony; aggravated criminal sexual assault, Class X Felony; predatory criminal sexual assault of a child, Class X; criminal sexual abuse, Class A Misdemeanor, Class IV Felony and Class II Felony, depending on the age of the victim, type of abuse, and aggravated criminal sexual abuse, Class II Felony. Under this Bill a person who is convicted a second time of any of the five listed offenses within a time frame of 20 years and where the victim was under 18, will be given a natural life sentence. I'll entertain any questions."

Speaker Lang: "The Gentleman's moved for the passage of the Bill. And on that question, the Chair recognizes Representative Reboletti."

- Reboletti: "Thank you, Mr. Speaker. To the Bill. I'd like to thank the Sponsor for holding this Bill from last week so that we could talk to the Cook County State's Attorney with respect to their objection, but their objection was based on the fact, that if the death penalty was abolished, this would be on the same level as natural life without parole for murder. But with respect to that, if you have somebody who's already been committed of sex crimes against children and then serves a term of 20 years and gets out and does the same thing, I think that the people of the State of Illinois must lock that person up for natural life because they are a predator and that's what they will do until they die. So, I'd urge for the Gentleman's support for the Bill."
- Speaker Lang: "There being no one further wishing to speak, those in favor of the Bill shall vote 'yes'; opposed 'no'. The voting is open. Have all voted who wish? Have all voted who wish? Have all voted who wish? Colvin, Davis, Lilly. Please take the record. On this question, there are 105 voting 'yes', 6 voting 'no'. And this Bill, having received the Constitutional Majority, is hereby declared passed. On page 12 of the Calendar, under the Order of Resolutions, appears House Resolution 110. The Chair recognizes Representative Bradley."
- Bradley: "Thank you, Mr. Speaker. House Resolution 110 is the proposal that would establish the amount of money that the Revenue & Finance Committee has determined is available for the state this year to spend. The number is approximately \$33.2 billion. We took the numbers from the Office of

Management and Budget from the Governor's Office. We backed out the things that have not taken place yet, which are not actually in law, and we arrived at a bipartisan number which was agreed upon by the Members of the committee, the Republican spokesperson. It's a bipartisan number. The idea being here that we will run the state like a family runs itself, like a small business would run itself. We can only spend the money we have. And this is the amount of money that we deem that we have. I'd ask for an 'aye' vote."

Speaker Lang: "The Gentleman moves for the passage of Reso… the adoption of the Resolution. On that question, the Chair recognizes Representative David Harris."

Harris, D.: "Thank you, Mr. Speaker. Question of the Sponsor?" Speaker Lang: "Sponsor yields."

Harris, D.: "Representative, this deals only with an estimate of how much revenue we're taking in, doesn't talk about the spending whatsoever, does it?"

Bradley: "Correct."

Harris, D.: "Thank you. To the Resolution, Mr. Speaker. Ladies and Gentlemen of the House, first of all my compliments to Speaker Madigan, who is not on the floor, for initiating this process. This is a process which every family in the State of Illinois engages in when they determine what they're going to spend in their budget. They sit around the table. They say how much money do we have to spend. Can we take a vacation this year? Can we get a new car? They determine how much money they have to spend and that way they can determine how... or how much money they're going

to take in and that way they can determine how much money they're going to spend. That's what this Resolution does. All it is is an estimate of how much we're going to take in. One point, it is lower than COGFA's number and it is lower than the Governor's Office of Management and Budget number. Are we, the committee Members, any smarter than No, we're not, but we're being realistic and thev are? we're being relatively conservative. This is indeed a good number to work with. Hopefully, the Appropriations Committees can live with the number that the House Revenue & Finance Committee is giving them. Again, my compliments to the Speaker. To all my Members on this side of the aisle, this is no commitment to vote for the budget whatsoever, but it is a recognition of how much money we think is going to come into the State of Illinois. And I concur and urge an 'aye' vote."

Speaker Lang: "Mr. Riley."

Riley: "Thank you, Mr. Speaker. Will the Sponsor yield?"

Speaker Lang: "Sponsor yields."

Riley: "Representative Bradley, first of all, I want to commend you on all the work that you've done so far and the work that all of us have to do. I'm not going to denigrate the abilities of everyone in this great Body, because we all have responsibilities. So... but I just want to know something about the decision process that went into this particular number. Were the other estimates considered at all or... How did we determine that we were going to take this number and not the other estimates, or maybe an amalgamation of them, or what?"

Bradley: "There were... there was an evaluation in a bipartisan manner by the Republican spokesperson, myself, members of our staffs, in terms of looking at the numbers that were available. And so..."

Riley: "Mr. Speaker, I can't hear Representative Bradley."

Bradley: "So, we made a decision based upon the numbers to be cautious and we took a cautious approach. We've gotten in trouble in the past overestimating, and so in this time we took a very cautious approach in terms of arriving at the numbers. So, we took the Governor's number, which was lower than the COGFA number, and we took out the stuff, which both numbers had in them, that hasn't actually taken place yet, CIT and the decoupling, because that's pie in sky until it happens and we arrived at a number, which was agreed to by both Parties within the committee structure. And so, I didn't take it lightly; I didn't arrive at it flippantly. We were trying to come up with a number that we were confident that the state could actually justify and meet. And it was a difficult decision, will continue to be a difficult decision, but we felt that was the approach that we should take given the fiscal climate we're in."

Riley: "Thank you. Thank you for your work."

Speaker Lang: "Representative Nekritz."

Nekritz: "Thank you, Mr. Speaker. To the Resolution. This Resolution establishes a baseline revenue number and this is really the first step in implementing the budgeting for outcomes process that Representative Sente and Senator Kotowski have worked so hard on. And without this step and establishing a number that we can then determine our

expenditures, we are really not going to be able to implement the budgeting for outcomes that is now in law. And this... while I know that this is a difficult number for a lot of people to take, this is, in fact, the reality of what we have. Once we are able to allocate this and then determine the spending that can fit within this number, we can have a legitimate public debate about whether we want more revenues, whether we... whether these are the right cuts we could be making, whether we want to be making other cuts, but until we establish this number, none of that public debate can happen. And that's what's happened to us over the last eight years. We've had Governors introduce budgets based on phantom income, or income that's not yet been adopted by the General Assembly and so, it's been very difficult to have an honest public debate about what is available to spend and what are we spending it on, and what are the programs, what are the things that we are buying for our tax dollars. Again, this is an important first step in establishing that process. I think this will better inform the public about what we're spending and what we're spending it on. And so, I'm very excited to be supporting this Resolution."

Speaker Lang: "Representative Eddy." Eddy: "Thank you. Would the Sponsor yield?" Speaker Lang: "Sponsor yields."

Eddy: "Representative, where do we go from here in the process? I agree that, so far, we're in a situation where there's been diligence performed. We're at a number that I think

would be best described as conservative. What happens next with this number?"

- Bradley: "It would be my anticipation, without speaking out of school, that now we would attempt to allocate that number among the Appropriations Committees, and start working on a budget."
- Eddy: "So, is there a point along the way at which this number is reexamined, or is this going to be, in your estimation, the... our approach, the conservative approach for the approps then to take over?"
- Bradley: "Well, obviously, the House of Representatives, the Senate, and the Governor can make laws or change laws. There were a couple of proposals that were in the law... in the numbers that were presented to us by both of the economic forecasters which have not taken place. Those numbers could take place at some point, which could have an effect on the number. Other things could happen... Shaw, could you move, please... other things could happen that could effect the numbers as well. And so, at this point, we think this is a good, cautious number. And I'm not going to start negotiating against myself or against ourselves."
- Eddy: "No. But if there are... if there are changes in these assumptions, is it your intention to replicate this process so that there would be the same type of bipartisan input to come to any change in that?"
- Bradley: "It is my intention to continue to work with spokesperson Harris, who has done a wonderful job representing the Republicans on the committee. We worked

very closely together, arrived very quickly in a cooperative manner on a number. I don't have any intention of that changing."

Jakobsson: "Thank you. Today is International Women's Day. International Women's Day has been observed since the early 1900s. That was a time of great expansion and turbulence

in the industrialized world. It saw a booming population growth and the rise of radical changes. In 1908, there was such great unrest occurring among women, and women's oppression and inequality was spurring women to become more active and more vocal. And in 1908, 15 thousand women marched through New York City demanding shorter hours, better pay, and voting rights. And this has continued to be International Women's Day, March 8, every day. And there are several events going on, but in particular this year's theme is equal access to education, training in science and technology, a pathway to decent work for women. And I'd like to share this time with Representative Bellock, who wants to talk about one of our own Illinois women heroes."

Speaker Lang: "The Chair recognizes Representative Bellock."

"Thank you very much, Mr. Speaker. And this is an Bellock: honor to talk about Jane Addams, who's probably one of the most famous women from Illinois who lived from 1860 to 1935 and founded the Hull House. After graduating from Rockford Seminary in 1881, she attended Women's Medical College in Pennsylvania. Upon leaving due to ill health, she toured Europe for several years. On a return trip in 1888 with her classmates, they visited Toynbee Settlement Hall in London's East End where they were inspired to start an American equivalent of that settlement house. Upon their return, they chose Hull mansion which was then used as a warehouse and surrounded by an immigrant neighborhood. As Hull House became an institution known worldwide, Addams wrote articles, lectured widely and did most of the

fundraising personally and served on many social work, social welfare and settlement house boards and commissions. Jane Addams also became involved in wider efforts on social reform including housing and sanitation issues, factory inspection, rights of immigrants, women and children, pacifism, and the eight-hour day. She served as a Vice President of the National Women's Suffrage Association from 1911-1914. She worked for the Peace Party, helped found and served as President in 1919-1935 of the Women's International League for Peace and Freedom and was a founding member of the ACLU. In 1931... this is a fact that a lot of people in Illinois did not know about. In 1931, Jane Addams was awarded the Nobel Peace Prize, only the second woman ever to be awarded that honor. Thank you."

Speaker Lang: "Thank you, Representatives. Before we adjourn, I would like to just thank the Members for your cooperation. We moved a lot of Bills today. Let's continue to do that as we move through the week. And now, Representative Lyons moves that, allowing perfunctory time for the Clerk, the House stand adjourned until Wednesday March 9 at 12 noon.
