Eddy: "Thank you... thank you, Mr. Speaker. Ladies and Gentlemen of the House, if I could have your attention for just a second. If you'll remember yesterday we were... we were treated to the wonderful colloquy of the Italian Caucus in which there were two major actors, one part was played by Representative DeLuca, the other part was played by Representative Coladipietro. After voting, heavy voting, a very close... very close vote, Representative Coladipietro has won the academy award for his performance yesterday in the Italian colloquy and he will receive this as a memento of his award. A round of applause for the academy award winning, Franco Coladipietro."

Speaker Mautino: "My understanding... Mr. Eddy, my understanding that... is that of the 13 voting members, Mr. Coladipietro received 17 votes. On page 28 of the Calendar is House Resolution 156, Representative Bradley."

Bradley: "Thank you, Mr. Speaker. This is the Resolution that sets the appropriation allocation levels. It passed out of committee unanimously. The way we arrived at these percentages was that we took a six-year average, then we took a six-year rolling average and then we averaged those two averages and came up with what we believe to be the historical allocation levels of the moneys that are available by this process. Again, it passed out of committee unanimously. It's a bipartisan agreement. I would ask for an 'aye' vote."

In the opinion of the Chair, the 'yeses' have it. And those Bills will be tabled. Mr. Clerk, Senate Bill #4. Has it been read a second time? On page 26 of the Calendar, please read the Bill a third time. Mr. Clerk, any Motions pending?"

Clerk Bolin: "Senate Bill 4, the Bill was read a second time on a previous day. Amendment #1 was tabled. Amendment #2 lost. Amendment #3 has been adopted. No further Amendments. No Motions filed."

Speaker Mautino: "Third Reading. And read the Bill."

Clerk Bolin: "Senate Bill 4, a Bill for an Act concerning Revenue. Third Reading of this Senate Bill."

Speaker Mautino: "Representative Bradley."

Bradley: "Thank you. This is the Bill that would provide the EDGE Credits for both the Continental Tire Project in southern Illinois as well as the Motorola Project in suburban northeastern Illinois. This is vitally important to creating hundreds, if not thousands, of jobs in our communities. The objectionable parts that people were most upset about, particularly the agricultural exemptions, have been removed from the Amendments. This Bill passed out of committee overwhelmingly. I would ask for an 'aye' vote."

Speaker Mautino: "Gentleman moves passage of Senate Bill 4. And on that, the Gentleman from Lake, Representative Sullivan."

Sullivan: "Thank you, Mr. Speaker. To the Bill. Ladies and Gentlemen, this has been an ongoing process that finally

Those parts that would have sunsetted all kinds of different tax credits have been removed. This is a Bill that will move Illinois forward on a tremendous amount of job creation in southern Illinois and up in my district with Motorola. To not pass this Bill will be a devastating blow to keeping Motorola mobility in the State of Illinois. That is certainly an iconic company that we would not want to lose to another state. So, I urge everybody in the Body, especially on my side of the aisle, to... to look at the Bill that is now in a good shape. It's not in the shape that it was in once before and please vote this out... over to the Senate. Thanks."

Speaker Mautino: "Further discussion? The Gentleman from Crawford, Representative Eddy."

Eddy: "Will the Sponsor yield?"

Speaker Mautino: "He indicates that he will."

Eddy: "Representative, I want to just clarify the term 'objectionable parts' a little more specifically, we have Members asking. The... the elimination of the Ag sales tax exemption was once part of this in an Amendment. That is not in here now?"

Eddy: "It's been totally removed. So, those people who were concerned..."

Bradley: "It... it was never adopted."

Bradley: "The... the proposal failed in committee. Senate Bill 4 remained clean. We put an Amendment on the Bill to include the Motorola provisions, to make some modifications to the EDGE Credits which were agreed to by DCEO."

Eddy: "Thank you very much. Just... we had a lot of questions because of that specific Ag sales tax exemption. I would urge everyone's support..."

Bradley: "I wouldn't be standing here today if that was still in there."

Eddy: "I think you're probably right. But thank you for that and I would urge everyone to support the Gentleman's Bill."

Speaker Mautino: "Further discussion? The Gentleman from Marion, Representative Cavaletto."

Cavaletto: "Thank you, Mr. Speaker. I just want to say that Senate Bill 4 means a lot to my district and Continental Tire. They're building another plant and going to provide hundreds of construction jobs and over 400 jobs that will be created for us in the 107th District. This product will be going overseas to foreign countries and we really appreciate your support on this Bill. Thank you very much."

Dunkin: "I... I don't have the privilege of being in your Revenue Committee where all the action is."

Bradley: "So, Representative, it's my understanding that there are three sunsets which remain in there. They were negotiated with DCEO. I know you're concerned about the film tax credit; it's not going away. We're putting sunsets on exemptions and credits for the purpose of evaluating. But this is obviously something you're very passionate about and I'm willing to work with you and I think others are willing to work with you in continuation of this potentially in the future. This does not get rid of them. It's been a policy of this state that new exemptions that we've done in the last several years we've put sunsets on. So, obviously a sunset is different than a repeal. This is not a repeal of the film tax credit."

Dunkin: "Sure. So, you're saying this Bill, which is effective immediately, will give five years of today's date or the effective signage date and then we'll come back and review... assess the credits?"

Bradley: "And... and the good credits will remain. Obviously, this applies to the project in my area as well. There's a sunset on that. There's going to be sunset on these EDGE Credits. The idea here is not to necessarily eliminate anything that's working, but it's part of a policy that the state is taking on in the last few years so that we have a review process in place."

Dunkin: "Is there a way... is there a barometer today that we can look at to see the success of, at least, the film tax credit, which is what I'm mainly interested in as you so..."

Bradley: "I'm going to rely on you as we work forward on these issues for you to help me understand that, help others understand that, the value of those credits as we move forward."

Dunkin: "Okay. Thank you."

Bradley: "Thank you."

Speaker Mautino: "Further discussion? The Gentleman from Randolph, Representative Reitz."

Reitz: "Thank you, Mr. Speaker. Will the Sponsor yield?"

Bradley: "Yes."

Reitz: "John, just on following up on Representative Dunkin's question, if someone has a current EDGE Tax Credit the sunset will still allow them, the DCEO, to honor those agreements until such time? It just means that we will revisit this. The Legislature will be forced to take a look at this program on a regular basis."

Bradley: "It's my understanding DCEO agreed to the language that's in here. It was negotiated. It's not the same as what originally was proposed."

Reitz: "Okay. Thank you. To the Bill. I commend the Sponsor. He did a great job cleaning this Bill up. As a former chairman of Revenue, I know there are issues we need to look at. And I think he did a very good job getting those... a discussion on those issues out there and did a great job on the EDGE Tax Credit. On this Bill... this Bill will help employers in southern Illinois create jobs, keep jobs in Illinois and... and I think it's a great program. EDGE, along with a number of the other tax credit programs that

we have, allow us another tool to compete with other states. So, good job, John."

Speaker Mautino: "Further discussion? The Gentleman from Cook, Representative Will Davis."

Davis, W.: "Thank you, Mr. Speaker. Will the Sponsor yield?"

Speaker Mautino: "He indicates that he will."

Davis, W.: "Representative Bradley, let me just ask something similar to Representative Dunkin's question with regard to these tax credits. Now, there are a few identified in this Bill. Are there more tax credits that are in... that are active here in the state than the other... than these three that are mentioned in this Bill?"

Bradley: "Yes."

Davis, W.: "Then is there any particular reason why we focused on these three?"

Bradley: "I... I can't answer that, Representative. There were several negotiations and discussions going on. I wasn't involved in all of those discussions. I think there were 500 or 600 listed at one time. But it's my understanding that the Governor's Office, DCEO negotiated with regards to these. And the idea being not to get rid of anything that's working, but to have a process to evaluate and confirm that those things are in fact working."

Davis, W.: "Well, if we review them I guess to determine their feasibility, and I would argue that particularly the film tax credit and for that matter even the EDGE Tax Credit, have had benefit and provided benefit here to the state. I believe there have been a few films that have been filmed here in Chicago... in the Chicago in particular. Matter of

fact, there's one coming up I saw a trailer for and recognized the use of the Metra train. So, while I appreciate the sunset, I... I'm just wondering then why we're not studying them first and then if they're not effective then just eliminate them versus putting a sunset on it and then kind of working backwards in that respect?"

Bradley: "I... I appreciate your comments. Those are things that have been discussed; issues that have been raised. And as always, Representative, I'm willing to work with you in my capacity as Revenue chair and I know that you're very capable in terms of presenting just how important these are."

Davis, W.: "Well, that... I guess that's what I'm trying to understand. And particularly, I'm going to point out that my colleague Ken Dunkin, former Senator Ricky Hendon, so the film credit piece was something that was an initiative of the Black Caucus. So, what would have been more palatable..."

Bradley: "I... I..."

Davis, W.: "...is that if they wanted to include it, maybe they should have talked to us first to say we want to do this. So, that the Gentleman from our chamber that's been the leader on that at least would have had the opportunity to provide his own input and maybe even discuss it with the Members. So, again..."

Bradley: "As someone..."

Davis, W.: "...I'm just a little concerned that's all."

Bradley: "And as someone that's received hundreds if not thousands of calls on these issues, I can appreciate what you're saying."

Davis, W.: "Okay."

Speaker Mautino: "Further discussion? The Gentleman from Cook, Representative Saviano."

Saviano: "Thank you, Mr. Speaker, Members of the House. Folks, this component of getting rid of the... the film credit with a sunset date, you might as well just end it today. You might as well just end it today and I'll tell you why you might as well end it today. TV shows that have come in... TV shows that have come into Chicago, a TV show comes in with a five-year business model which means they have..."

Speaker Mautino: "Excuse me, Representative. I'd ask the Members of the House to please bring down the volume in the chamber. Would staff take the conversations to the back of the chamber. Excuse me. Would the staff take their conversations to the back of the chamber."

Saviano: "Thank... thank you, Mr. Speaker. I want to reiterate here. Putting a sunset date on that film production credit will literally shut things down in the first year of the five-year sunset. We have TV shows who need a five... need five years as a business model. So, two years into the five-year sunset date we will no longer be able to attract new shows or possibly movies to our state. It's totally counterproductive. That's why it was so important not to put a sunset date in the last Bill as we passed it. Movie producers... sometimes it takes three, four years to develop a movie project and for them to all of the sudden come in

and say, well we only got two years left so we're going to forget about Illinois. And they'll go to Michigan, they'll go to Toronto, and they'll go Maryland. If you want to end the credit, end it. I'm for it, but end it because the first year or two into it, we could no longer attract TV shows, movies. We were... TV commercials, anything of that consequence will be gone from us. I would strongly advise, this has been a big success. We brought in Chicago Code, movies, since we've passed this. We have created a new venue for young kids coming out of Columbia with opportunities and kids of all diversities. It... we... we created an environment in this state that put a business that was dying back on the map and this state is now back on the map in this country on film production. I would ask the Sponsor... the rest of the Bill I have no concerns with; this is a bad component. This is bad for the State of Illinois. In some of our toughest times, we are realizing more money coming into our downtown hotels, restaurants, all our unions, all our unions are prospering. Where the convention business was faltering, our movie business was picking up and it was making up for those job losses. This will shut it all down. I'd appreciate you take this component out of the Bill, so I can vote for the rest of it. Under the current form, I cannot vote for it. Thank you, Mr. Speaker."

Harris, G.: "Thank you, Mr. Speaker. Will the Sponsor yield? I would like to echo the comment of the previous speaker."

Just as much as I would be against removing... putting the tax back on agricultural inputs that would negatively affect constituents in agricultural areas, ending this tax credit on the film and television production industry will have a tremendous detrimental affect on working families in the City of Chicago and the surrounding areas. Harris, D.: "Representative, my synopsis reads that for the film production services tax credit of 2008, which is what we've been discussing here, that for tax years beginning on or after the effective date of this Bill they have in essence an additional five years. Is that correct?"

Bradley: "That's my understanding."

Harris, D.: "So in effect, we are extending the... the services tax or the film production tax credit beyond what it would normally have expired at?"

Bradley: "I believe that's correct."
