Clerk Bolin: "House Joint Resolution 45, offered by Speaker Madigan.

WHEREAS, The Illinois House of Representatives has established prudent fiscal parameters for the State budget with House Resolution 110, which required the House Revenue & Finance Committee to set the total amount of general fund expenses for Fiscal Year 2012, and House Resolution 158, which required that any amount of additional State revenue be used to pay the backlog of unpaid State obligations rather than being spent on more State services; and

WHEREAS, The Illinois House and the Illinois Senate passed several State budget bills that held spending under the House Revenue & Finance Committee's State revenue estimate; and

WHEREAS, The Illinois House of Representatives passed the two fiscally responsible resolutions by a vote of 112-0-0 for

- House Resolution 110 and 114-0-2 for House Resolution 158, respectively; and
- WHEREAS, The State of Illinois would have paid employees represented by the American Federation of State, County, and Municipal Employees (AFSCME) an estimated \$2,762,956,700 in all funds for payroll costs before the House of Representatives and the Senate reduced the budget for Fiscal Year 2012; and
- WHEREAS, The Cost of Living Allowance (COLA) for employees represented by the American Federation of State, County, and Municipal Employees (AFSCME) has averaged an increase of 4.25% over the past 5 fiscal years; and
- WHEREAS, The Consumer Price Index has averaged an increase of 1.95% from the years 2007 to 2010; therefore, be it
- RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-SEVENTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that the State shall appropriate for no more than an X% increase for wage increases associated with any and all collectively bargained contracts throughout State government; and be it further
- RESOLVED, That it shall be the policy of the State of Illinois that the size of, or a reduction in, the State employee workforce shall not be a topic of collective bargaining."

Speaker Lyons: "Speaker Madigan."

Madigan: "Mr. Speaker and Ladies and Gentlemen, let me begin by reporting that as of October 22, the State Comptroller tells us that the State of Illinois has approximately \$2.71

billion in unpaid obligations outstanding 45 days or more. So as of a few days ago the State of Illinois had unpaid bills in the amount of \$2.71 billion. That's the background against which I have introduced this Resolution. The state is currently in the middle of a collective bargaining contract set to expire in June of 2012. The administration has advised us that they plan to open negotiations with AFSCME and all of the other unions that represent unionized state workers sometime during the fall of this year. So, their plan is to open the negotiations in the fall, conduct those negotiations through the end of this calendar year, into the next calendar year up to that deadline of June of 2012, when the current contract would expire. Traditionally, prior Governors have negotiated with AFSCME and the other unions without regard to Legislature. Traditionally, the Governor would negotiate, the Governor would come to an agreement with the unions, and then subsequently the Legislature would be told this is the cost of the contract that we just negotiated. They negotiate a contract, they'd send the bill to us, we'd be told, pay the bill. This Resolution is designed to interject the Legislature into a collective bargaining that will occur between the Governor's Office and the unions representing unionized state workers. The Resolution simply recites that the Legislature, beginning in the House last spring, did a very good job of adopting a budget that did not authorize spending beyond our means on a yearly basis. Resolution here; adopted а we live under restrictions of that Resolution. We adopted another

Resolution which said that if our estimates were too low and there was additional money received during the budget year that that money would be used to pay unpaid bills. So far, we've done very, very well. We're going to be called upon to draft another budget starting next spring and what the Resolution says is that we will adopt a number that we will send along to the Governor and to the unions, advising them as to how much we are prepared to spend on collective bargaining agreements. My plan is that this Resolution, which has just been filed, will be referred to the House Revenue Committee. We'll call upon Chairman John Bradley to scheduled hearings, maybe this week, certainly next week, leading up to the second week of the Veto Session, when I would call upon the Members of the Revenue Committee to adopt the Resolution, insert a number in the Resolution, report it to the floor and then all of us can consider the work product of the Revenue Committee. The bottom line of all of this is that budget making for Illinois is going to continue to be extremely difficult. It's not going to get better, sooner. The tough work will continue and essential element of what we do in budget making is the cost of personal services. That cost will be set somewhat by the bargaining between the Governor and the unions. Now we have a choice. We can stand on the sidelines, let those people go off and do what they do, send us a bill or we can interject ourselves now and be present through negotiations so that our position is known and understood as those people are bargaining and preparing to send us a statement as to what it's going to cost the State of

Illinois and the taxpayers of this state and what it's going to cost us as we do our budget making. So our plan, again, refer this to the Revenue Committee. I would invite every Member of the House to join as a cosponsor of the Resolution. It's designed as a House Joint Resolution at request of Senate President John Cullerton suggested that we engage with the Senate in this project. So they also will be invited to participate, everyone's invited to participate in the hearings that Chairman Bradley will schedule. And we're going to notify all interested organizations to come forward and help us as we work to develop a good sound reliable estimate as to how much money we wish to spend on personnel cost in this proposed contract, which will last for approximately two and a half years. So, let's remember that, again, in the past, Governors and the unions would sign contracts that would go beyond the term of a Governor so the new Governor would come in office and be told, oh, by the way, your predecessor obligated you to 'x' amount of dollars in a collective bargaining agreement. The Legislature, not so long ago, provided that these contracts cannot go beyond the term of the Governor. So, what we're talking about is about a two and a half year obligation on spending. Well, I think the Legislature has a rightful place in bargaining that will occur. Thank you for your time and your attention. And again, everyone's welcome to join as a cosponsor and participate in the hearings. Thank you very much, Mr. Speaker."

Speaker Lyons: "Mr. Speaker, would you be willing to take

questions from a couple of Members?"

Madigan: "Sure."

Speaker Lyons: "Representative Roger Eddy."

Eddy: "Thank you. Mr. Speaker, just a couple of quick questions. In the Resolution itself there are references made to certain percentages. Those percentages reference cost of living as compared to actual increases and that kind of sets the stage for a percentage referred to as no more than 'x' percentage increase for wage increases. Is that a developing... obviously, a developing number that these... these hearings will help establish?"

Madigan: "Representative Eddy, that's... that's the purpose and I think a model to use would be what we did on the... the Resolution that's recited here which was House Resolution 110, I believe. But that was referred to the Revenue Committee and in the end there was an agreement in the Revenue Committee as to the number that would have been put into House Resolution 110. Let me add that after this was filed and in reading it this morning, in the first resolved clause we talk about wage increases. I think that when it's reported by the Revenue Committee we'll probably want to amend that and talk in terms of wage and benefit increases because it's wage and benefits that are considered in the bargaining."

Eddy: "The... the total cost of the package."

Madigan: "Correct. Yeah."

Eddy: "That... that... it would be. And... and so that 'x' percentage will kind of be the subject of some of the discussions and...

and as the hearings are held using as a guide the idea of the cost of living as it is calculated compared to what the increases were and then establishing, at least in the last paragraph, the policy of the state that the size of or reduction in the state employee workforce shall not be a topic of collective bargaining."

Madigan: "That's a... thank you, again, Mr. Eddy. And so, I think we all know that last fall why the Governor entered into a side agreement with AFSCME where he pledged that there would be no layoffs. My view which I think is supported by many people here in the House, is that the state should never agree to not reduce the workforce because the way we do business in State Government is that the Legislature gives authority to the Governor to spend money. Once there's a contract in place that sets the rate of pay, why, the only avenue for adjustment in a budget year is the size of the workforce. Governor Quinn gave that away. I don't think he should do that and that's why we recite in this Resolution that should not be done."

Eddy: "Thank you, Mr. Speaker. And I know the frustration because it was discussed several times in those budget hearings that based on the personnel line item and those restrictions that were part of a bargaining agreement the actual number then was something that was difficult to implement based on those side agreements. So, going forward the idea would be to make known that frustration and that... that as we move to some very difficult budget years that the intent of the General Assembly would be that those types of arrangements don't take place. Thank you."

Speaker Lyons: "Representative Dave Winters."

Winters: "Thank you Mr. Speaker. I would rise in support of this Resolution as the Speaker has eloquently stated this is an issue that we need to move forward. I would encourage all of you to sign on as cosponsors; you can see what happens if you don't. There is arm twisting in this state and I may be an example of somebody that has not always signed on to the Speaker's Bills, but I'm more than happy to this time. That's all I have."

Speaker Lyons: "Representative Al Riley."

Riley: "Sponsor yield?"

Speaker Lyons: "Sponsor awaits your questions."

Riley: "Mr. Speaker. I was going to... one of the previous speakers talked about what you had talked about the issue of adding benefits along with wages. Along those lines then, that's more or less a limiting factor? This Resolution just limits our involvement to wages and benefits and not any other conditions that might be part of the collective bargaining... collective bargaining agreement?"

Madigan: "Representative, there may be other elements in the agreement that I'm not recalling, so the idea is that we're concerned with the total package, the bottom line cost of the total package. And so, again, there may be some things I'm forgetting; my memory is, it's wages and benefits. Based ...the biggest benefit, of course, is the health insurance benefit."

Riley: "Okay. Thank you."

Speaker Lyons: "Speaker, any final thoughts? Speaker Madigan?"

Pihos: "Thank you, Mr. Speaker. I move to override the Governor's Veto on 1079. This is a Bill that has to do with reporting equipment items at universities valued in excess of a thousand dollars. This was a long negotiated Bill. It came out of a Blue Ribbon Committee on higher education. The original threshold was brought into line with the

That would be \$5 thousand and as a compromise in discussion with the committee, we brought it down to \$1 thousand and it passed unanimously out of all committees in the House of Senate and off the House Floor and the Senate Floor. RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-SEVENTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that there shall be submitted to the electors of the State for adoption or rejection at the general election next occurring at least 6 months after the adoption of this resolution a proposition to amend Article XIII of the Illinois Constitution by adding Section 5.1 as follows:

#### ARTICLE XIII

#### GENERAL PROVISIONS

#### SECTION 5.1. PENSION BENEFIT INCREASES

(a)A bill shall not become a law without the concurrence of three-fifths of the members elected to each house of the

General Assembly if that bill increases a benefit under any pension or retirement system of the State, any unit of local government or school district, or any agency or instrumentality thereof. However, if the Governor vetoes a bill so passed by returning it with his objections to the house in which it originated, then that bill shall not become law unless, upon its return, it is passed by a record vote of two-thirds of the members elected to each house of the General Assembly. Likewise, if the Governor returns a bill so passed with specific recommendations for change to the house in which it originated, then those recommendations may be accepted only by a record vote of two-thirds of the members elected to each house of the General Assembly. The provisions of this subsection (a) apply notwithstanding Article IV.

- (b) An ordinance, resolution, or other action of the governing body of any unit of local government or school district shall not be valid without the concurrence of three-fifths of the members of that governing body if that ordinance, resolution, or other action increases a benefit under any pension or retirement system for officials or employees of that unit of local government or school district, or any agency or instrumentality thereof.
- (c) For the purposes of this Section, a bill, ordinance, resolution, or other action increases a benefit if it increases the amount of an existing benefit, adds a new benefit, or expands the class of persons eligible for a benefit, regardless of whether it includes an increase in contributions or a reduction in any other benefit.

(d) For the purposes of this Section, an increase in salary does not, by itself, constitute an increase in benefits. However, the provisions of this Section do apply to (i) an increase in salary resulting from the inclusion of a new category of benefits, bonuses, incentives, perquisites, or other compensation that previously was not considered a part of salary or (ii) an otherwise unusually high increase in salary.

#### SCHEDULE
