- Clerk Hollman: "House Bill 5913, a Bill for an Act concerning criminal law. Second Reading of this House Bill. No Committee Amendments. No Floor Amendments. No Motions are filed."
- Speaker Lyons: "Third Reading. Representative Cunningham, two in a row. Bill 5921. Out of the record. 5922. Out of the record. Representative Sullivan on a very important announcement for the chamber."
- Sullivan: "Thank you, Mr. Speaker. Ladies and Gentlemen, we are all going to have this week off to enjoy our families. Some of us will be having some campaigns to maybe work on. When we come back, we will resume the festivities of all that is Irish with the 10th annual, and yes, it is now 10 years, Sullivan Caucus. So, on the 21st we're going to continue the celebration of all that is Irish at the Dublin Pub Vinegar Hill Mall with our annual party and fundraiser. So,

- Speaker Lyons: "Thank you, Representative. Representative Patti Bellock, on page 14 of the Calendar, you have House Bill 5641. Representative Bellock, House Bill 5641. Out of the record. All right, Ladies and Gentlemen, we're going to give one more bite at the apple on the Third Readings starting on page 17. So, if you have a Bill on Third Reading and you want it read, you want to move it, here's opportunity. We'll vour start on top of page 17. Representative Gordon. Representative Gordon on House Bill 1384. Out of the record. Representative Farnham, you have House Bill 1535. Out of the record. Representative Dan Burke, on Third Reading, you have House Bill 1964. - Speaker Lyons: "Representative Burke on House Bill 1964. Out of the record. Representative Mary Flowers, House Bill 2065, Mary. Out of the record. Leader Acevedo, House Bill 2912, Ed Acevedo. Out of the record. Representative Naomi Jakobsson, you have House Bill 3045. 3-0-4-5. Out of the record. Representative Mussman, House Bill 3506, Michelle. Out of the record. Representative Toni Berrios, Toni, on Third Reading you have 4096. 4-0-9-6. Read the Bill, Mr. Clerk."

Clerk Hollman: "House Bill 4096, a Bill for an Act concerning insurance. Third Reading of this House Bill."

Speaker Lyons: "Representative Toni Berrios."

- Berrios: "Thank you, Mr. Speaker and Ladies and Gentlemen of the House. House Bill 4096 is an agreed Bill and it's to just close a problem that's been happening in many communities throughout Illinois. People purchase a car and they get insurance so that they can drive the car out of the lot and when they... they're paying their premiums on time. When they get into an accident the insurance company cancels the policy because they find out... well, they say they just found out that the person didn't have a driver's license. It's an unfair practice and I want to close this loophole."
- Speaker Lyons: "You've heard the Lady's explanation. Is there any discussion. House... The Chair recognizes Representative Roger Eddy."
- Eddy: "Thank you... Mr. Speaker could we have... it's hard to hear."
- Speaker Lyons: "Ladies and Gentlemen of the House, we are running Third Reading Bills. Shh. Thank you very much. Representative Eddy."

Eddy: "Thank you, Mr. Speaker. Would the Sponsor yield?"

Speaker Lyons: "Sponsor yields."

Eddy: "Yeah, Representative, could you, again, capsulate what your intention is with this Bill. It was a little loud and I'm not sure all the Members heard exactly what your intent is here."

- Berrios: "I'm trying to close an unfair practice or deceptive act that's going on in many communities. Individuals purchase a car and you have to have insurance to drive that car out of the lot. The insurance is purchased and if that individual gets into a car accident, they file their claim with the insurance company and the insurance company then cancels the entire policy and doesn't pay out because they state they did not realize the individual didn't have a driver's license."
- Eddy: "So, basically' if I understand this, you're trying to require that an insurance company is not allowed to deny coverage to a driver if they don't have a driver's license?"
- Berrios: "They can deny coverage if they like, but many actually promote in their windows you don't need a driver's license to get insurance from us. So, I'm trying to close the deceptive act that's going on when they do that."
- Eddy: "So, is your language limited to those instances where companies specifically seek out and advertise to sell insurance to individuals who don't have a license. It's... it's specific to that. It's in the Bill?"

Berrios: "Yes."

- Eddy: "Could... And... and if they'd advertise that way, then they cannot deny for that reason. So, my question is why would they ever advertise in the first place to people who they're not going to sell to?"
- Berrios: "That's on the insurance company. I couldn't answer that question."

- Eddy: "Well, the concern I have is the practice at all of providing coverage to someone who doesn't have a driver's license. And if your Bill basically address that issue, I think it'd be a lot different Bill than it is because the way the Bill is written it appears as if that as long as the company advertises that they're going to sell insurance to someone without a driver's license they can go ahead a do that. I... I don't see any reason to allow companies to... to sell car insurance to someone who doesn't have a driver's license that isn't going to drive the car or operate the vehicle."
- Berrios: "It's... my Bill isn't addressing that. That's allowable under current law."
- Eddy: "Well and I think that's the point. That's the issue that your Bill would allow for a practice that would make eligible for insurance individuals who don't have a driver's license."
- Berrios: "We're focusing on consumer protections and trying to stop exploiting individuals."
- Eddy: "Representative, with all due respect and... and I understand that may be what your focusing on, but I think the unintended consequence of this would be that individuals who do not have a valid driver's license would be allowed to purchase insurance and it appears that really there's no good reason for that as far as documentation and... and safety. So, I would urge the Body at this time and... and unless until the real issue is addressed to... to vote 'no' on this legislation. And... and..."

Speaker Lyons: "Representative Osmond... Representative Eddy."

Eddy: "I also would ask that if this receives the requisite number of votes that a verification."

Speaker Lyons: "So noted, Representative. Representative Osmond."

Osmond: "Thank you, Mr. Speaker. Will the Sponsor yield?" Speaker Lyons: "Sponsor yields."

Osmond: "Representative, last year you had a Bill very similar to this and you worked on it very hard. What is the standing with the insurance industry right today."

Berrios: "They are in full support of this legislation."

Osmond: "Is the Department of Insurance also supportive of this?"

Berrios: "They've stayed neutral."

Osmond: "They're neutral, okay."

Berrios: "They're neutral."

Osmond: "And... the Illinois Insurance Association, did you not work with them to remove all opposition?"

Berrios: "Yes."

Osmond: "All right. I... I really think that there's some confusion on this. I know that Representative Berrios has worked with the insurance industry trying to resolve many of their issues. I will support this Bill. Thank you."

Berrios: "Thank you."

Speaker Lyons: "Representative Bob Pritchard."

Pritchard: "Thank you, Mr. Speaker. Would the Sponsor yield?" Speaker Lyons: "Sponsor yields."

Pritchard: "Representative, will this Bill if it becomes law..." Berrios: "Sorry about that."

Pritchard: "Representative, if this Bill becomes law and the driver of this vehicle has an accident with another driver, would this insurance company then be liable for making payment to that other driver?"

Berrios: "Yes, it would."

Pritchard: "Because there has been an issue where some insurance companies take the premium, but then when there's an accident, they refuse to make payment. And I've had a number of constituents call me with this issue wanting the Department of Insurance to be tough on these companies and they really don't have the standing to do that. So, if this moves us towards responsibility as our law requires for having insurance that covers an accident then I would support your Motion."

Berrios: "Thank you."

Speaker Lyons: "Representative Chuck Jefferson."

Jefferson: "Thank you, Mr. Speaker. Will the Sponsor yield?" Speaker Lyons: "Sponsor yields."

Jefferson: "Representative, from what I understand that you can buy insurance without having a driver's license because if you buy the insurance... if you buy the car, it doesn't matter that you've got insurance simply because the law does not require you to have a license, I don't think to own a car. Do they?"

Berrios: "That's correct."

Speaker Lyons: "Chuck... Chuck, excuse me, Leader, but I think that the Sponsor's indicated she's going to take this Bill out of the record. Perhaps you could have a conversation with her on your remaining questions. Unless you care..."

Out of the record. Representative Gaffney, you have House Bill 4523. Out of the record. Top of page 18, Representative Bradley, on the Order of Third Reading, you have House Bill 4697. - Clerk Hollman: "House Bill 4697, a Bill for an Act concerning regulation. Third Reading of this House Bill."

Speaker Lyons: "Representative Bradley."

- Bradley: "I have never presented a Bill with my assistants here. My sons Jackson and Gabriel Bradley have joined me today."
- Speaker Lyons: "Welcome to your Capitol, kids, glad to see your dad on the job."
- Bradley: "Currently, the department only has the ability to either deny or approve permits. This would give them more flexibility, allow modifications. I'd ask for an 'aye' vote."

- Speaker Lyons: "You've heard the Gentleman's explanation. Is there any discussion? Seeing none, all those in favor of the passage of House Bill 4697 signify by voting 'yes'; those opposed vote 'no'. The voting is open. Have all voted who wish? Have all voted who wish? Have all voted who wish? Mr. Clerk, take the record. On this Bill, there are 97 Members voting 'yes', 0 voting 'no'. This Bill, having received the Constitutional Majority, is hereby declared passed. Continuing on page 18, on Third Readings, we have ... Representative Berrios, you have House Bill 4707, Toni. Out of the record. Representative... Representative D'Amico, John, you have House Bill 5056 on Third Reading. Out of the record. Representative Costello, you have House Bill 5099 on Third Reading. Read the Bill, Mr. Clerk."
- Clerk Hollman: "House Bill 5099, a Bill for an Act concerning transportation. Third Reading of this House Bill."

Speaker Lyons: "Representative Costello."

- Costello: "Thank you, Mr. Speaker and Members of the House. House Bill 5099 requires that no person use a handheld wireless cell phone within 500 feet of an emergency scene. This also applies to digital photography and video. It's important to note: hands-free use is allowable, voice activated use on hands-free is allowable. You can also use a phone for the sole purpose of reporting emergencies and you could use your phone or a... or video while parked on the shoulder. I ask for an 'aye' vote. Thank you."
- Speaker Lyons: "You've heard the Gentleman's explanation. Any discussion? Chair recognizes the Gentleman from Cook, Representative Will Davis."

Davis, W.: "Thank you very much, Mr. Speaker. Will the Sponsor yield?"

Speaker Lyons: "Sponsor yields."

- Davis, W.: "Representative, I believe yesterday there was a lot of conversation about what in, I guess, an accident scene is or what designates that. So, there are times when we're driving on the highway and we may see a police or an emergency vehicle that's parked on the side with their lights on, either the yellow lights indicating caution or even sometimes the red and blue flashing lights, but when you drive past it, there's absolutely nothing else there. So, is that considered an accident scene with the emergency vehicle on the side and they have lights on but there's nothing else there?"
- Costello: "An... an emergency vehicle with its lights on, one or more vehicle, emergency vehicle having red or blue lights would be considered an emergency scene. As a police officer, past police officer myself, I think it's important to note that from an injury standpoint, outside of domestic batteries or responding to domestic abuse calls, most injuries happen on roadways when you're responding to traffic stop situations."
- Davis, W.: "Okay. So... but the answer to my question though is that anytime there is an emergency vehicle on the side or parked and they have any of there lights on where they're visible to traffic moving in both directions, regardless of what else is there, that is considered to be an accident scene."

- Costello: "It's considered to be an emergency scene because there are emergency vehicles with their lights activated. All this requires is that you either, if you're talking on a handheld phone, you put the phone down or it's on a speaker feature or it's... you're allowed to use a hands-free feature."
- Davis, W.: "Okay. Well, I think what you said is very important. So if you are on the phone and you approach that scene, if you put the phone, not end your call, but simply put the phone down so that's its no longer in your hand and continue to drive that that is acceptable under your Bill?"

Costello: It absolutely is, Representative."

Davis, W.: "Thank you very much."

Speaker Lyons: "Representative Roger Eddy."

Eddy: "Thank you. Will the Sponsor yield?"

Speaker Lyons: "Sponsor yields."

Eddy: "Representative Costello, is this a primary stop offense?"

Costello: "A primary stop offense?"

- Eddy: "Yeah. Is this... is it allowable that a police officer detain you and/or pull you over for this as the primary offense or... do you have to... is this ancillary to another stop?"
- Costello: "No, it would be a primary as... you're talking about like probable cause, primary stop. Absolutely."

Eddy: "Yeah."

Costello: "This is treated as a traffic violation."

Eddy: "And so it would count as a moving violation?"

Costello: "Correct."

- Eddy: "So, if... if you were stopped in traffic and you were sitting there for 15 minutes and there are... we are within 500 feet of a... of an emergency scene, as defined in your Bill, you would be guilty of this offense, if you're sitting in traffic?"
- Costello: "No, you would not, Representative and actually defined in the Bill, it does specifically say that if you are parked while in normal traffic or stopped while in normal traffic that that is left out of the Bill. So, it would not be against the law if you were parked or stopped in normal traffic to... to use your phone."
- Eddy: "So, what about the issue related to the video, taking a photo at an emergency scene, a picture of an accident, actually videotaping, not just a photo but an entire sequence of events. How does your Bill effect that?"
- Costello: "As far as videotaping while you're driving or the operator of the vehicle, you would not be able to do it within 500 feet of the emergency scene as that would be considered distractive driving."

Eddy: "But a passenger could... "

Costello: "And only to the operator. Obviously a passenger could video or photo."

Eddy: "...or if you are stopped."

- Costello: "Or if you are stopped, absolutely, Representative."
- Eddy: "Okay, Representative, I'm not sure this isn't duplicative of another Bill that we discussed and debated on the House Floor. How does this interact with the

legislation that we passed that Representative D'Amico sponsored?"

- Costello: "Obviously, if an all-out ban of handheld cell phones was enacted, this Bill would be null and void."
- Eddy: "Okay. There's nothing... there's nothing in this Bill that states that with the passage of other legislation that would provide for that outright ban that this would be null and void or repealed. Is that something you'd be willing to add to this?"
- Costello: "Well, I think it is important to note that... I don't believe Representative D'Amico's Bill does cover the digital photography or video. So, that... that would be something that would be different from his Bill, Representative."
- Eddy: "So, you'd have to change this in some manner if his Bill... because otherwise you could be cited for two offenses for the same action, the way this is written."

Costello: "I believe that's correct, Representative."

Eddy: "Okay. Well, that's one flaw that I see. I understand that you're trying to fix something here, but I think it's very, very complicated and... and until we have some coalition of all these concerns into something that's a little more consistent so that we're not going to have two different offenses for the same action, I would think that it'd be a prudent thing to hold back on this, have it available, but right now the way the Bill is constructed, I would urge everyone to vote 'no', hold this Bill and not create a double offense for the same action."

Speaker Lyons: "Representative Costello."

Costello: "Representative Eddy, I... I appreciate that. From a police officer protection standpoint, obviously, that's the way this Bill was constructed or written, an emergency responder protection standpoint. I would urge the passage of this Bill, in case Representative D'Amico's Bill would not pass."

Speaker Lyons: "Representative Moffitt."

Moffitt: "Thank you, Mr. Speaker. Will the Sponsor yield?" Speaker Lyons: "Sponsor yields."

Moffitt: "Representative, this would be a moving violation. Is that correct?"

Costello: "It's a traffic violation, correct. Treated just as any other traffic violation."

Moffitt: "Okay. And your explanation if you came upon a scene, you're talking on your phone, you come up on a scene, your still adequately away, you just lay your phone down, but... hope it wouldn't happen... but suppose you were involved in an accident. I would think the records would show, if they had to go to them the phone company, your phone would be in use, would be engaged, if you didn't... you know, if you didn't actually hang up but just lay it on down as you mention in your description. It would... from a record standpoint, it seems like it would show that you were talking on your phone. I mean, if you had an accident I'm not sure it would necessarily be, that anyone could observe it but the record would show you we're using the phone at the moment of the accident. Now... is... wouldn't that be a possibility or not?"

Costello: "It... it would and if you were using it on a blue tooth or a speaker phone feature, it's also going to show that you were on your phone, Representative. I agree."

- Moffitt: "And part of the reason that I'm... you know, I... I think everyone in this chamber wants to do things to help make it safer for everyone involved, for motorists, for the police officers, all they do for us... I mean, we need to do everything we can do to help them. But when... when we first banned cell phones in construction zones, I think the first time I came upon one I just laid my phone down and said to the person, hold on a minute, I'm going through a construction zone. You know, I thought after that the records would show that you're still talking. So, now, I mean, as I approach, I turn it off. I say, I've got to go, I'm on a construction zone. So, I think just laying it down wouldn't really be a defense or be able to comply with the intent here, maybe. So, that's the concern that I had."
- Costello: "Right and... and as I said earlier, if you lay your phone down while your... you know... when you approach the scene, you would be in compliance. I... I understand what you're saying but also if you were using blue tooth, talking through a speaker feature, you know, the records are going to show that you were on the phone, Representative."

Moffitt: "Yeah. Thank you for your response."

Speaker Lyons: "Representative Costello to close."

Costello: "Members of the House, I would like to... to close with one short story that I'll read to you real quick. A southside motorist who struck and seriously injured an Illinois

State Trooper on the Dan Ryan Expressway was distracted while using her cell phone. She even struck the officer although she was warned by her passenger. She was driving approximately 60 miles hour. an She admitted to investigators that she was traveling 60 miles an hour, on the cell phone, did not realize that the officer was there. The trooper was 29 years old. She ended up with a shattered pelvis, two broken legs, and a head contusion. She has a seven-year-old daughter. So, I would challenge anyone who has not been a police officer or done a traffic stop, pull over on the Dan Ryan Expressway, put your hazards on, step outside your car and see how safe you feel. When I say that, obliviously, it's a little tongue in cheek, I would hope no one would do it, but please put that in your mind. I ask for an 'aye' vote. Thank you."
