SYNOPSIS AS INTRODUCED:

105 ILCS 5/10-20.60 new 105 ILCS 5/14-1.09a 105 ILCS 5/34-18.53 new

from Ch. 122, par. 14-1.09a

Amends the School Code. Provides that it is the power of a school board to hire school social workers. Sets forth qualifications to use the title of "school social worker". Provides that school districts may employ a sufficient number of school social workers to address the needs of their students and schools and may maintain the nationally recommended student-to-school social worker ration of 250 to 1. Prohibits school social workers from providing services outside their employment to any student in the district or districts that employ the school social worker. Makes conforming changes. Effective immediately.

Be it enacted by the People of the State of Illinois, represented in the General Assembly:

- 4 Section 5. The School Code is amended by changing Section
- 5 14-1.09a and by adding Sections 10-20.60 and 34-18.53 as

14-1.09a. School social worker. "School Social Worker" means a social worker who has graduated with a master's or higher degree in social work from an accredited graduate school of social work and who has such additional qualifications as may be required by the State Board of Education and who holds a Professional Educator License with a school support personnel endorsement for school social work pursuant to Section 21B-25 School Service Personnel Certificate endorsed for school social work issued pursuant to Section 21-25 of this Code. Only persons Persons so licensed and endorsed certified may use the title "school social worker" and may offer school social work services as provided in this Code and other applicable laws and as which are limited to those services set forth in 23 Ill. Adm. Code 226, Special Education, pertaining to children between the ages of 3 to 21, promulgated by the State Board of Education, governing the

1 provision of special education and related services to children 2 with disabilities and requirements for the treatment of 3 children with disabilities between the ages of 3 and 21. School 4 social workers may make evaluations, recommendations or 5 interventions regarding the placement of 6 educational programs or special education classes. However, a school social worker shall not provide such services outside 7 8 his or her employment to any student in the district or 9 districts which employ such school social worker.

The board may employ school social workers who have graduated with a master's or higher degree in social work from an accredited graduate school of social work and have such additional qualifications as may be required by the State Board of Education and who hold a Professional Educator License with a school support personnel endorsement for school social work pursuant to Section 21B-25 of this Code. Only persons so licensed and endorsed may use the title "school social worker" and may offer school social work services.
