2 AMENDMENT NO. _____. Amend House Bill 2451 on page 4, line
3 20, by deleting "3,"; and

4 on page 4, line 21, after "10,", by inserting "11, 11a, 12,";
5 and

6 on page 13, by replacing lines 19 and 20 with the following:
7 "(20 ILCS 2505/2505-650). Except as provided in subsections (c)
8 and, (e), ~~(f)~~, ~~(g)~~, and ~~(h)~~ of this Section, money collected";
9 and

10 on page 22, line 1, by replacing "the amount" with "the sum of
11 the amount"; and

12 on page 22, by replacing lines 4 through 7 with the following:
13 "from the Income Tax Refund Fund during the fiscal year plus
14 the amount of such refund claims received but neither paid nor

1 denied as of the end of the fiscal year over the amount
2 collected pursuant to subsections (c) and (d) of Section 201 of
3 this Act deposited into the Income Tax Refund Fund during the
4 fiscal year."; and

5 on page 22, by replacing lines 13 through 16 with the
6 following:

7 "Income Tax Refund Fund as of the end of such fiscal year (such
8 surplus shall be net of the amount of refund claims received
9 but neither paid nor denied as of the end of the fiscal year);
10 excluding for fiscal years 2000, 2001, and 2002 amounts
11 attributable to transfers under item (3) of subsection (c) less
12 refunds resulting from the earned income tax credit."; and

13 on page 23, line 19, after "2015," by inserting "each month";
14 and

15 on page 23, line 20, by replacing "transfer" with "certify to
16 the State Comptroller and the State Treasurer"; and

17 on page 24, immediately below line 1, by inserting the
18 following:

19 "Upon receipt of the certification, the State Comptroller
20 shall order transferred and the State Treasurer shall transfer
21 those amounts from the General Revenue Fund to the Fund for the
22 Advancement of Education."; and

1 on page 24, line 7, after "2015," by inserting "each month";
2 and

3 on page 24, line 8, by replacing "transfer" with "certify to
4 the State Comptroller and the State Treasurer"; and

5 on page 24, immediately below line 15, by inserting the
6 following:

7 "Upon receipt of the certification, the State Comptroller
8 shall order transferred and the State Treasurer shall transfer
9 those amounts from the General Revenue Fund to the Commitment
10 to Human Services Fund."; and

11 by replacing everything from line 20 on page 24 through line 5
12 on page 25 with the following:

13 "(h) Transfers ~~Deposits~~ into the Tax Compliance and
14 Administration Fund. Beginning on the first day of the first
15 calendar month to occur on or after August 26, 2014 (the
16 effective date of Public Act 98-1098), each month the
17 Department shall certify to the State Comptroller and the State
18 Treasurer ~~pay into the Tax Compliance and Administration Fund,~~
19 ~~to be used, subject to appropriation, to fund additional~~
20 ~~auditors and compliance personnel at the Department,~~ an amount
21 equal to 1/12 of 5% of the cash receipts collected during the
22 preceding fiscal year by the Audit Bureau of the Department

1 from the tax imposed by subsections (a), (b), (c), and (d) of
2 Section 201 of this Act, net of deposits into the Income Tax
3 Refund Fund made from those cash receipts. Upon receipt of the
4 certification, the State Comptroller shall order transferred
5 and the State Treasurer shall transfer those amounts from the
6 General Revenue Fund to the Tax Compliance and Administration
7 Fund. Those moneys shall be used, subject to appropriation, to
8 fund additional auditors and compliance personnel at the
9 Department."; and

10 on page 186, line 17, by replacing "Sections 8-35, 17-20, and
11 17-40" with ""Sections 8-35 and 17-20"; and

12 on page 190, by deleting lines 12 through 21; and

13 on page 498, line 10, by deleting "3,"; and

14 on page 498, line 11, after "10,", by inserting "11, 11a, 12,".
