SYNOPSIS AS INTRODUCED:

50 ILCS 205/21 new 30 ILCS 805/8.41 new

Amends the Local Records Act. Provides that a unit of local government or school district that serves a population of less than 1,000,000 that maintains an Internet website other than a social media or social networking website shall post to its website for the current calendar year a mechanism, such as a uniform, single email address, for members of the public to electronically communicate with elected officials of that unit of local government or school district. Requires the information to be easily accessible from the unit of local government's or school district's home page through a hyperlink. Limits home rule powers. Amends the State Mandates Act to require implementation without reimbursement.

1 AN ACT concerning local government.

Be it enacted by the People of the State of Illinois, represented in the General Assembly:

- Section 5. The Local Records Act is amended by adding Section 21 as follows:

- 7 Sec. 21. Internet posting requirements.
- (a) A unit of local government or school district that 8 9 serves a population of less than 1,000,000 that maintains an Internet website other than a social media website or social 10 networking website shall, within 90 days of the effective date 11 12 of this amendatory Act of the 100th General Assembly, post to its website for the current calendar year a mechanism, such as 13 14 a uniform single email address, for members of the public to electronically communicate with elected officials of that unit 15 of local government or school district, unless such officials 16 have an individual email address for that purpose. 17
 - (b) For the purposes of this Section "Internet website" shall not include any social media website, social networking website, or any other social media presence that a unit of local government or school district maintains.
- 22 <u>(c) A hyperlink to the information required to be posted</u>
 23 <u>under this Section must be easily accessible from the unit of</u>

- 1 local government's or school district's home page.
- 2 (d) The postings required by this Section are in addition
- 3 to any other posting requirements required by law or ordinance.
- 4 (e) No home rule unit may adopt posting requirements that

- of this Act, no reimbursement by the State is required for the
- implementation of any mandate created by this amendatory Act of
