A BILL FOR

1 AN ACT concerning appropriations.

2 **Be it enacted by the People of the State of Illinois, represented**
3 **in the General Assembly:**

4 Section 5. The following named amounts, or so much thereof
5 as may be necessary, respectively, are appropriated to the
6 Court of Claims for its ordinary and contingent expenses:

1 Section 10. The amount of \$450,000, or so much thereof as
 2 may be necessary, is appropriated from the Court of Claims
 3 Administration and Grant Fund to the Court of Claims for
 4 administrative expenses under the Crime Victims Compensation
 5 Act.

6 Section 15. The following named amount, or so much thereof
 7 as may be necessary, is appropriated to the Court of Claims for
 8 payment of claims as follows:

9 For claims under the Crime Victims
 10 Compensation Act:

11 Payable from the Court of Claims

12 Federal Grant Fund\$10,000,000

13 Section 20. The amount of \$1,000,000, or so much thereof
 14 as may be necessary, is appropriated from the General Revenue
 15 Fund to the Court of Claims for payment of awards solely as a
 16 result of the lapsing of an appropriation originally made from
 17 any funds held by the State Treasurer.

18 Section 25. The amount of \$5,000,000, or so much thereof
 19 as may be necessary, is appropriated from the General Revenue
 20 Fund to the Court of Claims for payment of line of duty awards.

1 Section 30. The following named amounts, or so much thereof
 2 as may be necessary, are appropriated to the Court of Claims
 3 for payment of claims as follows:

4 For claims under the Crime Victims

5 Compensation Act:

6 Payable from General Revenue Fund\$6,000,000

7 For claims other than Crime Victims:

8 Payable from the General Revenue Fund9,807,400

9 Total\$15,807,400

10 Section 35. The following named amounts, or so much thereof
 11 as may be necessary, are appropriated to the Court of Claims
 12 for payment of claims as follows:

13 For claims other than the Crime Victims

14 Compensation Act:

15 Payable from the Road Fund\$1,000,000

16 Payable from the DCFS Children's

17 Services Fund1,500,000

18 Payable from the State Garage Fund50,000

19 Payable from the Traffic and Criminal

20 Conviction Surcharge Fund100,000

21 Payable from the Vocational

22 Rehabilitation Fund125,000

23 Total\$2,775,000

1 Section 40. The amount of \$1,000, or so much thereof as may
2 be necessary, is appropriated from the Court of Claims Federal
3 Recovery Victim Compensation Grant Fund to the Court of Claims
4 for refund to the federal government for the Federal Recovery
5 Victim Compensation Grant.

6 Section 99. Effective date. This Act takes effect July 1,
7 2018.
