2 AMENDMENT NO. \_\_\_\_\_. Amend Senate Bill 9, AS AMENDED, by  
3 inserting Articles 32 and 95 in their proper numeric sequence  
4 as follows:

5 "ARTICLE 32. LIMITED LIABILITY COMPANY ACT

6 Section 32-5. The Limited Liability Company Act is amended  
7 by changing Section 50-10 as follows:

9 (Text of Section before amendment by P.A. 99-637)

10 Sec. 50-10. Fees.

11 (a) The Secretary of State shall charge and collect in  
12 accordance with the provisions of this Act and rules  
13 promulgated under its authority all of the following:

14 (1) Fees for filing documents.

15 (2) Miscellaneous charges.

1           (3) Fees for the sale of lists of filings and for  
2           copies of any documents.

3           (b) The Secretary of State shall charge and collect for all  
4           of the following:

5           (1) Filing articles of organization (domestic),  
6           application for admission (foreign), and restated articles  
7           of organization (domestic), \$39 ~~\$500~~. Notwithstanding the  
8           foregoing, the fee for filing articles of organization  
9           (domestic), application for admission (foreign), and  
10          restated articles of organization (domestic) in connection  
11          with a limited liability company with ability to establish  
12          series pursuant to Section 37-40 of this Act is \$59 ~~\$750~~.

13          (2) Filing articles of amendment or an amended  
14          application for admission, \$150.

15          (3) Filing articles of dissolution or application for  
16          withdrawal, \$100.

17          (4) Filing an application to reserve a name, \$300.

18          (5) Filing a notice of cancellation of a reserved name,  
19          \$100.

20          (6) Filing a notice of a transfer of a reserved name,  
21          \$100.

22          (7) Registration of a name, \$300.

23          (8) Renewal of registration of a name, \$100.

24          (9) Filing an application for use of an assumed name  
25          under Section 1-20 of this Act, \$150 for each year or part  
26          thereof ending in 0 or 5, \$120 for each year or part

1           thereof ending in 1 or 6, \$90 for each year or part thereof  
2           ending in 2 or 7, \$60 for each year or part thereof ending  
3           in 3 or 8, \$30 for each year or part thereof ending in 4 or  
4           9, and a renewal for each assumed name, \$150.

5           (10) Filing an application for change or cancellation  
6           of an assumed name, \$100.

7           (11) Filing an annual report of a limited liability  
8           company or foreign limited liability company, \$250, if  
9           filed as required by this Act, plus a penalty if  
10          delinquent. Notwithstanding the foregoing, the fee for  
11          filing an annual report of a limited liability company or  
12          foreign limited liability company with ability to  
13          establish series is \$250 plus \$50 for each series for which  
14          a certificate of designation has been filed pursuant to  
15          Section 37-40 of this Act and active on the last day of the  
16          third month preceding the company's anniversary month,  
17          plus a penalty if delinquent.

18          (12) Filing an application for reinstatement of a  
19          limited liability company or foreign limited liability  
20          company \$500.

21          (13) Filing Articles of Merger, \$100 plus \$50 for each  
22          party to the merger in excess of the first 2 parties.

23          (14) Filing an Agreement of Conversion or Statement of  
24          Conversion, \$100.

25          (15) Filing a statement of change of address of  
26          registered office or change of registered agent, or both,

1 or filing a statement of correction, \$25.

2 (16) Filing a petition for refund, \$15.

3 (17) Filing any other document, \$100.

4 (18) Filing a certificate of designation of a limited  
5 liability company with the ability to establish series  
6 pursuant to Section 37-40 of this Act, \$50.

7 (c) The Secretary of State shall charge and collect all of  
8 the following:

9 (1) For furnishing a copy or certified copy of any  
10 document, instrument, or paper relating to a limited  
11 liability company or foreign limited liability company, or  
12 for a certificate, \$25.

13 (2) For the transfer of information by computer process  
14 media to any purchaser, fees established by rule.

13 for withdrawal, \$25.

14 (4) Filing an application to reserve a name, \$300.

15 (5) Filing a notice of cancellation of a reserved name,  
16 \$100.

17 (6) Filing a notice of a transfer of a reserved name,  
18 \$100.

19 (7) Registration of a name, \$300.

20 (8) Renewal of registration of a name, \$100.

21 (9) Filing an application for use of an assumed name  
22 under Section 1-20 of this Act, \$150 for each year or part  
23 thereof ending in 0 or 5, \$120 for each year or part  
24 thereof ending in 1 or 6, \$90 for each year or part thereof  
25 ending in 2 or 7, \$60 for each year or part thereof ending  
26 in 3 or 8, \$30 for each year or part thereof ending in 4 or

1 9, and a renewal for each assumed name, \$150.

6 filed as required by this Act, plus a penalty if  
7 delinquent. Notwithstanding the foregoing, the fee for  
8 filing an annual report of a limited liability company or  
9 foreign limited liability company is \$250 plus \$50 for each  
10 series for which a certificate of designation has been  
11 filed pursuant to Section 37-40 of this Act and is in  
12 effect on the last day of the third month preceding the  
13 company's anniversary month, plus a penalty if delinquent.

14 (12) Filing an application for reinstatement of a  
15 limited liability company or foreign limited liability  
16 company \$500.

17 (13) Filing articles of merger, \$100 plus \$50 for each  
18 party to the merger in excess of the first 2 parties.

19 (14) Filing articles of conversion, \$100.

20 (15) Filing a statement of change of address of  
21 registered office or change of registered agent, or both,  
22 or filing a statement of correction, \$25.

23 (16) Filing a petition for refund, \$15.

16 ARTICLE 95. NO ACCELERATION OR DELAY

17 Section 95-995. No acceleration or delay. Where this Act  
18 makes changes in a statute that is represented in this Act by  
19 text that is not yet or no longer in effect (for example, a  
20 Section represented by multiple versions), the use of that text  
21 does not accelerate or delay the taking effect of (i) the  
22 changes made by this Act or (ii) provisions derived from any  
23 other Public Act."
