## Be it enacted by the People of the State of Illinois, represented in the General Assembly:

ARTICLE 1

Section 5. The following named amounts, or so much thereof 5 6 as may be necessary, respectively, for the objects and purposes hereinafter named, are appropriated from the General Revenue 7 8 Fund to the Illinois Community College Board for ordinary and 9 contingent expenses: 10 11 For State Contributions to Social 12 13 14 15 For Commodities ......4,400 16 17 18 19

- 1 Section 10. The sum of \$1,080,000, or so much thereof as
- 2 may be necessary, is appropriated from the General Revenue Fund
- 3 to Illinois Community College Board for costs associated with
- 4 administering high school equivalency tests.
- 5 Section 15. The sum of \$2,800,000, or so much thereof as
- 6 may be necessary, is appropriated from the General Revenue Fund
- 7 to the Illinois Community College Board for grants to the
- 8 alternative schools network and other providers for educational
- 9 purposes or bridge programs.
- 10 Section 20. The sum of \$150,000 or so much thereof as may
- 11 be necessary, is appropriated from the General Revenue Fund to
- 12 the Illinois Community College Board for support of the P-20
- 13 Council.
- 14 Section 30. The sum of \$60,200, or so much thereof as may
- be necessary, is appropriated from the General Revenue Fund to
- the Illinois Community College Board for awarding scholarships
- 17 to qualifying graduates of the Lincoln's Challenge Program.
- Section 35. The sum of \$12,386,000, or so much thereof as
- 19 may be necessary, is appropriated from the General Revenue Fund
- 20 to the Illinois Community College Board for the City Colleges
- of Chicago for educational-related expenses.

Section 75. The sum of \$200,000, or so much thereof as may

- 1 be necessary, is appropriated from the High School Equivalency
- Testing Fund to the Illinois Community College Board for costs 2
- associated with administering high school equivalency tests. 3
- Section 80. The sum of \$12,500,000, or so much thereof as 4
- may be necessary, is appropriated from the Illinois Community 5
- College Board Contracts and Grants Fund to the Illinois 6
- Community College Board to be expended under the terms and 7
- 8 conditions associated with the moneys being received, including
- 9 prior year expenditures.
- 10 Section 85. The sum of \$525,000, or so much thereof as may
- 11 be necessary, is appropriated from the ICCB Federal Trust Fund
- 12 to the Illinois Community College Board for ordinary and
- contingency expenses of the Board. 13
- 14 Section 90. The sum of \$1,250,000, or so much thereof as
- 15 may be necessary, is appropriated from the ICCB Adult Education
- Fund to the Illinois Community College Board for operational 16
- 17 expenses associated with administration of adult education and
- 18 literacy activities.
- 19 Section 99. Effective Date. This Act takes effect July 1,
- 20 2018. Notwithstanding anything in this Act to the contrary,
- appropriations authorized in this Act shall be used for all 21

1 costs incurred prior to July 1, 2019.
