WHEREAS, Joseph McCormack opened his own dental practice in Westchester and Woodstock, practicing dentistry for 38 years; he was an active member of the Chicago Dental Society; and

WHEREAS, Joseph McCormack enjoyed family vacations, fly fishing, and enjoying the outdoors; he and his wife were longtime members of St. Mary Church in Woodstock and supporters of St. Mary Grade School and Marian Central Catholic High School in Woodstock; and
