6	(b) Subject to the provisions of the Comptroller's		
7	Procurement Rules, which shall be substantially in accordance		
8	with the requirements of the Illinois Procurement Code, the		
9	State Comptroller may:		
10	(1) enter into contracts relating to construction,		
11	reconstruction, or renovation projects for any such		
12	buildings or lands acquired under subsection (a); and		
13	(2) equip, lease, repair, operate, and maintain those		
14	grounds, buildings, and facilities as may be appropriate to		
15	carry out his or her statutory purposes and duties.		
16	(c) The State Comptroller may enter into agreements for the		
17	purposes of exercising his or her authority under this Section.		
18	(d) The exercise of the authority vested in the Comptroller		
19	to acquire property under this Section is subject to

21	(e) The Capital Facility and Technology Modernization Fund		
22	is hereby created as a special fund in the State treasury.		
23	Subject to appropriation, moneys in the Fund shall be used by		
24	the Comptroller for the purchase, reconstruction, lease,
