Amends the Illinois Vehicle Code. Provides that, with respect to the supporting documentation required to obtain a plate for a veteran with a disability, the Secretary of State shall allow an applicant to redact information on the documentation that pertains to the nature of the applicant's health issue. Effective immediately.

# Be it enacted by the People of the State of Illinois, represented in the General Assembly:

Section 5. The Illinois Vehicle Code is amended by changing
Section 3-609 as follows:

6 (625 ILCS 5/3-609) (from Ch. 95 1/2, par. 3-609)

Sec. 3-609. Plates for veterans with disabilities.

(a) Any veteran who holds proof of a service-connected 8 9 disability from the United States Department of Veterans Affairs, and who has obtained certification from a licensed 10 physician assistant, or 11 physician, advanced practice 12 registered nurse that the service-connected disability qualifies the veteran for issuance of registration plates or 13 14 digital registration plates or decals to a person with disabilities in accordance with Section 3-616, may, without the 15 payment of any registration fee, make application to the 16 17 Secretary of State for license plates for veterans with disabilities displaying the international symbol of access, 18 19 for the registration of one motor vehicle of the first 20 division, one motorcycle, or one motor vehicle of the second 21 division weighing not more than 8,000 pounds.

(b) Any veteran who holds proof of a service-connecteddisability from the United States Department of Veterans

Affairs, and whose degree of disability has been declared to be 1 2 50% or more, but whose disability does not qualify the veteran 3 for a plate or decal for persons with disabilities under Section 3-616, may, without the payment of any registration 4 5 fee, make application to the Secretary for a special registration plate or digital registration plate without the 6 international symbol of access for the registration of one 7 motor vehicle of the first division, one motorcycle, or one 8 9 motor vehicle of the second division weighing not more than 10 8,000 pounds.

(c) Renewal of such registration must be accompanied with documentation for eligibility of registration without fee unless the applicant has a permanent qualifying disability, and such registration plates or digital registration plates may not be issued to any person not eligible therefor. The Illinois Department of Veterans' Affairs may assist in providing the documentation of disability.

(d) The design and color of the plates shall be within the 18 discretion of the Secretary, except that the plates issued 19 20 under subsection (b) of this Section shall not contain the international symbol of access. The Secretary may, in his or 21 22 her discretion, allow the plates to be issued as vanity or 23 personalized plates in accordance with Section 3-405.1 of this Code. Registration shall be for a multi-year period and may be 24 25 issued staggered registration.

(e) Any person eligible to receive license plates under

1 this Section who has been approved for benefits under the 2 Senior Citizens and Persons with Disabilities Property Tax Relief Act, or who has claimed and received a grant under that 3 Act, shall pay a fee of \$24 instead of the fee otherwise 4 5 provided in this Code for passenger cars displaying standard 6 multi-year registration plates or digital registration plates issued under Section 3-414.1, for motor vehicles registered at 7 under Section 8 8,000 pounds or less 3-815(a), or for 9 recreational vehicles registered at 8,000 pounds or less under 10 Section 3-815(b), for a second set of plates under this 11 Section.

12 (f) With respect to the supporting documentation required 13 to obtain a plate under this Section, the Secretary shall allow 14 an applicant to redact information on the documentation that 15 pertains to the nature of the applicant's health issue.
