### SYNOPSIS AS INTRODUCED:

20 ILCS 3855/1-76 new  
220 ILCS 5/16-111.10 new  
305 ILCS 20/19 new

Amends the Illinois Power Agency Act, the Public Utilities Act, and the Energy Assistance Act. Provides that the Department of Commerce and Economic Opportunity, the Illinois Commerce Commission, and the Illinois Power Agency shall cooperate in issuing a report evaluating opportunities for electric utility customers' ability to participate in the State's clean energy economy. Provides for repeal of the provisions on January 1, 2021. Effective immediately.

2 **Be it enacted by the People of the State of Illinois,**  
3 **represented in the General Assembly:**

4 Section 5. The Illinois Power Agency Act is amended by  
5 adding Section 1-76 as follows:

6 (20 ILCS 3855/1-76 new)

7 Sec. 1-76. Study of access to Illinois clean energy  
8 economy. No later than June 30, 2020, the Agency shall, in  
9 cooperation with the Department of Commerce and Economic  
10 Opportunity and the Illinois Commerce Commission, issue a  
11 report evaluating opportunities for electric utility customers  
12 to participate in the State's clean energy economy.

13 This Section is repealed on January 1, 2021.

14 Section 10. The Public Utilities Act is amended by adding  
15 Section 16-111.10 as follows:

16 (220 ILCS 5/16-111.10 new)

17 Sec. 16-111.10. Study of access to Illinois clean energy  
18 economy. No later than June 30, 2020, the Commission shall, in  
19 cooperation with the Department of Commerce and Economic  
20 Opportunity and the Illinois Power Agency, issue a report  
21 evaluating opportunities for electric utility customers to

1 participate in the State's clean energy economy.

2 This Section is repealed on January 1, 2021.

3 Section 15. The Energy Assistance Act is amended by adding  
4 Section 19 as follows:

5 (305 ILCS 20/19 new)

6 Sec. 19. Study of access to Illinois clean energy economy.

7 No later than June 30, 2020, the Department shall, in  
8 cooperation with the Illinois Commerce Commission and the  
9 Illinois Power Agency, issue a report evaluating opportunities  
10 for electric utility customers to participate in the State's  
11 clean energy economy.

12 This Section is repealed on January 1, 2021.

13 Section 99. Effective date. This Act takes effect upon  
14 becoming law.
