1 AMENDMENT TO SENATE BILL 447

2 AMENDMENT NO. _____. Amend Senate Bill 447 by replacing
3 everything after the enacting clause with the following:

4 "Section 5. The Department of Public Health Powers and
5 Duties Law of the Civil Administrative Code of Illinois is
6 amended by changing Section 2310-220 as follows:

7 (20 ILCS 2310/2310-220) (was 20 ILCS 2310/55.73)

8 Sec. 2310-220. Findings; rural obstetrical care. The
9 General Assembly finds that substantial areas of rural Illinois
10 lack adequate access to obstetrical care. The primary cause of
11 this problem is the absence of qualified practitioners who are
12 willing to offer obstetrical services. A significant barrier to
13 recruiting and retaining those practitioners is the high cost
14 of professional liability insurance for practitioners offering
15 obstetrical care.

16 Therefore, the Department, from funds appropriated for

1 that purpose, shall award grants to physicians practicing
2 obstetrics in rural designated shortage areas, as defined in
3 Section 3.04 of the Underserved Physician Workforce Family
4 ~~Practice Residency~~ Act, for the purpose of reimbursing those
5 physicians for the costs of obtaining malpractice insurance
6 relating to obstetrical services. The Department shall
7 establish reasonable conditions, standards, and duties
8 relating to the application for and receipt of the grants.

11 changing the title of the Act and Sections 1, 2, 3.03, 3.06,
12 3.07, 3.09, 4.01, 4.02, 4.07, 4.10, 4.11, 5, 6, and 9 and by
13 adding Section 3.10 as follows:

15 An Act to provide grants for primary care and other family
16 ~~practice~~ residency programs, and medical student scholarships,
17 and loan repayment assistance through the Illinois Department
18 of Public Health.

20 Sec. 1. This Act shall be known and may be cited as the
21 Underserved Physician Workforce Act ~~"Family Practice Residency~~
22 ~~Act"~~.

2 Sec. 2. The purpose of this Act is to establish programs in
3 the Illinois Department of Public Health to upgrade ~~primary~~
4 health care services for all citizens of the State, to increase
5 access, and to reduce health care disparities by providing
6 grants to ~~family practice and preventive medicine~~ residency
7 programs, scholarships to medical students, and a loan
8 repayment program for ~~physicians and other~~ eligible health
9 ~~primary~~ care providers who will agree to practice in areas of
10 the State demonstrating the greatest need for more professional
11 medical care. The programs shall encourage ~~family practice~~
12 ~~physicians and other~~ eligible health care ~~primary care~~
13 providers to locate in areas where health manpower shortages
14 exist and to increase the total number of ~~family practice~~
15 ~~physicians and other~~ eligible health care ~~primary care~~
16 providers in the State.

6 Sec. 3.07. "Eligible medical student" means a person who
7 meets all of the following qualifications:

8 (a) he or she is an Illinois resident at the time of
9 application for a scholarship under the program
10 established by this Act;

11 (b) he or she is studying medicine in a medical school
12 located in Illinois;

13 (c) he or she exhibits financial need as determined by
14 the Department; and

15 (d) he or she agrees to practice full-time in a
16 Designated Shortage Area as a primary care physician,
17 general surgeon, emergency medicine physician, or
18 obstetrician one year for each year he or she is a
19 scholarship recipient.

2 ~~providers within specialties determined to be eligible by the~~
3 ~~U.S. Health Resources and Services Administration for the~~
4 ~~National Health Service Corps Loan Repayment Program.~~

7 Sec. 3.10. Primary care physician."Primary care physician"
8 means a general internist, family physician, or general
9 pediatrician.

10 (110 ILCS 935/4.01) (from Ch. 144, par. 1454.01)

11 Sec. 4.01. To allocate funds to ~~family practice~~ residency
12 programs according to the following priorities:

13 (a) to increase the number of eligible health care
14 providers ~~family practice physicians~~ in Designated
15 Shortage Areas;

16 (b) (blank); ~~to increase the percentage of~~
17 ~~obstetricians establishing practice within the State upon~~
18 ~~completion of residency;~~

19 (c) to increase the number of accredited, eligible
20 health care provider ~~family practice~~ residencies within
21 the State;

22 (d) to increase the percentage of eligible health care
23 providers ~~family practice physicians~~ establishing practice
24 within the State upon completion of residency; and

1 (e) to provide funds for rental of office space,
2 purchase of equipment, and other uses necessary to enable
3 eligible health care providers ~~family practitioners~~ to
4 locate their practices in communities located in
5 designated shortage areas.

8 Sec. 4.02. To determine the procedures for the distribution
9 of the funds to ~~family practice~~ residency programs, including
10 the establishment of eligibility criteria in accordance with
11 the following guidelines:

12 (a) preference for programs which are to be established
13 at locations which exhibit potential for extending
14 eligible health care provider ~~family practice physician~~
15 availability to Designated Shortage Areas;

16 (b) preference for programs which are located away from
17 communities in which medical schools are located; and

18 (c) preference for programs located in hospitals
19 having affiliation agreements with medical schools located
20 within the State.

21 In distributing such funds, the Department may also
22 consider as secondary criteria whether a ~~family practice~~
23 residency program has:

24 (1) Adequate courses of instruction in the behavioral
25 sciences;

1 (2) Availability and systematic utilization of
2 opportunities for residents to gain experience through
3 local health departments or other preventive or
4 occupational medical facilities;

5 (3) A continuing program of community-oriented
6 research in such areas as risk factors in community
7 populations, immunization levels, environmental hazards,
8 or occupational hazards;

9 (4) Sufficient mechanisms for maintenance of quality
10 training, such as peer review, systematic progress
11 reviews, referral system, and maintenance of adequate
12 records; and

13 (5) An appropriate course of instruction in societal,
14 institutional, and economic conditions affecting a rural
15 health care ~~family~~ practice.

19 program established under this Act with the program
20 administered by the Illinois Board of Higher Education under
21 the "Health Services Education Grants Act".

24 Sec. 4.10. To establish programs, and the criteria for such

1 programs, for the repayment of the educational loans of ~~primary~~
2 ~~care physicians and other~~ eligible health ~~primary~~ care
3 providers who agree to serve in Designated Shortage Areas for a
4 specified period of time, no less than 2 years. Payments under
5 this program may be made for the principal, interest, and
6 related expenses of government and commercial loans received by
7 the individual for tuition expenses, and all other reasonable
8 educational expenses incurred by the individual. Payments made
9 under this provision shall be exempt from Illinois State Income
10 Tax. The Department may use tobacco settlement recovery funding
11 or other available funding to implement this Section.

15 seeking grants under this Act to make application according to
16 procedures consistent with the priorities and guidelines
17 established in Sections 4.01 and 4.02 of this Act.

20 Sec. 5. The Advisory Committee for ~~Family Practice~~
21 Residency Programs is created and shall consult with the
22 Director in the administration of this Act. The Committee shall
23 consist of 9 members appointed by the Director, 4 of whom shall
24 be eligible health care providers ~~family practice physicians,~~

1 one of whom shall be the dean or associate or deputy dean of a
2 medical school in this State, and 4 of whom shall be
3 representatives of the general public. Terms of membership
4 shall be 4 years. Initial appointments by the Director shall be
5 staggered, with 4 appointments terminating January 31, 1979 and
6 4 terminating January 31, 1981. Each member shall continue to
7 serve after the expiration of his term until his successor has
8 been appointed. No person shall serve more than 2 terms.
9 Vacancies shall be filled by appointment for the unexpired term
10 of any member in the same manner as the vacant position had
11 been filled. The Committee shall select from its members a
12 chairman from among the eligible health care provider ~~family~~
13 ~~practice physician~~ members, and such other officers as may be
14 required. The Committee shall meet as frequently as the
15 Director deems necessary, but not less than once each year. The
16 Committee members shall receive no compensation but shall be
17 reimbursed for actual expenses incurred in carrying out their
18 duties.

21 Sec. 6. Residency ~~Family practice residency~~ programs
22 seeking funds under this Act shall make application to the
23 Department. The application shall include evidence of local
24 support for the program, either in the form of funds, services,
25 or other resources. The ratio of State support to local support

1 shall be determined by the Department in a manner that is
2 consistent with the purpose of this Act as stated in Section 2
3 of this Act. In establishing such ratio of State to local
4 support, the Department may vary the amount of the required
5 local support depending upon the criticality of the need for
6 more professional health care services and the geographic
7 location and the economic base of the Designated Shortage Area.

10 Sec. 9. The Department shall annually report to the General
11 Assembly and the Governor the results and progress of the
12 programs established by this Act on or before March 15th.

13 The annual report to the General Assembly and the Governor
14 shall include the impact of programs established under this Act
15 on the ability of designated shortage areas to attract and
16 retain eligible physicians and other health care providers
17 ~~personnel~~. The report shall include recommendations to improve
18 that ability.

19 The requirement for reporting to the General Assembly shall
20 be satisfied by filing copies of the report as required by
21 Section 3.1 of the General Assembly Organization Act, and
22 filing such additional copies with the State Government Report
23 Distribution Center for the General Assembly as is required
24 under paragraph (t) of Section 7 of the State Library Act.

3 repealing Section 7.

4 Section 20. The Nurses in Advancement Law is amended by
5 changing Section 1-20 as follows:

6 (110 ILCS 970/1-20) (from Ch. 144, par. 2781-20)

7 Sec. 1-20. Scholarship requirements. It shall be lawful for
8 any organization to condition any loan or grant upon the
9 recipient's executing an agreement to commit not more than 5
10 years of his or her professional career to the goals
11 specifically outlined within the agreement including a
12 requirement that recipient practice nursing or medicine in
13 specifically designated practice and geographic areas.

14 Any agreement executed by an organization and any recipient
15 of loan or grant assistance shall contain a provision for
16 liquidated damages to be paid for any breach of any provision
17 of the agreement, or any commitment contained therein, together
18 with attorney's fees and costs for the enforcement thereof. Any
19 such covenant shall be valid and enforceable in the courts of
20 this State as liquidated damages and shall not be considered a
21 penalty, provided that the provision for liquidated damages
22 does not exceed \$2,500 for each year remaining for the
23 performance of the agreement.

1 This Section shall not be construed as pertaining to or
2 limiting any liquidated damages resulting from scholarships
3 awarded under the Underserved Physician Workforce ~~Family~~
4 ~~Practice Residency~~ Act.

6 Section 25. The Private Medical Scholarship Agreement Act
7 is amended by changing Section 3 as follows:

8 (110 ILCS 980/3) (from Ch. 144, par. 2703)

9 Sec. 3. Any such agreement executed by such an organization
10 and any recipient of loan, grant assistance or recommendation
11 may contain a provision for liquidated damages to be paid for
12 any breach of any provision of the agreement, or any commitment
13 contained therein, together with attorney's fees and costs for
14 the enforcement thereof. Any such covenant shall be valid and
15 enforceable in the courts of this State as liquidated damages
16 and shall not be considered a penalty, provided that such
17 provision for liquidated damages does not exceed \$2,500 for
18 each year remaining for the performance of such agreement.

19 This Section shall not be construed as pertaining to or
20 limiting any liquidated damages resulting from scholarships
21 awarded under the Underserved Physician Workforce ~~"Family~~
22 ~~Practice Residency Act"~~, as amended.

2 changing Section 12-4.24a as follows:

4 Sec. 12-4.24a. Report and recommendations concerning
5 designated shortage area. The Illinois Department shall
6 analyze payments made to providers of medical services under
7 Article V of this Code to determine whether any special
8 compensatory standard should be applied to payments to such
9 providers in designated shortage areas as defined in Section
10 3.04 of the Underserved Physician Workforce ~~Family Practice~~
11 ~~Residency Act, as now or hereafter amended.~~ The Illinois
12 Department shall, not later than June 30, 1990, report to the
13 Governor and the General Assembly concerning the results of its
14 analysis, and may provide by rule for adjustments in its
15 payment rates to medical service providers in such areas.
