18	Section 20. The amounts appropriated for repairs and
19	maintenance, and other capital improvements in Section 10 for
20	repairs and maintenance, roof repairs and/or replacements and
21	miscellaneous capital improvements at the Department's various
22	institutions are to include construction, reconstruction,

improvements, repairs and installation of capital facilities,

costs of planning, supplies, materials and all other expenses

- 1 required for roof and other types of repairs and maintenance,
- 2 capital improvements, and purchase of land.
- 3 No contract shall be entered into or obligation incurred
- 4 for repairs and maintenance and other capital improvements from
- 5 appropriations made in Section 10 of this Article until after
- 6 the purpose and amounts have been approved in writing by the
- 7 Governor.
- 8 Section 25. The sum of \$10,000, or so much thereof as may
- 9 be necessary, is appropriated to the Department of Juvenile
- 10 Justice from the General Revenue Fund for costs and expenses
- 11 associated with payment of statewide hospitalization.
- 12 Section 30. The amount of \$268,500, or so much thereof as
- may be necessary, is appropriated from the General Revenue Fund
- 14 to the Department of Juvenile Justice for the purposes of
- investigating complaints, evaluating policies and procedures,
- and securing the rights of the youth committed to the Department
- 17 of Juvenile Justice, including youth released on Aftercare
- 18 before final discharge.
- 19 Section 35. The amount of \$75,000, or so much thereof as
- 20 may be necessary, is appropriated from the General Revenue Fund
- 21 to the Department of Juvenile Justice for costs associated with

- 1 positive behavior interventions and supports.
- 2 Section 40. The amount of \$500,000, or so much thereof as
- 3 may be necessary, is appropriated from the General Revenue Fund
- 4 to the Department of Juvenile Justice for costs and expenses
- 5 associated with Shared Services.
- 6 Section 99. Effective Date. This Act takes effect July 1,
- 7 2019.
