Re: Certification of projected contributions to the Community College Health Insurance Security Fund for State Fiscal Year 2022

Dear Governor Pritzker, Comptroller Mendoza and Ms. Forde:

As required by Section 6.10 of the State Employees Group Insurance Act of 1971, the Board of Trustees of the State Universities Retirement System has certified the projected contributions for State Fiscal Year 2022 to the Community College Health Insurance Security Fund.

This amount is calculated by taking the annual projected payroll for all community college employees eligible to receive full-time benefits, as provided by the Illinois Community College Board, and multiplying the projected payroll by the required contribution rate of 0.5%. The Illinois Community College Board has advised the system that the projected payroll for State Fiscal Year 2022 is \$957,645,153.

Section 6.10 of the State Employees Group Insurance Act of 1971 requires that the certified amount be either decreased or increased by the amount that the actual active employee contributions either fell short of or exceeded the estimate used by the Board in making the certification the previous fiscal year. Below is a table reflecting this calculation.
