UTILIZATION SUMMARY | ILLINOIS-BASED FIRMS

FUND HIGHLIGHTS

- As of December 31, 2020, the Total Fund¹ was valued at \$12.7 billion. Of this, 17.0%, or \$2.2 billion was managed by Illinois-based investment managers (vs. 17.2% and \$2.0 billion in 2019).
 - The Cook County Fund invested 17.2% or \$2.1 billion with Illinois-based managers.
 - The Forest Preserve Fund invested 6.7% or \$15.0 million with Illinois-based managers.

ASSET ALLOCATION HIGHLIGHTS

- In 2020, Illinois-based investment manager utilization decreased for domestic equity and international equity but increased for alternatives.
- The decline in utilization for domestic and international equity was due to the loss of two managers as a result of the closure
 of Progress Investment Management, a Fund-of-Fund manager. Alternatives utilization increased primarily from higher private
 equity valuations.

MANAGER UTILIZATION | BY FUND

Illinois-based investment managers represented 17.0% of all assets managed as of December 31, 2020. Utilization was marginally lower compared to the prior year due to reallocation from Illinois managers from the former Progress portfolio and market value changes, but partially offset by increased valuation of private equity investments.







TOTAL FUND IL UTILIZATION BY ASSET CLASS

Allocations to Illinois-based investment managers declined marginally for domestic equity and international equity due to market value changes that were smaller relative to the increase of the total fund.

TREND HIGHLIGHTS

Domestic Equity

 The loss of Martin Inv. Mgmt from the Progress (manager – of-manager) closure was offset by \$73 million of IL-manager market value gains. However the full portfolio increased by \$602 million.

International Equity

 The loss of Ativo Cap. Mgmt from the Progress closure and market value gains for non-IL managers reduced utilization.

Fixed Income

• Fixed income utilization was unchanged at 0%.

Alternatives

 Higher valuations for private equity (Mesirow, Muller & Monroe) and real estate (LaSalle, Mesirow), coupled with new IL hedge fund managers in the Blackstone portfolio increased IL utilization by \$220 million.

ILLINOIS MANAGER UTILIZATION | ALTERNATIVES



- Illinois-based investment managers represented:
 - 9.7% of all real estate assets managed (an increase of 1.3% due to higher valuations for Mesirow Financial and LaSalle Investment Management)
 - 100.0% of all private equity assets managed
 - **0.1%** of the total hedge fund of funds allocation, up from 0.0% in 2019 due to new allocations.
- As a general practice, the Fund no longer invests directly in real estate properties, hedge fund holdings nor private equity funds. The Fund's active interests in these strategies are sub-advised in a fund-of-funds arrangement.

- Equity commission dollars and bond volume decreased from 2019, due to the merger of Williams Capital into the non-Illinois firm Siebert Williams Shank & Co, LLC
