#### STATEMENT OF LEGISLATIVE MANDATE

This document was prepared by the Illinois State Police (ISP) and is submitted to the Illinois General Assembly pursuant to 725 ILCS 5/108A-11(c) of the Illinois Compiled Statues. Please contact the ISP Electronic Criminal Surveillance Officer (ECSO) program coordinator, Division of Criminal Investigation, if you require further information.

#### **EXECUTIVE SUMMARY**

Of the 102 Illinois counties, 46 filed their 2020 eavesdropping report with the ISP. Twenty-three of the counties reported no eavesdrops were applied for in their jurisdiction. The following page lists the counties reporting no applications, as well as those failing to file a report. The statute requires each state's attorney to file a report with the ISP; however, 56 counties failed to file a report by the given deadline. Historically, several counties do not submit their report or fail to submit it before the deadline.

The report shows a total of 262 eavesdrop applications were submitted in 2020. Of these, 243 were original applications and 19 were extensions. The below list depicts the types of crimes investigated utilizing eavesdrops:

#### **INTRODUCTION**





# 2020 CONSENSUAL EAVESDROPS TYPES OF ORDERS




