## Introduction

The Illinois Angel Investment Tax Credit Program is designed to encourage interested firms or individuals to make investments in Illinois' innovative businesses. The investments encourage job growth and expand capital investment in Illinois. The Program can offer tax credits to qualified investors in an amount equal to 25% of their investment made directly in a Qualified New Business Venture (QNBV). The maximum amount of tax credits to be issued under the Act is \$10,000,000 per calendar year. While the Program was initially to be administered for the taxable years beginning after December 31, 2010 and ending on or before December 31, 2021, the Program was extended in 2021 to end on or before December 31, 2026.

The Program has two components of participation: (i) a business component and (ii) an investor component. Interested Illinois businesses must apply to DCEO each taxable year for which the business desires registration. If deemed eligible, the business can direct investors to apply for tax credits. Investors for eligible businesses must submit an application to DCEO in order to be considered for a tax credit. To receive a credit, investors must (i) invest in the eligible business after the business has been deemed eligible and within the same calendar year, (ii) submit an executed application (which conforms to the Program's requirements) and (iii) certify to keep their investment in the qualified new business venture for no less than 3 years.

## Overview

Operational efficiencies such as digital applications, automated submission confirmations and publicly shared schedules implemented by the Department have greatly improved the customer experience for both businesses and investors.

All \$10,000,000.00 in tax credits were utilized in 2021 which allowed the Department to leverage \$40,214,467.44 in private investments for innovative, early-stage businesses across the State of Illinois.

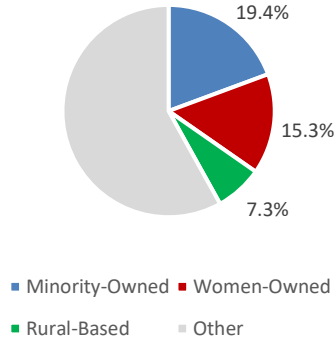
Additionally, the Department continues to make concerted efforts, such as outreach to various organizations and businesses about the program and providing webinars to highlight businesses, to reduce the equity gap.

2020 marked the first year the Department began tracking minority-, women- and persons with a disability-owned businesses separately in order to create more visibility into the equity of the program. Prior to this, the only measure tracked was businesses who were any of the above. 2021 marked the first year the Department began tracking ownership by race/ethnicity in addition to the metrics above.

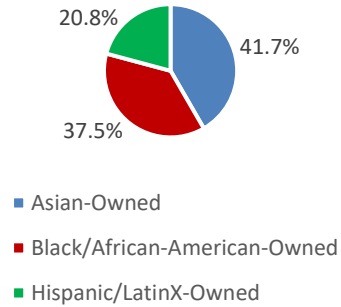

## Effectiveness of the Program

Since 2011, the Angel Investment Tax Credit Program has aided in the placement of over \$365,544,211 in investments into early-stage, innovative businesses throughout Illinois which provided \$91,310,000 in tax credits for 2,470 investments.
