Executive Summary

During Fiscal Year 2021, the Business Enterprise Program for Minorities, Females, and Persons with Disabilities Program (BEP) was managed by the Central Management Services of the State of Illinois (CMS). On January 1, 2022, the BEP program was removed from CMS and merged into the Commission on Equity and Inclusion (CEI) pursuant to 30 ILCS 575/4f(4).

As the COVID-19 crisis continued throughout Fiscal Year 2021, BEP continued its efforts to increase procurement access and opportunities for disadvantaged entrepreneurs. Through engagement and collaboration with State agencies, institutions of higher education, community colleges, the BEP vendor community, and other stakeholders, the State of Illinois sought to expand the Program's impact through increased participation in State contracting opportunities.

Fiscal & Program Accomplishments

The Business Enterprise Program set several records during Fiscal Year 2021. A BEP certified business is defined as a business which is at least 51% owned by one or more minority persons, one or more women, and/or one or more persons with a disability and the management and daily business operations of which are controlled by those persons. The Program staff increased the number of certified BEP vendors by 42%, thereby providing the State with a larger pool of certified BEP vendors eligible to participate in state contracts. Additionally, BEP set a new record by increasing the number of BEP certified vendors awarded contracts by 11%. Fiscal Year 2021 represents the largest number of BEP certified vendors involved in State procurements with a total of 1,245 BEP vendors participating in the State's procurement process. Moreover, through BEP's efforts, the State of Illinois spent \$885,489,466 with BEP certified vendors, representing an increase of 22% compared to the spend in Fiscal Year 2020.

BEP assessed the State's prior performance and determined that a new goal setting methodology was necessary. The new methodology allows the State to set more feasible BEP goals. The BEP goal is set by taking the number of BEP certified vendors registered in the commodity codes related to the scope of work and dividing it by the total number of vendors in the commodity codes related to the scope of work to determine the percentage of BEP vendor availability (BEP Vendors / All Vendors). The new formula change will positively impact goal setting and increase opportunity for BEP vendors going forward.

Operational Accomplishments

Compliance

The Compliance Unit launched numerous statewide trainings on the new goal setting methodology internally and externally. Compliance also conducted statewide vendor outreach trainings to assist bidding BEP vendors in the state procurement's Utilization Plan process. These trainings have demonstrated an increase in the number of responsive Utilization Plans submitted by BEP vendors.

Fiscal Year 2021 also marks the first year of BEP vendor expenditure reporting by the State's Community Colleges. In step with agencies and public institutions of higher education, community colleges are now submitting annual Compliance Plans and BEP expenditures to Compliance staff for inclusion in the BEP Annual Expenditure Report.

Compliance also established new transparency in reporting, thereby housing all the required reporting documentation on the website for effectiveness.

Certification

BEP's Certification Unit has successfully certified 3,265 companies by the closed of Fiscal Year 2021. The BEP vendor base has increased through the Program staff's targeted email campaign, virtual office hours, and webinars to potential vendors across the State of Illinois. The FY21 certification totals reflect an additional 969 firms, or a 42% increase of certified entities added to our BEP vendor based since FY20.

To highlight some significant gains in FY21, the total certified African Americans were 1,191, increasing 57% from FY20. Similarly, certified Hispanic Americans increased in FY21 with 511 vendors, an increase of 42% from FY20.

The Certification Team will continue their work toward a larger vendor pool by identifying ways to infuse equity into certification processes.

Outreach

The BEP Outreach Unit participated in 75 virtual events during the first half of Fiscal Year 2021. From January 2021 through the remainder of the fiscal year, there were no staff to perform the responsibilities of Outreach Unit. As of November 2021, BEP welcomed one new staff member to Outreach with the remaining positions to be filled very soon. Under the leadership of the Commission on Equity and Inclusion, the new Outreach team will work closely with the Mentor Protégé Program as they connect with new partners and deliver resources and opportunity to BEP vendors.

Mentor Protégé Program

Through the efforts of the BEP Outreach Unit, the Capacity Building Mentor Protégé Program has been established in Fiscal Year 2021 by BEP. The Mentor Protégé Program has hired a Mentor Protégé Program Manager who is assisting with program development and implementation. During Fiscal Year 2021, the program rolled out its pilot Mentor Protégé agreement. The Program will continue to grow its efforts of expanding and reaching BEP Certified vendors by collaborating with BEP Outreach to connect those vendors with experienced firms who will provide various types of support to create equitable access for economic growth while meeting the State's BEP contracting goals. Throughout FY21 and FY22 the Mentor Protégé Program's mission is to create capacity and growth opportunities for emerging and scaling vendors within the Business Enterprise Program.

Outlook for Fiscal Year 2022

The Business Enterprise Program is committed to providing quality programs and service with excellence. While BEP had some significant gains in Fiscal Year 2021, the Program staff recognizes that there is much work to be completed with respect to expanding BEP participation on State contracts and is committed to implementing the changes necessary to seeing it ensue. BEP is promoting economic advancement for Minorities, Women and Persons with Disabilities and values how significant our work is for the success of communities in the State of Illinois. The Business Enterprise Program is aggressively moving towards growth in 2022 under the new Commission on Equity and Inclusion.
