If the General Assembly fails to disapprove any waiver request or appealed request within such 60 day period, the waiver or modification shall be deemed granted. Any resolution adopted by the General Assembly disapproving a report of the State Board in whole or in part shall be binding on the State Board.

- 4. Narrative identifying and justifying the specific request.
- 4. a. i) The intent of this waiver is to permit Dalzell District #98 to charge a tuition fee less the 110% of the per capita tuition charge for non-resident children due to proximity, safety and educational reasons. It would be the sole discretion of the Board of Directors to annually set the tuition rate and approve applications of children wanting to attend Dalzell Grade School.
- ii)Applications will be accepted from children in the immediate family of staff members (children and grand children, brothers and sisters, adopted and step children and grand children, brothers and sisters), children who reside in the Blakely subdivision and any future subdivisions that are contiguous to the Dalzell School District boundaries or within ½ miles of the village of Dalzell, children (adopted and step) of former graduates of Dalzell Grade school from years past who live outside the district boundaries, and any child who was at one time legally enrolled in Dalzell Grade School and moved outside the District boundaries. The Board reserves the right to admit non-resident students when it can be done without prejudice to the rights of resident students. In lieu of per capita tuition, the school district will claim each student on our enrollment count for Evidenced Based Funding. Transportation will not be provided for those residing 1½ mile from the school.

iii)The purpose of the request is to facilitate improved student performance and stimulate innovation. Granting the waiver would enhance the student performance and stimulate innovation within the school by enhancing the performance of members of the staff. Their vested interest in the instructional program becomes a personal benefit. Their own children and grand children, brothers and sisters, adopted and step children and grand children, brothers are advantaged by the merits of their individual efforts. Teachers want the best for their family members. The benefits of a conscientious staff member's contributions to an educational institution can be enhanced and highlighted when their own family members are affected. Granting this request will also assist the school district in recruiting high quality staff.

Several students who live in the Blakely subdivision, (less than ½ mile from Dalzell School District boundary) have inquired to have their children attend Dalzell District #98. The reason given by these parents is that their children play with and associate with District 98 students on a regular basis. This would also allow for safer transportation to and from school as these students would not be required to cross a busy highway. Parents have also indicated they feel their children would learn more and perform better on state achievement tests because their children would be better adjusted both socially and emotionally because they would be able to be with those students they normally associate with during non-school hours. Also smaller class sizes at Dalzell Grade School would benefit these new students without dramatically increase class size. This could be the case if any new subdivisions are developed adjacent to the town of Dalzell but not within the School District boundaries.

Many parents would like their children to have the small type of education they had as kids growing up. In our preschool we presently have children of former graduates who would like to continue their child's education at Dalzell Grade School. Our preschool has been supported without any state support, but is funded by local tax dollars and minimal tuition charges. Parents have indicated they feel their children would learn more and perform better on state achievement tests because their children would be better adjusted both socially and emotionally because they would be in the smaller classes at Dalzell Grade School. Additionally, many of these children have grandparents in Dalzell and maintain a close working relationship with Dalzell Grade School.

Often when parents move outside the Dalzell School District they inquire if the students can remain in our school. In some cases of divorce, where one parent moves outside the district and the other maintains a residence within the district, the students continue their education at Dalzell Grade School while living predominately with the parent residing outside the District boundaries. Allowing students who at one time were legally enrolled in Dalzell School to continue attending Dalzell Grade School will benefit these students and families tremendously. Many of our most vulnerable students transfer from one local school to another every year or two. This will bring educational stability for these students.

These steps will allow Dalzell Grade School to maintain an enrollment sufficient to maintain a school allowing Dalzell to continue to receive a maximum amount of state aid. The school will continue to maintain small classes and a quality educational program most effectively and efficiently.

iv)Since Dalzell Grade School is a very small school, financial concerns can have a major impact on the quality of services provided to the students and impact the quality of education and student achievement. Our enrollment has decreased substantial over the last 10 years, but stabilized the past 5 years, mostly due to this waiver. Since total enrollment is a critical factor in the evidence-base funding model used to determine how much of any year's increase in state appropriations for state aid, it is important to maintain our total enrollment. Dalzell Grade school has been a tier 1 school for the initial 2 years of evidenced-based funding. The loss of this waiver could potential lower our total enrollment from 57 students to 47 students. This waiver coupled with a recent increase in EAV makes the future of Dalzell Grade School very optimistic toward the continuance of its tradition of providing quality education for its students.
