Dear Governor and Members of the General Assembly:

The enclosed information fulfills the statutory directive that the Illinois Department of Commerce and Economic Opportunity (DCEO) report annually to the members of the Illinois General Assembly on the status of the Illinois Angel Investment Tax Credit Program.

The Illinois Angel Investment Tax Credit Program officially became effective on January 1, 2011. The purpose of the Angel Investment Tax Credit Program is to attract and encourage the placement of investment dollars into early-stage, innovative companies throughout Illinois. The investment dollars provide these companies with much needed access to working capital to further their growth and success in our state.

I trust you will find the 2019 Angel Investment Tax Credit Program Report useful.

#### I. Introduction

The Illinois Angel Investment Credit Program ('Program') is designed to encourage interested firms or individuals to make an investment in one of Illinois' innovative, qualified new business ventures. The investment will encourage job growth and expand capital investment in Illinois. The Program can offer a tax credit to qualified investors in an amount equal to 25% of their investment made directly in a qualified new business venture. The maximum amount of tax credits to be issued under the Act is capped at \$10,000,000 per calendar year. The Program will be administered for the taxable years beginning after December 31, 2010 and ending on or before December 31, 2021 except the taxable year ending December 31, 2017.

The Program has two components of participation: (i) a business component and (ii) an investor component. Interested Illinois businesses must apply to DCEO each taxable year for which the business desires registration. If deemed eligible, the business can direct investors to apply for a tax credit. Investors of eligible businesses must submit an application to DCEO in order to be considered for a tax credit. To receive a credit, investors must (i) invest in the eligible business <u>after</u> the business has been deemed eligible, (ii) submit an executed application (which conforms to the Program's requirements) and (iii) certify to keep their investment in the qualified new business venture for no less than 3 years.

#### Effectiveness:

Since 2011, the Angel Investment Tax Credit Program has aided in the placement of \$284,900,000 in investments into early-stage, innovative businesses throughout Illinois. The placement of \$284,900,000 of investments provided 1,950 investors with \$71,225,000 in tax credits.

During 2011, the Program utilized \$2.04 million of the available \$10 million in tax credits. 58 businesses were registered for the program with 65 registered investors.

During 2012, the Program utilized all \$10 million of the available tax credits. 99 businesses were registered for the program with 304 registered investors.

During 2013, the Program utilized \$9.9 million of the available tax credits. 109 businesses were registered for the program with 374 registered investors.

During 2014, the Program utilized all \$10 million of the available tax credits. 112 businesses were registered for the program with 307 registered investors.

During 2015, the Program utilized \$9.285 million of the available tax credits. 86 businesses were registered for the program with 260 registered investors.



During 2016, the Program utilized all \$10 million of the available tax credits. 94 businesses were registered for the program with 235 registered investors.

During 2018, the Program utilized all \$10 million of the available tax credits. 168 businesses were registered for the program with 231 registered investors.

During 2019, the Program utilized all \$10 million of the available tax credits. 148 businesses were registered for the program with 174 registered investors.
