Senator Lightford offered the following Senate Resolution, which was referred to the Committee on Assignments:

SENATE RESOLUTION NO. 164

WHEREAS, Delta Sigma Theta Sorority, Incorporated was founded by 22 illustrious college-educated young women on the campus of Howard University in Washington, D.C. in January 1913 and is celebrating its 108th anniversary; and

WHEREAS, Shortly after the founding of Delta Sigma Theta Sorority, Inc., the 22 young women participated in the Women's Suffrage March and demanded rights for women, including the right to vote, which transformed the role of women in the democratic process; and

WHEREAS, Delta Sigma Theta Sorority, Inc. is an organization of college-educated women committed to the constructive development of its members through public service with a primary focus on the Black community; and

WHEREAS, The programs of Delta Sigma Theta Sorority, Inc. are implemented through its Five Point Programmatic Thrust, which includes Economic Development, Educational Development, Physical and Mental Health, Political Awareness and Involvement, and International Awareness and Involvement; and

WHEREAS, Members of Delta Sigma Theta Sorority, Inc. are accomplished corporate, civic, and public officials and acclaimed scholars; and

WHEREAS, Delta Sigma Theta Sorority, Inc. has a membership of more than 350,000 college-educated women in more than 1,020 chapters worldwide, of which 25 chapters are located in the State of Illinois; and

WHEREAS, In 1989, the National Social Action Commission instituted Delta Days in the Nation's Capital as a biennial legislative conference to increase member involvement in the public policy-making process; and

WHEREAS, Delta Day at the Illinois State Capitol has occurred on an annual basis with members from across the State in attendance; therefore, be it

RESOLVED, BY THE SENATE OF THE ONE HUNDRED SECOND GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we declare March 10, 2021 as Delta Day 2021 in the State of Illinois in recognition of Delta Sigma Theta Sorority, Incorporated and the 2021 theme of "Embracing and Elevating the Power In Our Voice"; and be it further

RESOLVED, That a suitable copy of this resolution be presented to Delta Sigma Theta Sorority, Inc. as a symbol of our respect and esteem.

Senator Aquino offered the following Senate Resolution, which was referred to the Committee on Assignments:

SENATE RESOLUTION NO. 165

WHEREAS, Chicago is home to over 150,000 Puerto Rican residents who are deeply concerned with and connected to Puerto Rico, as demonstrated by the fact that Chicago's Puerto Rican community was the first to send nongovernmental aid to the island after Hurricane Maria in 2017; and

WHEREAS, This diasporic community has long voiced support for Puerto Rico; today, it once again reaffirms this support, in recognition of international law and human rights; and

WHEREAS, Puerto Rico enters the 123rd year of U.S. colonization, which began with the U.S. invasion in 1898 and the subsequent annexation of Puerto Rico through The Treaty of Paris between the U.S. and Spain that year; and

WHEREAS, The U.S. Supreme Court declared, in the wake of the Plessy vs. Ferguson decision, that Puerto Rico belongs to but is not part of the United States, citing Puerto Ricans supposed racial inferiority and unfitness for self-rule, which would subsequently govern Puerto Rico through a doctrine of separate and unequal; and

WHEREAS, The U.S. government and corporations have benefited immensely from Puerto Rico's resources, labor, and environment at the cost of Puerto Rican well-being and freedom and, as a result, fueled mass migration from the island, to such an extent that today the majority of Puerto Ricans live outside of Puerto Rico; and

WHEREAS, While Puerto Rico was granted local autonomy through the establishment of the Commonwealth constitution in 1952, this did not alter the colonial relationship between the U.S. and Puerto Rico, as the U.S. Congress retained plenary power over Puerto Rico; and

WHEREAS, U.S. authorities have long repressed movements and efforts to self-determination and have allowed non-binding plebiscites and referendums that have unresolved the status issue; and

WHEREAS, The Puerto Rican New Progressive Party, which advocates for Puerto Rico to become the 51st state of the union, has imposed the two most recent referenda in 2017 and 2020; these have been marred by partisan control, voting irregularities, and confusing ballot language; and

WHEREAS, Statehood proponents, such as the current governor of Puerto Rico, Pedro Pierluisi, who did not win a majority of the vote, argue that the November 3, 2020 referendum produced a mandate for statehood; there are significant reasons to question this conclusion, including the fact that the referendum suffered from historic lows in participation, excluded non-statehood options, offered voters no transition plan on the consequences of the vote, and was widely opposed by much of Puerto Rico's civil society; and

WHEREAS, There is no mandate for statehood; there is consensus in Puerto Rico and throughout its diaspora that resolving Puerto Rico's colonial status requires a fair, inclusive, transparent, democratic, and binding self-determination process; and

WHEREAS, This type of process is outlined in the Puerto Rico Self-Determination Act, soon to be reintroduced by Puerto Rican Congresswomen Nydia Velazquez and Alexandria Ocasio-Cortez; and

WHEREAS, The Puerto Rico Self-Determination Act affirms that Puerto Ricans have the final determination on the destiny of Puerto Rico and proposes the formation of a constitutional convention of elected delegates that represent all of the major political status positions, including statehood, free association, and independence; and

WHEREAS, The Act further recommends that the Puerto Rican people must be provided with extensive information and engagement on all non-territorial options available and what the real implications of those options would be, and that the process be led and decided by the people who are impacted, not by political parties or under the pressures of political agendas; and

WHEREAS, The act most closely corresponds with President Biden's pledge to "engage Puerto Ricans — including representatives of every status option — in a process of self-determination, listening and developing federal legislation that outlines a fair path forward"; and

WHEREAS, Today, the Puerto Rican community in Chicago joins with Puerto Ricans across the diaspora and in Puerto Rico to support Congresswomen Nydia Velazquez and Alexandria Ocasio-Cortez's Puerto Rico Self-Determination Act and calls for an end to the shameful colonization of Puerto Rico; therefore, be it

RESOLVED, BY THE SENATE OF THE ONE HUNDRED SECOND GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge all Illinois legislators at all levels of government to endorse the Puerto Rico Self-Determination Act; and be it further

RESOLVED, That we urge the U.S. Congress to respond to will of Puerto Rico and to usher in a new relationship between the United States and the people of Puerto Rico; and be it further

RESOLVED, That suitable copies of this resolution be delivered to the President of the United States, the U.S. Senate Majority Leader, the U.S. Senate Minority Leader, the U.S. Speaker of the House, the U.S. House of Representatives Minority Leader, and all members of the Illinois Congressional Delegation.

Senator Pacione-Zayas offered the following Senate Resolution, which was referred to the Committee on Assignments:

SENATE RESOLUTION NO. 166

WHEREAS, Over the past several months, the Illinois State Board of Education has heard from superintendents, building principals, classroom teachers, parents, and students regarding their thoughts and concerns on federally required assessments for the 2020-2021 school year; and

WHEREAS, Because so many of our students have been separated from their school since March 2020, bringing students back in-person only to immediately begin state testing will have a detrimental effect on the goals of supporting their social and emotional well-being, mental health, and reconnection with the school community; while 77 percent of our 852 school districts are offering some in-person instruction, data show that more than a million students are still learning in fully remote environments; fewer than 200 Illinois school districts serving less than 200,000 students are currently able to provide fully in-person instruction to all students; Illinois students need their school and district administrators focused on resuming in-person instruction for the purposes of providing trauma-informed supports, increasing the quality of instruction, and rebuilding relationships between students and teachers; the administration of state assessments would take away from these critical endeavors that are foundational to the recovery of our educational systems; and

WHEREAS, After hearing the concerns of district and school leaders, teachers, families, and students, ISBE delayed its testing windows in order to provide as much flexibility for administration under socially distanced conditions; currently, and in addition to supporting the academic, social, and emotional needs of students, districts are utilizing time and resources to ensure transportation and safe logistics for testing; this time could be better spent coordinating vaccination administration for educators and the larger community and providing necessary supports for students; and

WHEREAS, Without a clear signal that the Department of Education will permit an assessment waiver, districts will continue to plan for the administration of assessments; this is not the optimal use of their time or resources; and

WHEREAS, Illinois educators understand and believe in the importance of assessment results, but the likely variability in participation across the State will limit the comparability and usefulness of the data at both the individual student and student group levels; and

WHEREAS, The potential yet diminished benefits of using incomplete state assessment data as a means of understanding the scope of learning loss that may have occurred as a result of the pandemic do not outweigh the significant burden that the administration of state assessments would incur on our students, families, teachers, and administrators; and

WHEREAS, Assessment, the practice of collecting evidence about student learning to provide students with feedback and to inform supports and instructional design, is still critically important to helping students recover from the pandemic; schools, districts, and teachers can and should continue to conduct

formative assessments at the local levels to understand the impact of the pandemic on student learning and provide holistic and individualized supports; and

WHEREAS, Accountability is an effective means of identifying schools and students in the greatest need of assistance; a second year without state assessments will impact longitudinal data and accountability systems; however, ISBE has the ability to continue to provide support to the highest need schools and students and to leverage local data sources to evaluate its progress; therefore, be it

RESOLVED, BY THE SENATE OF THE ONE HUNDRED SECOND GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge the U.S. Department of Education, pursuant to section 8401(b) of the Elementary and Secondary Education Act of 1965, as amended, to offer states the option to waive the following assessment and concomitant accountability and reporting requirements; specifically the U.S. Department of Education should release an expedited waiver application for:

- (1) Assessment requirements in section 1111(b)(2) covering all required assessments in school year 2020-2021;
- (2) The requirement that a state annually meaningfully differentiate all public school and to identify schools for comprehensive and targeted support and improvement, as required in sections 1111(c)(4) and 1111(d)(2)(C)-(D); and
- (3) Those report card provisions related to assessments and accountability in section 1111(h) that would be based on data from the 2020-2021 school year; and be it further

RESOLVED, That we believe that it is in the best interest of students and educators for the U.S. Department of Education to release an expedited waiver of assessment and accountability requirements for the 2020-2021 school year.

Senator Morrison offered the following Senate Resolution, which was referred to the Committee on Assignments:

SENATE RESOLUTION NO. 167

WHEREAS, Health and human service organizations are important components of a strong Illinois, essential employers for a robust economy, and integral to healthy and safe communities throughout our State; and

WHEREAS, These organizations contribute \$4.5 billion to the economy annually, while ensuring people are healthy, stable, and able to realize their potential, care for their families, and contribute to their communities; and

WHEREAS, These organizations play a fundamental role in providing person-centered, culturally sensitive, evidence-based healthcare, social services, and long-term services and supports aimed at promoting equality, opportunity, and advancing equity; and

WHEREAS, According to national statistics, 81% of social workers are female, with 27% of social workers being people of color; 69% of counselors are female, with 24.7% of counselors being people of color; 87% of direct support professionals are female, with 60% of direct support professionals being people of color; 87% of nursing, psychiatric, and home health aides are female, with 39% of these professionals being people of color; and

WHEREAS, Adequately supported health and human service organizations are crucial in preventing hospitalizations and addressing the increased demand for services, including childcare, access to food, housing, mental health services and supports to persons with disabilities, and healthcare for our most underserved populations; and

WHEREAS, The COVID-19 pandemic greatly publicized the crucial nature of health and human service organizations, with increased expectations to provide high quality services and supports in an unprecedented environment, while ensuring the health and safety of as many Illinoisans as possible; and

WHEREAS, It has been consistently documented across national and state level studies that many health and human services sectors were in precarious financial positions prior to the start of the pandemic, which significantly hampers the ability of these organizations to meet their missions of service; and

WHEREAS, According to Feeding America's Map the Meal Gap Study, food insecurity in Illinois is projected to increase by 46% due to the COVID-19 pandemic, with Northwestern University estimating 23% of Illinois households being impacted; and

WHEREAS, According to data from the Illinois Department of Public Health, 85% of COVID-19 fatalities are among adults age 60 or older, with nearly half of these deaths being residents of nursing homes; and

WHEREAS, According to the Illinois Department of Public Health data, opioid overdose deaths rose 36.5% in the first five months of 2020, from 197 deaths in January to 269 deaths; and

WHEREAS, According to data from Illinois counties, teen suicides were up in 2020 compared to 2019; Cook County's Black community experienced 71 suicides in the first 9 months of 2020, compared to 56 in all of 2019; and

WHEREAS, According to the U.S. Department of Housing and Urban Development and the U.S. Census American Community Survey, an estimated 10,199 individuals experience street and shelter-based homelessness and an additional 106,443 people experience homelessness by temporarily staying with others across Illinois; and

WHEREAS, More than 3 million Illinoisans live in 245 areas experiencing shortages in primary health care workforce across our State, limiting their access to basic health care; and

WHEREAS, Nationally, 95% of community health centers have reported at least one clinical staff vacancy, impacting their ability to provide community-directed, primary and preventative care; and

WHEREAS, While health and human services are always important components of a strong state, the current crisis facing Illinois elevates health and human services to the highest priority level for the General Assembly and the Governor as they approach the State fiscal year 2022 budget; therefore, be it
