Senator Lightford offered the following Senate Resolution, which was referred to the Committee on Assignments:

SENATE RESOLUTION NO. 774

WHEREAS, All students thrive when they are taught by educators who are well prepared to support their academic, social, and emotional needs; and

WHEREAS, Research shows that teacher quality is the number one school-based factor impacting student achievement and that all teachers benefit from regular performance feedback they can use to improve their teaching methods; and

WHEREAS, The Performance Evaluation Reform Act (PERA), which put Illinois' teacher evaluation system in place, is now over ten years old; and

WHEREAS, Both practice and available Illinois-based research indicate that teacher evaluations have significantly improved since the passage of PERA, facilitated more productive conversations between educators and evaluators, and strengthened feedback loops relating to instructional practice and student learning; and

WHEREAS, The value of joint committees to problem-solve and negotiate elements relating to teacher evaluation is clear; and

WHEREAS, The value of thoughtful evaluations also comes with concerns that these more substantive evaluations may be time-consuming; and

WHEREAS, The lack of state-level research and disaggregated data make it challenging to fully understand the impact and opportunities of evaluation elements, such as measuring professional practice or student growth; and

WHEREAS, Any change to PERA and our State's system of teacher evaluation are best addressed comprehensively, rather than through piecemeal legislation or changes; and

WHEREAS, PERA called for the creation of the Performance Evaluation Advisory Council (PEAC) to oversee implementation and training relating to PERA, which uniquely represents a variety of important stakeholders involved in PK-12 education, and is convened and staffed by the State Board of Education; and

WHEREAS, A comprehensive review of the implementation of PERA and the opportunity to consider whether and how evaluation policies might be improved would be timely and beneficial; therefore, be it

RESOLVED, BY THE SENATE OF THE ONE HUNDRED SECOND GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge the Performance Evaluation Advisory Council (PEAC) to initiate and complete a research study into the implementation of teacher evaluation in Illinois, gather feedback from stakeholders state-wide, review best practice from other states, and use that research to inform a set of policy recommendations that would address any identified challenges while preserving the core benefits of PERA's robust evaluation system with an interim report to the legislature by December 31, 2022 that includes a full timeline for report creation, including a plan for gathering stakeholder feedback, with a final report to be given to the legislature by December 31, 2023; and be it further

RESOLVED, That we urge the PEAC convene to initiate discussion on this charge by April 30, 2022; and be it further

RESOLVED, That a suitable copy of this resolution be delivered to the PEAC.

Senator Johnson offered the following Senate Resolution, which was referred to the Committee on Assignments:

SENATE RESOLUTION NO. 787

WHEREAS, Children learn gender roles and gender stereotypes through products with which they interact at the earliest ages of development; and

WHEREAS, Society has realized that gender distinctions are influenced by children's products and the advertising and marketing thereof; and

WHEREAS, In modern societies, the advertising industry plays a major role in the media landscape; and

WHEREAS, Advertising is a very powerful form of social communication, offering a concentrated set of images and ideas that appeals to children's emotions and, thereby, shapes their values, attitudes, and understanding of the world; and

WHEREAS, Due to the advertising industry's normative power to reflect daily life, it shapes children's understanding of gender; and

WHEREAS, The advertising industry plays a vital role in constructing, or deconstructing, gender roles and gender equality; and

WHEREAS, Addressing gender influencing in advertising is central to efforts towards achieving gender equality; therefore, be it

RESOLVED, BY THE SENATE OF THE ONE HUNDRED SECOND GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge the Federal Communication Commission to encourage the advertising industry to provide gender inclusive advertising and marketing for children's products.

Senator Anderson offered the following Senate Resolution, which was referred to the Committee on Assignments:

SENATE RESOLUTION NO. 788

WHEREAS, Out of School Time (OST) programs are a critical service for youth, families, and communities throughout Illinois; this was evident during 2020, the first year of the pandemic, when OST programs offered emergency services for children of frontline workers, provided tens of thousands of meals for children and their families, supported youths' social and emotional needs, and served as virtual learning sites in partnership with schools; these programs were often the safest place, both physically and emotionally, for numerous school age youth to spend their day; and

WHEREAS, Each year, regardless of a pandemic, Out of School Time programs benefit communities throughout Illinois by:

(1) Being a critical part in violence prevention in communities by actively engaging youth in supportive environments; afterschool programs also provide a safe haven and help dissuade youth from engaging in risky behaviors on and offline; studies have found that participants in afterschool programs are 30% less likely to participate in criminal activities;

(2) Supporting their participants social and emotional learning (SEL), as well as fostering character development; according to the Afterschool Alliance, "Afterschool and summer learning programs are a unique setting where youth can connect to positive adult mentors, feel safe to try new things, and have the opportunity to acquire new skills and develop mastery in an area."; compared to control students, students participating in SEL programs showed significantly more positive outcomes with respect to enhanced SEL skills, attitudes, positive social behavior, and academic performance and significantly lower levels of conduct problems and emotional distress;

(3) Partnering in education with schools; OST programs offer educational support during the school year and lessen learning loss during the summer; regarding the COVID pandemic, OST programs are critical to learning recovery; studies show that afterschool programs are sparking students' interest in school, leading to better school attendance, grades, standardized test scores, and behavior; OST programs also support academic outcomes by providing STEM activities, mentoring programs, career exploration, arts enrichment, and physical activity;

(4) Allowing parents, guardians, or caregivers to go to work or attend school knowing their children are safe and receiving quality programming, with 82% of parents agreeing that their afterschool program provides peace of mind and helps them keep their job; working families and businesses also benefit from afterschool programs that ensure that youth have a safe place to go while parents or guardians are at work; parents and guardians who do not have access to childcare miss an average of eight days of work per year, and this decreased worker productivity costs businesses up to \$300 billion annually; and

(5) Ensuring nutrition for youth through healthy after school snacks and, in many cases, evening meals; 96% of afterschool programs in Illinois offer at least a snack in their programs, while a quarter offer either breakfast, lunch, or dinner; many OST programs are USDA meal sites with over 28,056,694 meals and snacks being served to Illinois youth in these programs from October 1, 2020 to September 30, 2021; and be it further

WHEREAS, The need for more Out of School Time programs is great in Illinois, with four children waiting to access an afterschool program for every one child currently enrolled; additionally, nearly 430,000 youth who are not enrolled in a summer program say they would be if one was available to them; not only will Out of School Time programs cause a noticeable change in areas of need in our State, but they will also save money in the long-term; by increasing kids' earning potential, improving academic achievement, and reducing juvenile crime and delinquency, afterschool/OST programs save up to \$9 for every \$1 invested; therefore, be it

RESOLVED, BY THE SENATE OF THE ONE HUNDRED SECOND GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE HOUSE OF REPRESENTATIVES CONCURRING HEREIN, that we support Out of School Time programs in Illinois and recognize that they serve as a key component to supporting violence prevention, academic achievement, social/emotional well-being, nutritional needs, and a strong workforce, and we further recognize these programs' importance in a continuum of care for youth from birth to adulthood.

Senator Morrison offered the following Senate Resolution, which was referred to the Committee on Assignments:

SENATE RESOLUTION NO. 791

WHEREAS, Building an Illinois that can thrive now and in the future requires a steady commitment to supporting the physical, mental, and emotional well-being of all of the State's residents; and

WHEREAS, Equitable strategies are needed to ensure that all residents have the supports at home and in their communities that build a well-being, buffer against negative experiences, foster resilience, and make it possible to thrive; and

WHEREAS, Trauma, which may include adverse childhood experiences and other experiences across the life-course, disrupts health and well-being, making it more difficult for people to reach their potential and participate fully in their communities; and

WHEREAS, The landmark Adverse Childhood Experiences (ACEs) Study identified a profound connection between poor health during a person's adulthood and ACEs, which include physical, emotional, and sexual abuse, physical and emotional neglect, and household stressors such as domestic violence, separation or divorce involving household members, substance abuse, untreated mental illness, or incarceration of a household member; and

WHEREAS, ACEs studies have also found a strong correlation between the number of ACEs and a person's risk for health and social outcomes that include cancer, cardiovascular disease, diabetes, smoking, substance abuse, depression, obesity, unplanned pregnancies, low birth weight, suicide attempts, workplace absenteeism, unemployment, lower educational achievement, and lower wages; and

WHEREAS, Individuals with six or more ACEs are at risk, on average, to live 20 years less than those individuals with zero ACEs; and

WHEREAS, Findings from the Illinois 2017 Behavioral Risk Factor Surveillance Survey (BRFSS) Illinois ACEs Response Collaborative found that almost 60% of non-institutionalized adults in Illinois say they had at least one ACE; this number equates to almost five million Illinois residents; approximately 16% of Illinois adults reported four or more ACEs; and

WHEREAS, BRFSS data also showed that approximately 20% of African American adults in Illinois report four or more ACEs, compared to 15% of white residents; and

WHEREAS, ACEs are not the only potentially traumatic experiences that can influence health across the lifespan; extensive research demonstrates that community experiences such as gun violence, lack of educational or economic opportunities, poor or unaffordable housing, and lack of community cohesion can have the same detrimental effects on later health outcomes in individuals as ACEs; and

WHEREAS, These adverse community experiences are the result of historical traumas, such as slavery and genocides, and subsequent systemic inequities and oppression, such as racism; racism, which can include power inequalities, prejudices, stereotypes, discrimination, beliefs, and a systemic lack of access to essential supports including healthcare, has been directly linked to reduced physical and mental health in communities and individuals; and

WHEREAS, As a result of these historical traumas and subsequent systemic inequities, Black and Latinx residents in Illinois are more likely to live in neighborhoods with restricted access to essential resources such as education and economic opportunities, healthy food choices, safe and affordable housing, and behavioral and physical healthcare; like adverse childhood experience, these have all been linked to health and social outcomes that include reduced life expectancy, higher rates of infant and maternal mortality, high rates of asthma, higher rates of lead poisoning, and higher vulnerabilities to public health pandemics, including COVID-19; and

WHEREAS, These health inequities have been compounded and exacerbated by the COVID-19 pandemic, which has disproportionately affected Black and Latinx communities in Illinois; Black and Latinx residents are more likely to contract and more likely to die from the disease than white residents; Black and Latinx Americans are also significantly more likely to have COVID-19 be a "major threat to their general health and well-being" than the overall population; and

WHEREAS, COVID-19 has exacerbated burnout, and its associated conditions such as secondary trauma and compassion fatigue have affected those in the health care, education, human service, and other community supporting workforces; and

WHEREAS, Immigrant and refugee populations have been under the additional strain of stigmatizing rhetoric and an immigration system that fosters fear, mistrust, isolation, and injustice; and

WHEREAS, Robust research demonstrates that positive supports and experiences, such as stable and nurturing relationships and equitable access to food, housing, health care, financial resources, and other fundamentals of lifelong health and well-being can buffer against the effects of adversity and build resilience; and

WHEREAS, Resilience, the capacity to adapt and thrive in the face of adversity through strengths-based methods, can be built in individuals throughout the lifespan through trauma-informed, healing-centered care principles and practices such as trustworthiness and reliability, establishing physical and emotional safety, and providing opportunities for empowered decision-making; and

WHEREAS, Trauma-informed, healing-centered care is not a therapy or an intervention but is a principle-based, culture change process aimed at recognizing strengths and resiliency as well as helping people who have experienced trauma heal; and

WHEREAS, Implementing trauma-informed policies and practices mitigates the effects of workforce burnout, improves provider well-being, and leads to better outcomes for patients, students, and people engaged in human service and other community-supporting organizations; and

WHEREAS, Healthy and thriving communities are also fostered through these same trauma-informed, healing-centered, resilience-building principles; and

WHEREAS, It has been shown to be cost effective and sustainable to build programs and policies that foster positive experiences and are dedicated to the prevention and mitigation of traumatic experiences and their potential effects on physical and mental well-being and health, particularly in childhood; and

WHEREAS, This can be seen in allocated resources, as well as the creation of policies that acknowledge trauma and its effects on the health of individuals and communities, and how historical and contemporary systemic oppression may lead to potentially traumatic events such as adverse childhood experiences and adverse community experiences; and

WHEREAS, Applying a trauma-informed and healing-centered framework to the development and implementation of public policies has the potential to create sustainable, scalable change; and

WHEREAS, The State of Illinois has previously recognized the impact of ACEs on its residents' health and how trauma-informed, healing-centered principles, policies, and practices can prevent and mitigate the adverse health outcomes associated with trauma, such as Trauma-Informed Awareness Day in 2019, 2020, and 2021, the passage of the Children of Incarcerated Parents Bill of Rights, and the creation of the Whole Child Task Force introduced by the Illinois Legislative Black Caucus, as well as local resolutions recognizing Trauma-Informed Awareness Day in communities such as Winnebago County and the City of Chicago; and

WHEREAS, These same trauma-informed, healing-centered principles, policies, and practices must also recognize the detrimental effect that systemic oppressions such as racism can have on the health of individuals and communities and how these are, in fact, traumatic experiences with the same potential adverse health outcomes as ACEs; and

WHEREAS, The COVID-19 pandemic has made these systemic inequities more apparent and impactful, and a comprehensive response must recognize the role of racism and other oppressions in contraction of the disease, patient outcomes, and vaccine and treatment distribution; and

WHEREAS, The State's commitment to the support of a trauma-informed Illinois must be expanded to include recognition of the role that systemic policies and oppression have played in the creation and impact of trauma and communities; and

WHEREAS, This recognition must include a racially-just and healing-centered approach with an acknowledgment of the additional potential burden of trauma faced by Black and Latinx residents in Illinois and the United States; and

WHEREAS, The inclusion of recognizing the issue of systemic oppression and its impact on the creation of historical, community, and individual trauma will allow for a more thorough and effective response to reduce and eliminate health disparities in Illinois; and

WHEREAS, A trauma-informed, healing-centered Illinois can work to dismantle these systemic inequities and address the effects of racism and poverty, while working to prevent continued disparities; and

WHEREAS, This expanded definition of a trauma-informed, healing-centered Illinois enhances the ability of individuals and communities to adapt, cope, and thrive, including during difficult times, supporting the physical and mental well-being of everyone in Illinois; therefore, be it

RESOLVED, BY THE SENATE OF THE ONE HUNDRED SECOND GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we declare May 25, 2022 as Trauma-Informed Awareness Day in the State of Illinois to highlight the impact of trauma and the importance of prevention of adversity and fostering individual and community resilience through trauma-informed, healing-centered care; and be it further

RESOLVED, That we encourage members of the General Assembly and their staff to incorporate trauma-informed principles, such as safety, trustworthiness, collaboration, strengths-based approaches, and social justice, into the policymaking process; and be it further

RESOLVED, That we encourage all officers, agencies, and employees of the State of Illinois whose responsibilities include individuals throughout the life course and communities, including the Office of the Governor, the State Board of Education, the Department of Human Services, the Department of Children and Family Services, the Department of Public Health, the Department of Juvenile Justice, and Department of Corrections to become informed regarding well-documented, short-term, long-term, and multi-generational impacts of adverse childhood experiences, toxic stress, systemic racism, and other potentially traumatic experiences for children, adults, and communities and to become aware of and implement evidence-based and racially-just, trauma-informed, healing-centered care practices, tools, and interventions that promote positive experiences and racial justice to build resilience in individuals and communities so that they will be able to maximize their well-being and thrive.

Senator Koehler offered the following Senate Resolution, which was referred to the Committee on Assignments:

SENATE RESOLUTION NO. 792

WHEREAS, The Medicaid program in Illinois has an immense and growing impact, both in terms of taxpayer dollars and in the effect it has on citizens across the State; and

WHEREAS, State resources for healthcare services are scarce, and many healthcare providers, including pharmacists, are discontinuing services or ceasing operation, leading to a profoundly detrimental impact on our communities and the expansion of pharmacy deserts; and

WHEREAS, Enrollment under the Illinois Department of Healthcare and Family Services' Medical Assistance Programs (Medicaid) exceeds three million; and

WHEREAS, A sizable portion of the Medicaid population is currently enrolled, often mandatorily, in Managed Care Organizations (MCOs), making outlays to MCOS, measured in billions of dollars, one of the largest disbursements in the State; and

WHEREAS, 12,500 licensed pharmacists in Illinois provide medications and patient care services to assure the rational and safe use of all medications; and

WHEREAS, Pharmacists, as front-line healthcare providers, answered the call to aid during the ongoing COVID-19 pandemic and have assumed additional responsibilities of care and practice in order to best serve the public health needs of the citizens of the State of Illinois; and

WHEREAS, A significant number of pharmacists respond to the charge of their community to establish a pharmacy to provide access to care for their patients; and

WHEREAS, Pharmacies generate additional taxable revenue for the State and yet are continuously reimbursed below their cost on medications dispensed to meet their patient's needs; and

WHEREAS, Pharmacy benefit managers are companies that manage prescription drug benefits on behalf of Illinois' Managed Care Programs, which includes providing claims processing services or other prescription drug services; and

WHEREAS, Public Act 101-452, which was signed into law August 23, 2019 and went into effect on January 1, 2020, provides oversight of pharmacy benefit managers; and

WHEREAS, A number of other states have performed audits evaluating the role and benefit of pharmacy benefit managers; and

WHEREAS, It is paramount that the General Assembly stay engaged in Medicaid funding and corresponding healthcare outcome issues and be prepared to make legislative and administrative recommendations; therefore, be it

RESOLVED, BY THE SENATE OF THE ONE HUNDRED SECOND GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that the Auditor General is directed to conduct a performance audit of the Department of Healthcare and Family Services' administration of pharmacy benefit managers; and be it further

RESOLVED, That the performance audit include, but not be limited to, the following determinations:

(1) The amount of State and federal funds used by managed care organizations to reimburse pharmacy benefit managers and, in time, the amount paid by pharmacy benefit managers to reimburse pharmacies for fiscal years 2020 and 2021;

(2) An examination of contracts between managed care organizations and pharmacy benefit managers and between pharmacy benefit managers and pharmacies receiving reimbursement;

(3) The level of oversight the Department of Healthcare and Family Services provides over the contracts and over the pharmacy benefit managers to ensure compliance with contract requirements;
