WHEREAS, International Women's Day is intended to focus the global community's attention on accelerating gender parity; and

WHEREAS, The theme of this year's International Women's Day, Break the Bias, calls on all of us to challenge inequality and to take meaningful action towards a more equitable and inclusive world; and

WHEREAS, The health disparities that women face have been exacerbated by the COVID-19 pandemic; and

WHEREAS, Healthy women are the backbone of a thriving, stable, and resilient society; and

WHEREAS, International Women's Day is an opportune time to raise awareness of the inequity in women's health and begin efforts to improve such inequities while encouraging all women to prioritize their health; and

WHEREAS, March 8th of each year is recognized as International Women's Day by countries around the world to celebrate the past, present, and future achievements of women as well as the obstacles that women continue to face in their struggle for equal rights and gender equality; and

WHEREAS, International Women's Day is a time to reflect on the progress we have made in the economic, social, and political achievements of women and to reaffirm our commitment to pursue strategies

that guarantee the basic human rights of women and girls both statewide and globally, to promote meaningful and significant participation of women in all facets of our society, to encourage equitable access to and healthcare for all women and girls, and to support policy initiatives that seek to achieve gender parity and empower all women; therefore, be it

RESOLVED, BY THE SENATE OF THE ONE HUNDRED SECOND GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we declare March 8, 2022 as "International Women's Day" in the State of Illinois in order to reflect on the progress made thus far in women's rights; and be it further

RESOLVED, That we reaffirm the State's commitment to pursue strategies that guarantee the basic human rights of women and girls, to promote meaningful and significant participation of women in all aspects of our society, to encourage equitable access to and healthcare for all women and girls, and to support policy initiatives that seek to achieve gender parity and empower all women.

WHEREAS, The first police department in the United States was established in New York City in 1844 and officially organized in 1845; other cities followed suit, including Chicago in 1855; and

WHEREAS, The COVID-19 pandemic has highlighted the enduring courage and unwavering devotion of law enforcement officers to the communities that they have sworn to serve; and

WHEREAS, There are currently more than 900,000 sworn law enforcement officers and more than 17,000 state and local law enforcement agencies serving nationwide; and

WHEREAS, Approximately 12 percent of current law enforcement officers are female; and

WHEREAS, In uncertain times, these men and women are the first response in the face of crisis or tragedy, and they continue to put on their uniforms to bravely face challenges to ensure the general welfare of our society; and

WHEREAS, In 2021, 582 officers made the ultimate sacrifice while serving our great nation, including ten in Illinois; our fallen officers should be remembered and honored for their courage and sacrifice; and

WHEREAS, In 1962, President John F. Kennedy proclaimed May 15 as National Peace Officers Memorial Day and the calendar week in which May 15 falls as National Police Week; therefore, be it

RESOLVED, BY THE SENATE OF THE ONE HUNDRED SECOND GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we declare May 15 to May 21, 2022 as Police Appreciation Week in the State of Illinois; and be it further

RESOLVED, That we recognize the dedication and sacrifice of local, state, and federal police officers and their service to our great State; and be it further

RESOLVED, That we celebrate the contributions of law enforcement from across the State, recognizing their hard work, dedication, loyalty, and commitment to keeping our communities safe; and be it further

RESOLVED, That we recognize the families of law enforcement officers for their endless sacrifices; and be it further

RESOLVED, That we encourage all residents of Illinois to recognize the essential mission that law enforcement officers undertake every day and thank them for their dedication and service.

SENATE BILL NO. 4197. Introduced by Senator Hunter, a bill for AN ACT concerning State government.

The bill was taken up, read by title a first time, ordered printed and referred to the Committee on Assignments.

MESSAGES FROM THE HOUSE

A message from the House by Mr. Hollman, Clerk:

Mr. President -- I am directed to inform the Senate that the House of Representatives has adopted the following joint resolution, in the adoption of which I am instructed to ask the concurrence of the Senate, to-wit:

HOUSE JOINT RESOLUTION NO. 51

WHEREAS, It is highly fitting that the Illinois General Assembly pays honor and respect to the truly great individuals who have served our State and, in doing so, have made the ultimate sacrifice for our safety; and

WHEREAS, Officer Chris Oberheim was born in Decatur on October 31, 1976; and

WHEREAS, Officer Chris Oberheim began his career in law enforcement at the Decatur Police Department in 2000, where he quickly became a respected officer who led by quiet example and maintained a sense of humility even when receiving recognition for his heroic actions; he always looked forward to playing in the annual Illinois Police Benevolent and Protective Association State Softball Tournament and making memories with his fellow officers, whose friendships he treasured; and

WHEREAS, Officer Chris Oberheim transferred to the Champaign Police Department in 2008, where he continued to protect and serve his community; during his tenure, he received two Medals of Valor for his courageous acts of selfless bravery; and

WHEREAS, Officer Chris Oberheim dedicated a great deal of his time off-duty to coaching several successful girls' softball teams; his influence on the field was felt by many who loved and respected him; and

WHEREAS, Officer Chris Oberheim was not only a police officer but also a son, brother, husband, father, beloved coach, trusted friend, and respected leader; he valued his family as his first priority, and his four daughters were his absolute pride and joy; he will be remembered for being a devoted public servant, a family tradition further continued by his younger brother and his cousin who both serve as Decatur police officers; and

WHEREAS, Officer Chris Oberheim was preceded in death by his sister, LeighAnn, and his grandfather, Neil Ganley; and

WHEREAS, Officer Oberheim is survived by his wife, Amber; his daughters, Hannah, Avery, Addison, and Aubree; his parents, Ted and Mary Ann Oberheim; his siblings, Greg (Michelle), Amy, Matt (Jennifer), Joe (Chelsea), and Sarah (Jason); his in-laws; and his nieces and nephews; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED SECOND GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that we designate South Side Drive in Decatur from Route 51 to Route 48 as the "Officer Chris Oberheim Memorial Highway"; and be it further

RESOLVED, That the Illinois Department of Transportation is requested to erect at suitable locations, consistent with State and federal regulations, appropriate plaques or signs giving notice of the name of the "Officer Chris Oberheim Memorial Highway"; and be it further

RESOLVED, That suitable copies of this resolution be presented to the family of Officer Chris Oberheim, the Secretary of the Illinois Department of Transportation, the Champaign Police Department, the Decatur Police Department, and the Mayor of the City of Decatur.

Mr. President -- I am directed to inform the Senate that the House of Representatives has adopted the following joint resolution, in the adoption of which I am instructed to ask the concurrence of the Senate, to-wit:

HOUSE JOINT RESOLUTION NO. 64

WHEREAS, Women have proudly served their country throughout the history of the United States, whether in the disguise of a male soldier during the American Revolution and Civil War, as a nurse in World War I, as a combat helicopter pilot in Afghanistan or in another of many additional roles throughout the years; and

WHEREAS, Women have formally been part of the United States Armed Forces since the inception of the Army Nurse Corps in 1901 but have informally served since the inception of our nation's military; and

WHEREAS, In 1917, the United States Navy announced it would open enlistment to women, and approximately 12,000 women officially joined the Navy to serve in a variety of positions, including as interpreters, couriers, and translators as well as positions using drafting skills; and

WHEREAS, At the conclusion of World War II in 1945, there were 12 million enlisted who were remaining to serve in the United States military, of which approximately 280,000 were women; and

WHEREAS, With the passage of the Women's Armed Services Integration Act of 1948, women became a permanent part of the United States military but were restricted to two percent of the military population; the restriction was finally lifted in 1967 with an amendment to the Women's Armed Services Integration Act, which opened senior officer ranks to women; and

WHEREAS, On June 12, 1948, President Harry S. Truman signed the Women's Armed Services Integration Act into law, allowing women to serve as regular members of the United States military; and

WHEREAS, In the late 1970s and early 1980s, several laws were passed that recognized the many contributions made by women during World War II and that formally granted veteran status to women for their time in service; this allowed women to utilize programs, opportunities, and benefits from the federal and state governments, the Department of Veterans Affairs, and veteran service organizations; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED SECOND GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that we declare June 12, 2022 as "Women's Veterans Day" in the State of Illinois to commemorate the day women were officially added as regular members of the United States military, to recognize the critical role of women in the military forces, and to commemorate the sacrifices and valor displayed by Illinois women veterans; and be it further

RESOLVED, That we urge Women's Veterans Day be observed with appropriate programs, services, and activities.
