SENATE RESOLUTION 56

Senators Brady - Althoff - Burzynski - Righter offered the following Senate Joint Resolution, which was referred to the Committee on Rules:

SENATE JOINT RESOLUTION NO. 10

WHEREAS, The Health Facilities Planning Act is set to expire on April 1, 2007; and

WHEREAS, The role of the Health Facilities Planning Board has been the source of ongoing debate in the General Assembly; and

WHEREAS, The House Democrat Caucus initiated a review of the Health Facilities Planning Board in House Resolution 1497 of the 94th General Assembly; and

WHEREAS, The Commission on Government Forecasting and Accountability has solicited a study on the ability of the Health Facilities Planning Board to fulfill its mission of health care cost containment in response to House Resolution 1497; and

WHEREAS, The Senate Republican Caucus has reviewed the health facilities planning process and released a report detailing desired changes that will make the Health Facilities Planning Board more responsive and efficient; and

WHEREAS, The tumultuous past and uncertain future of the Health Facilities Planning Board

necessitates specific attention from the General Assembly; therefore, be it

RESOLVED, BY THE SENATE OF THE NINETY-FIFTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE HOUSE OF REPRESENTATIVES CONCURRING HEREIN, that there is created the Health Facilities Planning Board Task Force consisting of 13 members appointed as follows: one member appointed by the Director of Public Health, one member appointed by the Governor to represent hospitals, one member appointed by the Governor to represent physicians, 2 members appointed by the President of the Senate, 2 members appointed by the Minority Leader of the Senate, 2 members appointed by the Speaker of the House of Representatives, 2 members appointed by the Minority Leader of the House of Representatives, and the current Chairperson of the Illinois Health Facilities Planning Board; and be it further

RESOLVED, That the Task Force shall study the utility, effectiveness, and efficiency of the Health Facilities Planning Board and shall report its findings to the General Assembly on or before February 1, 2008; and be it further

RESOLVED, That a copy of this resolution be presented to the Director of Public Health, the Governor, the President of the Senate, the Minority Leader of the Senate, the Speaker of the House of Representatives, the Minority Leader of the House of Representatives, and the Chairperson of the Health Facilities Planning Board.

Senator Brady offered the following Senate Joint Resolution, which was referred to the Committee on Rules:

SENATE JOINT RESOLUTION NO. 11

WHEREAS, Medicaid pays for 40% of all births in the State of Illinois; and

WHEREAS, Women enrolled in Medicaid are statistically less likely to receive prenatal care; and

WHEREAS, One third of all babies born into the Medicaid program have some type of health complication; and

WHEREAS, Unhealthy births exact an emotional toll on the child's mother and family; and

WHEREAS, Unhealthy births result in substantial set-backs to a child's early development; and

WHEREAS. The costs associated with those unhealthy births exceed \$200 million annually; and

WHEREAS, Title V of the Social Security Act is intended to improve the health of pregnant women and children; and

WHEREAS, Simple and logical steps can be taken to reduce the incidence of unhealthy births in Illinois, resulting in healthier babies and a more efficient use of Medicaid resources; therefore, be it

RESOLVED, BY THE SENATE OF THE NINETY-FIFTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE HOUSE OF REPRESENTATIVES CONCURRING HEREIN, that the Illinois Department of Healthcare and Family Services shall work with the Illinois Department of Human Services in structuring a single information technology system that recognizes and identifies pregnant women enrolled in Medicaid and in need of prenatal services; and be it further

RESOLVED, That the Department of Healthcare and Family Services use the new information technology system to promote prenatal services to the identified population and thereby reduce the incidence of unhealthy births; and be it further

RESOLVED, That the Department of Healthcare and Family Services study the effectiveness of this

approach and annually report to the General Assembly on progress towards reaching the goal of reducing the number of unhealthy births in Illinois; and be it further

RESOLVED, That copies of this resolution be delivered to the Director of Healthcare and Family Services and the Secretary of Human Services.

Senator J. Jones offered the following Senate Joint Resolution, which was ordered printed and referred to the Committee on Rules:

SENATE JOINT RESOLUTION NO. 12 CONSTITUTIONAL AMENDMENT

SC0012

RESOLVED, BY THE SENATE OF THE NINETY-FIFTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE HOUSE OF REPRESENTATIVES CONCURRING HEREIN, that there shall be submitted to the electors of the State for adoption or rejection at the general election next occurring at least 6 months after the adoption of this resolution a proposition to amend Article VII of the Illinois Constitution by changing Section 6 as follows:

ARTICLE VII LOCAL GOVERNMENT

SECTION 6. POWERS OF HOME RULE UNITS

- (a) Any A County which has a chief executive officer elected by the electors of the county and any municipality which has a population of more than 25,000 is a are home rule unit units. Other municipalities may elect by referendum to become home rule units. Except as limited by this Section, a home rule unit may exercise any power and perform any function pertaining to its government and affairs including, but not limited to, the power to regulate for the protection of the public health, safety, morals and welfare; to license; to tax; and to incur debt.
 - (b) A home rule unit by referendum may elect not to be a home rule unit.
- (c) (Blank). If a home rule county ordinance conflicts with an ordinance of a municipality, the municipal ordinance shall prevail within its jurisdiction.
- (d) A home rule unit does not have the power (1) to incur debt payable from ad valorem property tax receipts maturing more than 40 years from the time it is incurred or (2) to define and provide for the punishment of a felony.
- (e) A home rule unit shall have only the power that the General Assembly may provide by law (1) to punish by imprisonment for more than six months or (2) to license for revenue or impose taxes upon or measured by income or earnings or upon occupations.
- (f) A home rule unit shall have the power subject to approval by referendum to adopt, alter or repeal a form of government provided by law, except that the form of government of Cook County shall be subject to the provisions of Section 3 of this Article. A home rule municipality shall have the power to provide for its officers, their manner of selection and terms of office only as approved by referendum or as otherwise authorized by law. A home rule county shall have the power to provide for its officers, their manner of selection and terms of office in the manner set forth in Section 4 of this Article.
- (g) The General Assembly by a law approved by the vote of three-fifths of the members elected to each house may deny or limit the power to tax and any other power or function of a home rule unit not exercised or performed by the State other than a power or function specified in subsection (l) of this section.
- (h) The General Assembly may provide specifically by law for the exclusive exercise by the State of any power or function of a home rule unit other than a taxing power or a power or function specified in subsection (l) of this Section.
- (i) Home rule units may exercise and perform concurrently with the State any power or function of a home rule unit to the extent that the General Assembly by law does not specifically limit the concurrent exercise or specifically declare the State's exercise to be exclusive.
- (j) The General Assembly may limit by law the amount of debt which home rule counties may incur and may limit by law approved by three-fifths of the members elected to each house the amount of debt, other than debt payable from ad valorem property tax receipts, which home rule municipalities may incur
 - (k) The General Assembly may limit by law the amount and require referendum approval of debt to be

incurred by home rule municipalities, payable from ad valorem property tax receipts, only in excess of the following percentages of the assessed value of its taxable property: (1) if its population is 500,000 or more, an aggregate of three percent; (2) if its population is more than 25,000 and less than 500,000, an aggregate of one percent; and (3) if its population is 25,000 or less, an aggregate of one-half percent. Indebtedness which is outstanding on the effective date of this Constitution or which is thereafter approved by referendum or assumed from another unit of local government shall not be included in the foregoing percentage amounts.

- (I) The General Assembly may not deny or limit the power of home rule units (1) to make local improvements by special assessment and to exercise this power jointly with other counties and municipalities, and other classes of units of local government having that power on the effective date of this Constitution unless that power is subsequently denied by law to any such other units of local government or (2) to levy or impose additional taxes upon areas within their boundaries in the manner provided by law for the provision of special services to those areas and for the payment of debt incurred in order to provide those special services.
- (m) Powers and functions of home rule units shall be construed liberally. (Source: Illinois Constitution.)

SCHEDULE

This Constitutional Amendment takes effect upon being declared adopted in accordance with Section 7 of the Illinois Constitutional Amendment Act.

Senator Lauzen offered the following Senate Joint Resolution, which was ordered printed and referred to the Committee on Rules:

SENATE JOINT RESOLUTION NO. 13 CONSTITUTIONAL AMENDMENT

SC0013

RESOLVED, BY THE SENATE OF THE NINETY-FIFTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE HOUSE OF REPRESENTATIVES CONCURRING HEREIN, that there shall be submitted to the electors of the State for adoption or rejection at the general election next occurring at least 6 months after the adoption of this resolution a proposition to add Sections 11 and 12 to Article IX of the Illinois Constitution as follows:

ARTICLE IX

REVENUE

Section 11. LIMITATION ON PROPERTY TAXATION

(a) The maximum amount of any ad valorem tax on real property shall not exceed 2% of the fair cash value of such property, to be collected by the counties and apportioned according to law to the districts within the counties.

The limitation provided for in subsection (a) does not apply to ad valorem taxes or special assessments to pay the principal and interest on:

- (1) Bonded indebtedness issued prior July 1, 2008; or
- (2) Bonded indebtedness issued on or after July 1, 2008, approved by two-thirds of the votes cast by the voters voting on the proposition.

Section 12. PROPERTY TAX DEFINITIONS AND REQUIREMENTS

(a) The "fair cash value" means either (i) the county assessor's valuation of real property for the 2005 tax year, or (ii) thereafter, the actual acquisition price of real property when purchased, newly constructed, or a change in ownership has occurred after the 2005 assessment. For purposes of this Section, "newly constructed" does not include real property that is reconstructed after a disaster, as declared by the Governor, where the fair market value of the real property, as reconstructed, is comparable to its fair market value prior to the disaster.

However, the General Assembly may provide that, pursuant to definitions and procedures established by the General Assembly, any person 65 years of age or older who resides in property that is eligible for a homestead exemption may transfer the base year value of the property entitled to exemption, with the adjustments authorized by subsection (b), to any replacement dwelling of equal or lesser value located within the same county and purchased or newly constructed by that person as his or her principal residence within two years of the sale of the original property. For purposes of this Section, "any person

65 years of age or older" includes a married couple one member of which is 65 years of age or older.

In addition, the General Assembly may authorize each county board of supervisors to adopt an ordinance making the provisions of this subsection relating to transfer of base year value also applicable to situations in which the replacement dwellings are located in that county and the original properties are located in another county within this State.

- (b) The full cash value base may be either (i) increased each year by the lesser of 2% or the rate of inflation, or (ii) reduced as shown in the consumer price index, or to reflect substantial damage, destruction, or other factors causing a decline in value.
- (c) For purposes of subsection (a), the General Assembly may provide for exemptions from the term "newly constructed".
- (d) For purposes of this Section, the term "change in ownership" does not include the acquisition of real property as a replacement for comparable property if the person acquiring the real property has been displaced from the property replaced by eminent domain proceedings, by acquisition by a public entity, or governmental action that has resulted in a judgment of inverse condemnation. The real property acquired shall be deemed comparable to the property replaced if it is similar in size, utility, and function, or if it conforms to state regulations defined by the General Assembly governing the relocation of persons displaced by governmental actions.
- (e)(1) Notwithstanding any other provision of this Section, the General Assembly shall provide that the base year value of property that is substantially damaged or destroyed by a disaster, as declared by the Governor, may be transferred to comparable property within the same county that is acquired or newly constructed as a replacement for the substantially damaged or destroyed property.
- (2) Except as provided in paragraph (3), this subsection shall apply to any comparable replacement property acquired or newly constructed on or after July 1, 1985, and to the determination of base year values for the 1985-86 fiscal year and fiscal years thereafter.
- (3) In addition to the transfer of base year value of property within the same county that is permitted by paragraph (1), the General Assembly may authorize each county board of supervisors to adopt, after consultation with affected local agencies within the county, an ordinance allowing the transfer of the base year value of property that is located within another county in the State and is substantially damaged or destroyed by a disaster, as declared by the Governor, to comparable replacement property of equal or lesser value that is located within the adopting county and is acquired or newly constructed within three years of the substantial damage or destruction of the original property as a replacement for that property. The scope and amount of the benefit provided to a property owner by the transfer of base year value of property pursuant to this paragraph shall not exceed the scope and amount of the benefit provided to a property owner by the transfer of base year value of property pursuant to subsection (a). For purposes of this paragraph, "affected local agency" means any city, special district, school district, or community college district that receives an annual allocation of ad valorem property tax revenues. This paragraph shall apply to any comparable replacement property that is acquired or newly constructed as a replacement for property substantially damaged or destroyed by a disaster, as declared by the Governor, occurring on or after October 20, 1991, and to the determination of base year values for the 1991-92 fiscal year and fiscal years thereafter.
 - (f) For the purposes of subsection (e):
- (1) Property is substantially damaged or destroyed if it sustains physical damage amounting to more than 50 percent of its value immediately before the disaster. Damage includes a diminution in the value of property as a result of restricted access caused by the disaster.
- (2) Replacement property is comparable to the property substantially damaged or destroyed if it is similar in size, utility, and function to the property that it replaces, and if the fair market value of the acquired property is comparable to the fair market value of the replaced property prior to the disaster.
- (g) For purposes of subsection (a), the terms "purchased" and "change in ownership" do not include the purchase or transfer of real property between spouses, including, but not limited to, all of the following:
- (1) Transfers to a trustee for the beneficial use of a spouse, or the surviving spouse of a deceased transferor, or by a trustee of such a trust to the spouse of the trustor.
 - (2) Transfers to a spouse that take effect upon the death of a spouse.
- (3) Transfers to a spouse or former spouse in connection with a property settlement agreement or decree of dissolution of a marriage or legal separation.
 - (4) The creation, transfer, or termination, solely between spouses, of any co-owner's interest.
- (5) The distribution of a legal entity's property to a spouse or former spouse in exchange for the interest of the spouse in the legal entity in connection with a property settlement agreement or a decree of dissolution of a marriage or legal separation.

- (h) For purposes of subsection (a), the terms "purchased" and "change in ownership" do not include the purchase or transfer of the principal residence of the transferor in the case of a purchase or transfer between parents and their children, as defined by the General Assembly, and the purchase or transfer of the first \$1,000,000 of the fair cash value of all other real property between parents and their children, as defined by the General Assembly. This subsection shall apply to both voluntary transfers and transfers resulting from a court order or judicial decree.
 - (i) The General Assembly may provide with respect to a qualified contaminated property.

SCHEDULE

This Constitutional Amendment takes effect upon being declared adopted in accordance with Section 7 of the Illinois Constitutional Amendment Act.

Senator Wilhelmi offered the following Senate Joint Resolution, which was referred to the Committee on Rules:

SENATE JOINT RESOLUTION NO. 14

WHEREAS, There has been, and continues to be, a significant expansion in the volume of personal property sold through pawnbrokers, auction services, consignment sellers, and other resellers; and

WHEREAS, There has been, and continues to be, a similar increase in the volume of stolen personal property sold through pawnbrokers, auction services, consignment sellers, and other resellers; and

WHEREAS, Access by law enforcement to sales-related information generated by pawnbrokers, auction services, consignment sellers, and other resellers has always been an important tool in combating burglary, robbery, theft, and other crimes directed at personal property; and

WHEREAS, Recent advances in electronic data collection and compilation have greatly simplified both the reporting of sales-related information by pawnbrokers, auction services, consignment sellers, and other resellers; and

WHEREAS, These same advances have created opportunities for law enforcement to access sales-related information at increasingly shorter intervals after the date of sale; and

WHEREAS, Law enforcement agencies, pawnbrokers, auction services, consignment sellers, resellers, and information technology-related businesses in several states have created differing systems to provide law enforcement with timely access to sales-related information; therefore, be it

RESOLVED, BY THE SENATE OF THE NINETY-FIFTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE HOUSE OF REPRESENTATIVES CONCURRING HEREIN, that there is created the Re-Sellers' Electronic Reporting Task Force, consisting of 19 members appointed as follows:

- (1) four members of the General Assembly, one member appointed by the President of the Senate, one member appointed by the Minority Leader of the Senate, one member appointed by the Speaker of the House, and one member appointed by the Minority Leader of the House; the members appointed by the President of the Senate and the Speaker of the House shall serve as co-chairs of the Task Force:
 - (2) three members appointed by the Governor; and
- (3) twelve members who are not members of the General Assembly appointed by the co-chairs of the Task Force representing a range of interests, including: law enforcement, pawnbrokers, consignment sellers, auctioneers, insurance companies, and the general public; and be it further

RESOLVED, That all members shall serve without compensation but shall be reimbursed for their reasonable and necessary expenses from funds appropriated for that purpose; and be it further

RESOLVED, That the Task Force shall study the various systems, technologies, and methods of operation for providing law enforcement with timely access to information relating to the sales of

personal property by pawnbrokers, auction services, consignment sellers, and other resellers, and shall consult with such law enforcement agencies, pawnbrokers, auction services, consignment sellers, resellers, and other persons or entities as it may deem fit, including, but not limited to, providers of technology and services relating to the collection, compilation, storage, and access to such information; and be it further

RESOLVED, That on or before December 31, 2007, the Task Force shall report to the General Assembly concerning its recommendations regarding the systems and technologies, together with their usage and potential funding mechanisms and sources, to be implemented to create a state-wide system for the collection of sales-related information by pawnbrokers, auction services, consignment sellers, and other resellers, and for the compilation, storage and timely access to such information by law enforcement and shall include proposed legislation to implement its recommendations, if needed; and be it further

RESOLVED, That upon issuing its report, the Task Force shall be dissolved.

Senator Althoff offered the following Senate Joint Resolution, which was referred to the Committee on Rules:

SENATE JOINT RESOLUTION NO. 15

WHEREAS, In the 2005-2006 school year, over 322,000 children with disabilities were served in special education programs across Illinois; and

WHEREAS, The number of children in special education programs has risen 5.4% in the last 5 years, and special education accounts for approximately 23% of all State education spending; and

WHEREAS, The federal government has established a goal of reimbursing 40% of the costs of special education incurred by school districts, but it currently provides only 18% of costs nationally and only 14% in Illinois; and

WHEREAS, Illinois has failed for decades to update reimbursement rates for special education costs, with the last reimbursement rate set in 1973 for special education orphanage tuition, in 1985 for special education personnel, in 1978 for special education private tuition, in 1976 for special education summer school, and in 1965 for special education transportation; and

WHEREAS, Illinois has continued to prorate special education mandated categoricals at less than 100%, with the FY07 budget prorating these mandated categoricals at 97%; and

WHEREAS, Even if Illinois fully funded mandated categoricals at 100%, this would still only represent partial funding, as the reimbursement rates are severely outdated; and

WHEREAS, Illinois school districts currently spend an estimated \$1 billion from their own general education funds to meet the unreimbursed costs of special education services that are mandated by federal and State laws and administrative rules; and

WHEREAS, Special education continues to represent a growing financial burden on school districts as the need for services increases while State and federal funding fails to increase along with that need; therefore, be it

RESOLVED, BY THE SENATE OF THE NINETY-FIFTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE HOUSE OF REPRESENTATIVES CONCURRING HEREIN, that a task force shall be created to study current special education funding needs and to make recommendations as to how the State can increase special education funding and ease the financial burden on school districts; and be it further

RESOLVED, That the task force shall consist of the State Superintendent of Education (or his or her

designee) plus 16 members appointed as follows: the House Majority Leader and the House Minority Leader shall each appoint one representative, the Senate President and the Senate Minority Leader shall each appoint one senator, and these 4 leaders shall each appoint 3 public members representing the interests of special education administrators and services, school districts, and disability advocates; and be it further

RESOLVED, That the task force shall be facilitated by the State Board of Education; and be it further

RESOLVED, That the task force shall report its findings and recommendations to the Governor and the General Assembly by January 1, 2008; and be it further

RESOLVED, That a suitable copy of this resolution be transmitted to the State Superintendent of Education

Senator Althoff offered the following Senate Joint Resolution, which was referred to the Committee on Rules:

SENATE JOINT RESOLUTION NO. 16

WHEREAS, The Constitution of the State of Illinois gives the State the primary responsibility for funding the cost of public education; however, the State currently only covers thirty-six percent of this cost, which ranks the State forty-seventh in the nation in terms of the percentage of state funding provided to schools; and

WHEREAS, Rather than fulfilling its constitutional obligation, the State has shifted the primary responsibility for funding the cost of public education to local property taxpayers, with school districts receiving an average of fifty-six percent of their funds from local property taxes; Illinois ranks forty-ninth among the fifty states for its over-reliance on local property taxes to fund education; and

WHEREAS, By relying on the property tax as the primary source of funding for schools, the State has created a disparity between property rich school districts and school districts without substantial property wealth; the existing funding disparity is unfair to the children of Illinois, who all deserve an equal opportunity to a quality education regardless of where they reside; and

WHEREAS, If the State is to ever assume primary responsibility for funding public education and resolve the current dependence on the property tax and the funding disparity between school districts, the State must either increase an existing source of State revenue or create a new revenue stream; and

WHEREAS, Taxpayers should not be asked to provide additional resources to public schools and school districts without the State improving the current systems of fiscal and performance accountability in such a manner as to provide a guarantee that new moneys would be well spent in ways likely to improve schools and that taxpayers would be afforded appropriate and understandable accountability for greater investments in school improvement; therefore, be it

RESOLVED, BY THE SENATE OF THE NINETY-FIFTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE HOUSE OF REPRESENTATIVES CONCURRING HEREIN, that there is created the Accountable Schools Task Force, which shall be facilitated by the State Board of Education, to review and evaluate the complex issues involving the fiscal and performance accountability of the State's school districts and individual schools; and be it further

representing teachers who participate in collective bargaining and two of whom shall be appointed by a different organization representing teachers who participate in collective bargaining; two members who are representatives of the education management community appointed by an organization representing school management; two members who are representatives of a statewide child advocacy organization appointed by the Governor; two members who are representatives of a statewide organization of parents and teachers appointed by the Governor; one member who is a mayor or village president from the northeastern Illinois region appointed by an organization representing mayors of northern Illinois; one member who is a mayor or village president from downstate Illinois appointed by an organization representing mayors of southern Illinois; one member who is a representative of the Mayor of the City of Chicago appointed by the Mayor of the City of Chicago; and three members appointed at-large by a national or regional organization with particular expertise in school fiscal and performance accountability; and be it further

RESOLVED, That following the appointment of all Task Force members, the Task Force shall meet at the call of the Governor and select a member to serve as Chairperson and shall meet at the call of the Chairperson as necessary thereafter; and be it further

RESOLVED, That the Task Force shall have the following duties and responsibilities: (1) to evaluate the State's existing fiscal and performance accountability systems; (2) to identify costs of mandates imposed on school districts and individual schools; (3) to recommend a fiscal assessment process that includes criteria for examining and evaluating the current financial practices of all school districts and schools and determining the adequacy and efficiency of internal controls; (4) to recommend methods to improve and stabilize the State's system of performance accountability; and (5) to recommend methods by which the fiscal and performance accountability systems are made more transparent and understandable for parents of students and taxpayers; and be it further

WHEREAS, The countries that currently participate in the Visa Waiver Program include Andorra, Australia, Austria, Belgium, Brunei, Denmark, Finland, France, Germany, Iceland, Ireland, Italy, Japan, Liechtenstein, Luxembourg, Monaco, the Netherlands, New Zealand, Norway, Portugal, San Marino, Singapore, Slovenia, Spain, Sweden, Switzerland, and the United Kingdom; and

WHEREAS, It is appropriate that the Republic of Poland be made eligible for the United States Department of State's Visa Waiver Program; therefore, be it

SC0018

RESOLVED, BY THE SENATE OF THE NINETY-FIFTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE HOUSE OF REPRESENTATIVES CONCURRING HEREIN, that there shall be submitted to the electors of the State for adoption or rejection at the general election next occurring at least 6 months after the adoption of this resolution a proposition to amend Article V of the Illinois Constitution by changing Sections 1, 3, 7, and 18 and by repealing Section 17 as follows:

ARTICLE V THE EXECUTIVE

SECTION 1. OFFICERS

The Executive Branch shall include a Governor, Lieutenant Governor, Attorney General, Secretary of State, Comptroller and Treasurer elected by the electors of the State. They shall keep the public records and maintain a residence at the seat of government during their terms of office.

(Source: Illinois Constitution.) SECTION 3. ELIGIBILITY

To be eligible to hold the office of Governor, Lieutenant Governor, Attorney General, Secretary of State, Comptroller or Treasurer, a person must be a United States citizen, at least 25 years old, and a resident of this State for the three years preceding his or her election.

SECTION 7. VACANCIES IN OTHER ELECTIVE OFFICES

If the Attorney General, Secretary of State, Comptroller or Treasurer fails to qualify or if the his office becomes vacant, the Governor shall fill the office by appointment. The appointee shall hold office until the elected officer qualifies or until a successor is elected and qualified as may be provided by law and shall not be subject to removal by the Governor. If the Lieutenant Governor fails to qualify or if the his office becomes vacant, it shall remain vacant until the end of the term.

SECTION 17. COMPTROLLER - DUTIES (REPEALED)

The Comptroller, in accordance with law, shall maintain the State's central fiscal accounts, and order payments into and out of the funds held by the Treasurer.

SECTION 18. TREASURER - DUTIES

The Treasurer, in accordance with law, shall (i) maintain the State's central fiscal accounts, and order payments into and out of the funds held by him or her, (ii) be responsible for the safekeeping and investment of monies and securities deposited with him or her, and for their disbursement upon his or her order, and (iii) have the duties and powers that may be prescribed by law of the Comptroller. (Source: Illinois Constitution.)
