Senator Murphy offered the following Senate Joint Resolution, which was ordered printed and referred to the Committee on Rules:

### SENATE JOINT RESOLUTION NO. 19 CONSTITUTIONAL AMENDMENT

SC0019

RESOLVED, BY THE SENATE OF THE NINETY-FIFTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE HOUSE OF REPRESENTATIVES CONCURRING HEREIN, that there shall be submitted to the electors of the State for adoption or rejection at the general election next occurring at least 6 months after the adoption of this resolution a proposition to amend the Illinois Constitution in Article V by changing Sections 1, 3, and 7 and by adding Section 18.5 and in Article VIII by changing Section 3 as follows:

### ARTICLE V THE EXECUTIVE

#### SECTION 1. OFFICERS

The Executive Branch shall include a Governor, Lieutenant Governor, Attorney General, Secretary of State, Comptroller, and Treasurer, and Auditor General elected by the electors of the State. The Auditor General shall first be elected in 2010. They shall keep the public records and maintain a residence at the seat of government during their terms of office.

(Source: Illinois Constitution.) SECTION 3. ELIGIBILITY

To be eligible to hold the office of Governor, Lieutenant Governor, Attorney General, Secretary of State, Comptroller, or Treasurer, or Auditor General, a person must be a United States citizen, at least 25 years old, and a resident of this State for the three years preceding his election.

#### SECTION 7. VACANCIES IN OTHER ELECTIVE OFFICES

If the Attorney General, Secretary of State, Comptroller, or Treasurer . Auditor General fails to qualify or if his office becomes vacant, the Governor shall fill the office by appointment. The appointee shall hold office until the elected officer qualifies or until a successor is elected and qualified as may be provided by law and shall not be subject to removal by the Governor. If the Lieutenant Governor fails to qualify or if his office becomes vacant, it shall remain vacant until the end of the term.

#### SECTION 18.5. AUDITOR GENERAL

The Auditor General shall conduct the audits of public funds of the State. The Auditor General shall also have full and complete authority, on his or her own initiative, to investigate all matters relating to government operations, financial or otherwise without limitation. He or she shall make additional reports and investigations as directed by the General Assembly. The Auditor General shall have subpoena power. The Auditor General shall report his or her findings and recommendations to the General Assembly and to the Governor. The Auditor General is subject to oversight and audit as the General Assembly may provide by law.

# ARTICLE VIII FINANCE

# SECTION 3. STATE AUDIT AND AUDITOR GENERAL

- (a) The General Assembly shall provide by law for the audit of the obligation, receipt and use of public funds of the State. The General Assembly, by a vote of three-fifths of the members elected to each house, shall appoint an Auditor General and may remove him for cause by a similar vote. The Auditor General shall serve for a term of ten years. His compensation shall be established by law and shall not be diminished, but may be increased, to take effect during his term.
- (b) The Auditor General shall conduct the audit of public funds of the State. He shall make additional reports and investigations as directed by the General Assembly. He shall report his findings and recommendations to the General Assembly and to the Governor. (Source: Illinois Constitution.)

#### **SCHEDULE**

This Constitutional Amendment takes effect upon being declared adopted in accordance with Section 7 of the Illinois Constitutional Amendment Act and applies to the office of Auditor General first filled by election in 2010.

Senator Wilhelmi offered the following Senate Joint Resolution, which was referred to the Committee on Rules:

#### SENATE JOINT RESOLUTION NO. 20

WHEREAS, WHEREAS, Operation Hero Miles donates free round-trip tickets to military families in need; and

WHEREAS, Fisher House, a non-profit foundation, administers the Operation Hero Miles program and has provided more than 7,500 airline tickets worth more than 10 million dollars; and

WHEREAS, Thousands of Illinois servicemen and servicewomen are currently on active duty around the world; and

WHEREAS, Family members of injured servicemen and servicewomen often need to fly at short notice to be at their injured relatives' bedside; and

WHEREAS, Participants in most frequent flyer programs can donate miles to Operation Hero Miles; and

WHEREAS, Illinois State employees earn frequent flyer miles that can be donated to Operation Hero Miles; therefore, be it

RESOLVED, BY THE SENATE OF THE NINETY-FIFTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE HOUSE OF REPRESENTATIVES CONCURRING HEREIN, that we encourage all residents of Illinois including State employees to donate generously to the Operation Hero Miles program.

Senator Raoul offered the following Senate Joint Resolution, which was referred to the Committee on Rules:

#### SENATE JOINT RESOLUTION NO. 21

WHEREAS, Enrollment in pre-primary education in the United States has increased significantly since 1991; according to the National Center for Education Statistics, from 1991-2001 pre-primary enrollment of children between the ages of three and five increased by twenty percent; and

WHEREAS, During the kindergarten years, children often make considerable gains in reading and math; in addition, they begin to develop advanced social skills from the constant interaction that they have with one another; and

WHEREAS, Those different skills and abilities that kindergartners acquire lay the foundation for success at future grade levels; history has shown that in many cases, these children go on to become more competent learners, and are less likely to be held back in school; and

WHEREAS, The Illinois General Assembly is committed to improving education in Illinois at all levels; the State of Illinois is aiming to not only enhance the educational experiences of current students, but also to continue increasing enrollment in pre-school and kindergarten programs in the State; therefore be it

RESOLVED, BY THE SENATE OF THE NINETY-FIFTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE HOUSE OF REPRESENTATIVES CONCURRING HEREIN, that we proclaim the second Tuesday of September in each year to be Kindergarten Day in the State of Illinois, and we encourage all parents to enroll their children in kindergarten to enhance their abilities and provide their children with better chances to succeed later in life.

Senator Sandoval offered the following Senate Joint Resolution, which was referred to the Committee on Rules:

#### SENATE JOINT RESOLUTION NO. 22

WHEREAS, In the National Labor Relations Act of 1935 (29 U.S.C. Sec. 151, et seq.) the United States Congress declared it to be the policy of the United States to encourage the practice of collective bargaining by protecting the exercise by workers of full freedom of association, self-organization, and designation of representatives of their own choosing for the purpose of negotiating the terms and conditions of their employment or other mutual aid or protection; and

WHEREAS, The freedom to form or join a union is a fundamental human right; and

WHEREAS, Unions benefit communities by strengthening tax bases, promoting equal treatment, and enhancing civic participation; and

WHEREAS, Fifty-seven million United States workers have indicated that they would join a union if given the opportunity; and

WHEREAS, Even though the nation's workers ostensibly have the freedom to choose whether to organize, in reality they are routinely denied that right; and

WHEREAS, When the right of workers to form a union is violated, wages decline, race and gender pay gaps widen, workplace discrimination increases, and job safety standards lapse; and

WHEREAS, Each year, 20,000 of America's workers are illegally threatened, coerced, or terminated for attempting to form a union; and

WHEREAS, Most violations of workers' freedom to join a union occur behind closed doors, and each year millions of dollars are spent to frustrate workers' efforts to organize; and

WHEREAS, A worker's fundamental right to join a union is a public issue that requires public policy solutions, including legislative remedies; and

WHEREAS, Federal legislation, the Employee Free Choice Act, has been introduced in the United States Congress (H.R. 800) in order to restore workers' freedom to join unions; therefore, be it

RESOLVED, BY THE SENATE OF THE NINETY-FIFTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE HOUSE OF REPRESENTATIVES CONCURRING HEREIN, that we urge the Congress of the United States of America to enact the Employee Free Choice Act that would protect and preserve the freedom of America's workers to organize and join unions by authorizing the National Labor Relations Board to certify a union as the bargaining representative when a majority of employees voluntarily sign authorization cards (commonly known as "card check" recognition), providing for first contract mediation and arbitration, and establishing meaningful penalties for violations of a worker's right to join a union; and be it further

RESOLVED, That suitable copies of this resolution be delivered to the President pro tempore of the U.S. Senate, the Speaker of the U.S. House of Representatives, and each member of the Illinois congressional delegation.

WHEREAS, More than 3,100 members of the United States Armed Forces have been killed and more than 23,000 members of the Armed Forces have been wounded in substantially accomplishing the stated purpose of the United States of giving the people of Iraq a reasonable opportunity to decide their own future; and

WHEREAS, The United States military occupation of Iraq has placed significant strains on the capacity of the United States Armed Forces, both active duty and reserve and the National Guard; and

WHEREAS, The armed forces of Iraq number more than 76,000 troops as of June 8, 2005, and are growing in number and capability daily; and

WHEREAS, The forces of the Iraqi Interior Ministry number more than 92,000 personnel as of June 8, 2005, and are growing in number and capability daily; and

WHEREAS, More than \$200 billion has been appropriated by Congress to fund military operations and reconstruction in Iraq, and Illinois residents' share now exceeds \$2.1 billion; and

WHEREAS, The funds spent by Illinois taxpayers on the war and occupation in Iraq could have provided Head Start for one year for more than 238,056 children; or medical insurance for one year for more than 1,076,242 children; or more than 31,147 public school teachers for one year; or more than 16,183 additional housing units, according to the National Priorities Project; and

WHEREAS, The war and continued occupation have resulted in the devastation of Iraq's physical and social infrastructure and led to widespread and continuous resistance to U.S. occupation that threatens the lives of Iraqi civilians and the men and women who compose the ranks of U.S. and other occupying forces; and

WHEREAS, The presence of United States forces in Iraq has inflamed anti-American passions in the Muslim world and increased the terrorist threat to United States citizens, both at home and abroad; and

WHEREAS, Polls show that less than half of the American people support the war; and

WHEREAS, Illinois Congresspersons Rush, Lipinski, Emanuel, Davis, Schakowsky, Jackson, Gutierrez, and Costello joined more than 100 other Congresspersons in voting for a House resolution on an Iraq exit strategy; therefore, be it

RESOLVED, BY THE SENATE OF THE NINETY-FIFTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that on behalf of the citizens of Illinois, we urge the United States government to immediately commence an orderly and rapid withdrawal of United States military personnel from Iraq; and be it further

RESOLVED, That the Illinois General Assembly, recognizing that the stability of Iraq is crucial to the security of the citizens of Illinois and to all Americans, urges the United States government to provide the people of Iraq with all necessary non-military material aid as shall be necessary for the security of Iraq's citizens and for the rebuilding of Iraq; and be it further

RESOLVED, That the financial resources used to prosecute the war be redirected to address the urgent needs of America and the most vulnerable portions of our population, including health, education, and homeland security; and be it further

RESOLVED, That a suitable copy of this resolution shall be sent to George W. Bush, President of the United States, and the members of the Illinois Congressional delegation.

RESOLVED, BY THE SENATE OF THE NINETY-FIFTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that the Auditor General is directed to conduct a performance audit on the Medicaid program and Group Health Insurance program at the Department of Healthcare and Family Services for compliance with the mandates of the State Prompt Payment Act from July 1, 2003 through December 31, 2006; and be it further

RESOLVED, That the audit include, but is not limited to, the following determinations:

- (i) the number of unpaid bills that have generated in excess of \$50 in interest, by fiscal year;
- (ii) the amount of unpaid Prompt Payment interest on unpaid bills that have generated in excess of \$50 in interest, by fiscal year;
- (iii) the amount of paid Prompt Payment interest on unpaid bills that have generated in excess of \$50 in interest, by fiscal year;
- (iv) the number of unpaid bills that have generated in excess of \$5 in interest but no more than \$50 in interest, by fiscal year;
- (v) the amount of unpaid Prompt Payment interest on unpaid bills that have generated in excess of \$5 in interest but no more than \$50 in interest, by fiscal year; and
- (vi) the amount of paid Prompt Payment interest on unpaid bills that have generated in excess of \$5 interest but no more than \$50 in interest, by fiscal year, and be it further

RESOLVED, That the Auditor General commence this audit as soon as possible and, upon completion, make the findings and recommendations public in accordance with the provisions of Section 3-14 of the Illinois State Auditing Act.

### ARTICLE IV THE LEGISLATURE

## SECTION 8.1. PASSAGE OF REVENUE BILLS

A bill that would result in the increase of revenue may become law only with the concurrence of two-thirds of the members elected to each house of the General Assembly. An increase of revenue includes, without limitation, the imposition of new taxes, an increase in the rate of an existing tax, a change in a definition that results in an expansion of a tax base, a deduction or elimination of any preferential or exempt status, or the reduction or elimination of any credit, exemption, or deduction.

## ARTICLE VIII FINANCE

### SECTION 2. STATE FINANCE

(a) The Governor shall prepare and submit to the General Assembly, at a time prescribed by law, a State budget for the ensuing fiscal year. The budget shall set forth the estimated balance of funds available for appropriation at the beginning of the fiscal year, the estimated receipts, and a plan for expenditures and obligations during the fiscal year of every department, authority, public corporation and quasi-public corporation of the State, every State college and university, and every other public agency created by the State, but not of units of local government or school districts. The budget shall

also set forth the indebtedness and contingent liabilities of the State and such other information as may be required by law. Proposed expenditures shall not exceed funds estimated to be available for the fiscal year as shown in the budget.

- (b) The General Assembly by law shall make appropriations for all expenditures of public funds by the State. Appropriations for a fiscal year shall not exceed funds estimated by the General Assembly to be available during that year.
- (c) The rate of growth in total State expenditures in any fiscal year over the prior fiscal year is limited to: (i) the percentage increase in the annual rate of increase, for the previous calendar year, of the Consumer Price Index for All Urban Consumers for all items, published by the United States Bureau of Labor Statistics; plus (ii) the rate of increase in the State's population for the same 12-month period. Population growth must be determined by annual federal census estimates and must be adjusted every decade to match the federal decennial census.
- (d) The State shall maintain a reserve fund equal to 3% of the enacted budget for the prior fiscal year. (Source: Illinois Constitution.)

WHEREAS, The American Institute of Architects (AIA), the national professional organization representing architects has also adopted the "2030 Challenge" resolution; and

WHEREAS, The Inter-Governmental Panel on Climate Change (IPCC), the international community's

most respected assemblage of scientists, has found that climate disruption is a reality and that human activities are largely responsible for increasing concentrations of global warming pollution; and

WHEREAS, The North American and global building sector has been shown to be the major consumer of fossil fuel and producer of global warming causing greenhouse gases; and

WHEREAS, The federal government through programs fostered within many of its key agencies and numerous state governments as well as municipalities across the U.S. have adopted high performance green building principles; and

WHEREAS, A recent study completed by researchers from Capitol E and the Lawrence Berkeley National Laboratory, the most definitive cost-benefit analysis of green buildings ever conducted, concluded that the financial benefits of green design are between \$50 and \$70 per square foot, more than 10 times the additional cost associated with building green; and

WHEREAS, The large positive impact on employee productivity and health gains suggests that green building has a cost-effective impact beyond just the utility bill savings; and

WHEREAS, Studies have indicated that student attendance and performance is higher in high performance school buildings; and

WHEREAS, Recognizing that a building's initial construction costs represent only 20 to 30 percent of the building's entire costs over its 30 to 40 year life, emphasis should be placed on the "life cycle costs" of a public building rather than on solely its initial capital costs; and

WHEREAS, The construction industry in the U.S. represents a significant portion of our economy and a significant portion of the building industry is represented by small business and an increase in sustainable building practices will encourage and promote new and innovative small business development throughout the nation; therefore, be it

RESOLVED, BY THE SENATE OF THE NINETY-FIFTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE HOUSE OF REPRESENTATIVES CONCURRING HEREIN, that all State of Illinois buildings meet the following targets; and be it further

RESOLVED, That new construction of buildings shall be designed to and achieve a minimum delivered fossil-fuel greenhouse gas (GHS) emitting energy consumption performance standard of one-half the U.S. average for that building type as defined by the Environmental Protection Agency (EPA) in the EPA's Target Finder; and be it further

RESOLVED, That renovation building projects shall be designed to and achieve a minimum delivered fossil-fuel GHG emitting energy consumption performance standard of one-half the U.S. average for that building type as defined by the EPA's Target Finder; and be it further

RESOLVED, That all other new construction, renovation, repairs, and replacements of buildings shall employ cost-effective, energy-efficient, green building practices to the maximum extent possible; and be it further

RESOLVED, That the State of Illinois will work to increase the fossil-fuel GHG emitting reduction standard for all new buildings to carbon neutral by 2030, in the following increments:

60% in 2010

70% in 2015

80% in 2020

90% in 2025

Carbon-neutral by 2030 (meaning new buildings will use no fossil fuel GHG emitting energy to operate); and be it further

RESOLVED, That the Illinois Green Government Coordinating Council will develop plans to fully implement these targets as part of the procurement and inspection process and by establishing polices to insure compliance and measure results; and be it further

RESOLVED, That the State of Illinois will work in conjunction with other appropriate organizations to join this effort to develop plans to fully implement similar targets; and be it further
