Senator Syverson offered the following Senate Resolution, which was referred to the Committee on Rules:

SENATE RESOLUTION NO. 723

WHEREAS, Hugo Rafael Chavez Frias is the current President of Venezuela; and

WHEREAS, In 2002, President Chavez tried to take over the Caracas city police force, which reports to an opposition mayor; the Venezuelan Supreme Court ordered Chavez to restore the force's autonomy; an opposition strike occurred in January of 2003 and violence ensued, resulting in two deaths; and

WHEREAS, In October of 2005, President Chavez accused what he called the "North American empire" of threatening "all life on the planet"; and

WHEREAS, In August of 2006, President Chavez made statements comparing Israel to Hitler; and

WHEREAS, In September of 2006, President Chavez delivered a speech to the United Nations General Assembly condemning U.S. President George Bush; in the speech, Chavez referred to President Bush as "the devil", adding that Bush had come to the United Nations General Assembly to "share his nostrums to try to preserve the current pattern of domination, exploitation and pillage of the peoples of the world"; in response, U.S. House Minority Leader Nancy Pelosi (D-California) stated "He is an everyday thug"; and

WHEREAS, President Chavez has undergone criticism from the global community for what is considered to be an excess usage of police action; and

WHEREAS, In May of 2007, President Chavez silenced the popular Radio Caracas Television (RCTV) and replaced it with a state-run broadcast station; the station had been on the air for 53 years and aired news broadcasts with a decidedly anti-governmental perspective; it was one of only a handful of private broadcast stations that openly criticized the government; and

WHEREAS, Media outlets have accused the Chavez administration of intimidating their journalists using specially-dispatched gangs; and

WHEREAS, In November of 2007 and in February of 2008, President Chavez threatened to cut off oil shipments to the United States; and

WHEREAS, President Chavez's warm and public friendship with Cuban President Fidel Castro has compromised the U.S. policy of isolating Cuba diplomatically and economically; and

WHEREAS, The U.S. State Department released a report in April of 2008 which states that President Chavez is not cooperating with U.S. anti-terror efforts and has "deepened Venezuelan relationships with state sponsors of terrorism Iran and Cuba"; it further notes that Venezuelan weapons stocks have turned up in the hands of Colombian terrorist organizations; therefore, be it

RESOLVED, BY THE SENATE OF THE NINETY-FIFTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we encourage the State of Illinois and its citizens to not conduct business with President Hugo Chavez or any companies associated with President Hugo Chavez; and be it further

RESOLVED, That a suitable copy of this resolution be presented to the Governor.

Senator Noland offered the following Senate Resolution, which was referred to the Committee on Rules:

SENATE RESOLUTION NO. 724

WHEREAS, Many common consumer products contain hazardous materials; some of these materials, such as lead and mercury, which can be found in compact fluorescent lamps (CFLs), are persistent bioaccumulative and toxic chemicals; when products containing these materials are improperly stored or disposed of and accidently break, they can contaminate the soil, groundwater, and air, posing a risk to human health and wildlife; and

WHEREAS, CFLs significantly reduce mercury, greenhouse gases, and other toxic emissions from coal-fired power plants and are two to three times more efficient than standard incandescent light bulbs, but concerns have been raised about the safety of CFLs because all models contain mercury and some models contain lead; and

WHEREAS, Mercury is a persistent and toxic pollutant that bioaccumulates in the environment; and

WHEREAS, The Illinois Department of Public Health recognizes that the developing nervous systems of fetuses and children could be damaged if exposed to small amounts of methylmercury; at high doses, methylmercury can affect the central nervous system causing health problems such as memory loss and slurred speech; and methylmercury can cause kidney damage, kidney failure, and gastrointestinal damage; and

WHEREAS, The Illinois Environmental Protection Agency, municipalities, IKEA, and Ace Hardware offer CFL collection programs for proper recycling, but the vast majority of CFLs end up in landfills or trash incinerators where the hazardous substances in CFLs can get released into the environment; and

WHEREAS, Approximately two percent of household CFLs and thirty percent of commercial CFLs are recycled in the United States; therefore, be it

RESOLVED, BY THE SENATE OF THE NINETY-FIFTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge CFL manufactureres and retailers to voluntarily implement CFL collection programs to ensure that more CFLs are properly recycled.

WHEREAS, Nuclear power accounts for roughly 19% of the total net electricity generated in the United States; and

WHEREAS, The genesis of all of the nuclear industries in the world was the first controlled nuclear chain reaction, which took place in Illinois on December 2, 1942 at the University of Chicago; and

WHEREAS, Illinois is home to more commercial nuclear plants than any other state in the nation and is ranked first among the 31 states with nuclear capacity, as of January 2005; and

WHEREAS, Of all of the states in the nation, the electric industry in Illinois ranked sixth in highest carbon dioxide emissions, eleventh-highest in sulfur dioxide emissions, and eighth-highest in nitrogen oxide emissions in 2004; and

WHEREAS, Nuclear energy is clean compared to electricity generated by burning fossil fuels, and nuclear power plants produce no air pollution; and only a small amount of emissions result from processing uranium used in nuclear reactors; and

WHEREAS, Expansions in the nuclear power market in Illinois have the potential to meet increasing

demand for electricity without adverse affects on air quality, global warming, and public health; however, before the industry can grow, questions of long-term liabilities such as disposal of waste and safe and affordable decommissioning must first be answered; and

WHEREAS, Given that Illinois derives almost one-half of its power generation from nuclear power plants, and that a number of issues are in public discourse concerning the current plants, waste storage, and the future of nuclear generation in a carbon-constrained world, the General Assembly of the State of Illinois believes it is necessary to convene a task force to study nuclear power issues; therefore, be it

RESOLVED, BY THE SENATE OF THE NINETY-FIFTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE HOUSE OF REPRESENTATIVES CONCURRING HEREIN, that there is created the Nuclear Power Issues Task Force consisting of 9 members appointed as follows: one Senator chosen by the Senate President, who shall be a co-chairperson, one Representative chosen by the Speaker of the House of Representatives, who shall be a co-chairperson, one Senator chosen by the Senate Minority Leader, one Representative chosen by the House Minority Leader, one member chosen by the Attorney General, one member from the business community chosen by the co-chairperson appointed by the Senate President, one member from the environmental community chosen by the Illinois Environmental Protection Agency, or his or her designee, and the Director of the Illinois Emergency Management Agency, or his or her designee; and be it further

RESOLVED, That the Illinois Emergency Management Agency, the Illinois Environmental Protection Agency, and the Office of the Attorney General shall cooperate to provide technical and administrative support for the Task Force, subject to available appropriations for that purpose; and be it further

RESOLVED, That the Task Force shall compile information on the following issues, as well as others it deems necessary:

- the decommissioning of existing or retired plants, including waste storage or disposal issues;
- (2) waste storage and movement within the State, including any economic potential;
- (3) the re-processing of spent nuclear fuel; and
- (4) the existing moratorium on new nuclear power generation in the State, looking at the

structure and process for new generation, and how nuclear generation can play a role in the future power needs of the State, including looking also at greenhouse gas emissions and potential regulations to constrain carbon output; and be it further

RESOLVED, That in order to gather all necessary information, the Task Force shall solicit expert testimony and public opinion through a series of public hearings; and be it further

RESOLVED, That the Task Force shall prepare a report and file it with the Secretary of the Senate and the Clerk of the House by January 1, 2009 detailing the issues raised and any policy recommendations it deems necessary, if any, as well as outlining the next steps for further study of the issues.
