Senator Schoenberg offered the following Senate Resolution, which was referred to the Committee on Assignments:

SENATE RESOLUTION NO. 98

WHEREAS, The John H. Stroger, Jr. Hospital of Cook County (formerly, Cook County Hospital) provides vital health care services to the people of Cook County; and

WHEREAS, The Hospital has been beset by budgetary shortfalls and management difficulties that have undermined its ability to deliver timely, adequate health care; and

WHEREAS, Following a series of management reforms, the Hospital was awarded full accreditation by the Joint Commission on Accreditation of Healthcare Organizations in February 2008; and

WHEREAS, A recent ordinance will provide additional revenues to the Hospital and has established an independent board of trustees to take over management of the Hospital as of May 2008, for a period of 3 years; therefore, be it

RESOLVED, BY THE SENATE OF THE NINETY-SIXTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that the Auditor General is directed to conduct a management audit of the administration of John H. Stroger, Jr. Hospital of Cook County; and be it further

RESOLVED. That the audit include, but not be limited to, the following determinations:

- (1) whether the Hospital's procurement processes are in compliance
- with applicable laws, rules and policies and are adequately documented;
 - (2) whether the Hospital's internal controls over expenditure and
 - revenue processing appear to be adequate;
- (3) whether the Hospital has developed fraud detection programs that

appear to be adequate and designed to identify and control fraud risks in its operations; and

(4) whether the Hospital's short and long range plans for staffing

administrative positions are documented and appear reasonable; and be it further

RESOLVED, That the John H. Stroger, Jr. Hospital of Cook County and any other State, county, or local entity having information relevant to this audit cooperate fully and promptly with the Auditor General's Office in the conduct of this audit: and be it further

RESOLVED, That the Auditor General commence this audit as soon as possible and report his findings and recommendations upon completion in accordance with the provisions of Section 314 of the Illinois State Auditing Act.

Senator Link offered the following Senate Resolution, which was referred to the Committee on Assignments:

SENATE RESOLUTION NO. 99

WHEREAS, The members of the Illinois Senate are deeply concerned about the impact of climate change and the future health and well-being of our planet; we believe that energy efficiency, natural resource conservation, and a demand by the voting public for action by elected officials are important elements to combating climate change; and

WHEREAS, Earth Hour is an international and local symbolic event organized by the World Wildlife Fund to raise awareness about climate change issues and to encourage businesses, individuals, and governments to take action to reduce their carbon emissions and their impact on the environment in their daily lives and operations; and

WHEREAS, Earth Hour asks all citizens, businesses, government agencies, and commercial and non-commercial establishments to turn off all non-essential lighting for one hour, beginning at 8:30 P.M. on March 28, 2009, and to encourage citizens and businesses to commit to actions they can take in the coming year to reduce their carbon footprints and conserve energy; and

WHEREAS, If every household were to install one compact fluorescent lamp (CFL), annual energy savings will reach approximately 18 gigawatt hours per year, or 1.3% of total residential energy demand; and

WHEREAS, Earth Hour will be used as a tool to inform local residents and businesses about existing information and tools already available within the community to assist them in increasing energy efficiency and decreasing emissions and the use of natural resources; and

WHEREAS, Extinguishing non-essential lights in all State government buildings, public schools, and public landmarks for one hour and urging all businesses and citizens to do the same will send a clear message that the people of Illinois are concerned about climate change, that we stand with the rest of the world in seeking solutions, and that we are demanding that elected leaders act immediately to take measures that will help fight global climate change effort to stop climate change, including the passage of legislation and good-faith participation in the United Nations Climate Change Conference negotiations in Copenhagen, Denmark in December of 2009; and

WHEREAS, Turning non-essential lights off in all State government buildings, public schools, and public landmarks will serve as an important rallying point for the Statewide energy conservation event known as Earth Hour; therefore, be it

RESOLVED, BY THE SENATE OF THE NINETY-SIXTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we embrace and support Earth Hour in order to raise awareness about global climate change and energy efficiency; and be it further

RESOLVED, That we encourage all State employees to turn off all non-essential lighting in State government buildings, public schools, and public landmarks for the hour between 8:30 and 9:30 P.M. on March 28, 2009 in order to conserve energy and raise awareness about global climate change as part of this energy conservation event; and be it further

RESOLVED, That we designate the date of March 28, 2009 as "Earth Hour Day" in the State of Illinois.

Senator Maloney offered the following Senate Joint Resolution, which was referred to the Committee on Assignments:

SENATE JOINT RESOLUTION NO. 29

WHEREAS, During the 1970s, a special provision was written into the Social Security Act of 1935 concerning contingent academic workers; that provision excluded education workers from receipt of unemployment benefits unless they can demonstrate that they do not have "reasonable assurance" of continued employment; and

WHEREAS, Academic contingent workers in higher education are frequently denied access to unemployment benefits based on a very broad interpretation of "reasonable assurance"; therefore, be it

RESOLVED, BY THE SENATE OF THE NINETY-SIXTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE HOUSE OF REPRESENTATIVES CONCURRING HEREIN, that there is created the Unemployment Insurance for Contingent Academic Workers Task Force; and be it further

RESOLVED, That the Task Force shall be charged with the following tasks:

- (1) to estimate costs to higher education institutions of a change in law that allows contingent academics to collect unemployment insurance; and
- (2) to examine the growth of employment of part-time contingent faculty over the past 10 years; and be it further

RESOLVED, That the Task Force shall be composed of the following:

- (1) 2 members who are statewide education labor union representatives from a 2-year institution; each member shall be appointed by the union that he or she represents;
- (2) 2 members who are statewide education labor union representatives from a 4-year institution; each member shall be appointed by the union that he or she represents;
 - (3) 2 members who are management representatives from higher education institutions appointed by the Board of Higher Education;
 - (4) one member appointed by the Director of Employment Security;
- (5) 4 legislative members; one of whom shall be appointed by the President of the Senate; one of whom shall be appointed by the Minority Leader of the Senate; one of whom shall be appointed by the Speaker of the House of Representatives; and one of whom shall be appointed by the Minority Leader of the House of Representatives; and
 - (6) one member appointed by the Governor; and be it further

RESOLVED, That the Task Force may hold hearings on the issue of unemployment insurance for contingent academic workers and shall report its findings to the General Assembly on or before July 1, 2010; and be it further

RESOLVED, That suitable copies of this resolution be delivered to the Board of Higher Education, the Director of Employment Security, and the Governor.

Senator Steans offered the following Senate Joint Resolution, which was referred to the Committee on Assignments:

SENATE JOINT RESOLUTION NO. 30

WHEREAS, The United States Supreme Court in Olmstead v. L.C. Ex Rel. Zimring, 119 S.Ct. 2176 (1999), held that the unjustifiable institutionalization of a person with a disability who could live in the community with appropriate supports and services, and wishes to do so, is unlawful discrimination in violation of the Americans with Disabilities Act (ADA); and

WHEREAS, Many individuals with developmental disabilities in Illinois who desire home or

community-based residential services are unable to obtain them due to the unavailability of such options; and

WHEREAS, As a result of insufficient home and community-based service options for individuals with developmental disabilities in Illinois, many individuals and their families must choose between living with their parents or other family members without the supports and services they need, or living in a State-operated development center or another institution, even if they could live successfully in a less restrictive setting with appropriate supports and services; and

WHEREAS, There are now over 15,000 individuals with developmental disabilities in Illinois with documented emergency, critical or future service needs who are on the Department of Human Services' PUNS waiting list for services and supports, and the need is probably greater because this number only represents those individuals who have actually signed up for the PUNS database; and

WHEREAS, Almost 10 years after the Olmstead decision, a recent report titled "The State of the States in Disabilities 2008" by the Department of Psychiatry and Coleman Institute for Cognitive Disabilities of the University of Colorado ranks the State of Illinois 51st in the nation in terms of making small community living arrangements (6 residents or fewer) available to individuals with developmental disabilities; and

WHEREAS, The State of Illinois ranks near the very bottom both nationally and among other Midwest states in per capita spending for home and community-based supports and services for individuals with developmental disabilities; and

WHEREAS, The level of need for individuals with developmental disabilities in Illinois will grow each year as the number of aging caregivers increases; and

WHEREAS, Numerous legislative measures and lawsuits over the last decade have attempted to address the shortcomings of Illinois' fragmented and inadequate system of services and supports to individuals with developmental disabilities; and

WHEREAS, Until the State breaks the cycle of underfunding and lack of significant growth of home and community-based services and supports for people with developmental disabilities and their families which perpetuates short-term measures to address crises in the system and which, in the long term, has maintained and fostered the competition among many for scarce public resources; therefore, be it

RESOLVED, BY THE SENATE OF THE NINETY-SIXTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE HOUSE OF REPRESENTATIVES CONCURRING HEREIN, that the Department of Human Services, Division of Developmental Disabilities, shall develop a 7-year Plan with yearly benchmarks to enhance and expand access to quality community services and supports as described in the recommendations of the "Blueprint for System Redesign" (January 2008) and other reports that have been done, by December 1, 2009; and be it further

RESOLVED, That any increase in the resources available to the Department shall be appropriated to services and supports consistent with the action steps in the Plan considering, but not limited to, funding incentives, maximizing current revenue sources, creating opportunities for capacity building and new rate methodologies that enhance quality service and quality assurance, crisis intervention and workforce development; and be it further

RESOLVED, That the Secretary of Human Services shall provide an annual report on the implementation of the Plan to the Governor and to each member of the General Assembly by not later than July 1 of each year and interim progress reports to the Governor and to the members of the General Assembly not later than December 31 of each year until the Plan is fully implemented; and be it further

RESOLVED, That appropriate committees of the House of Representatives and the Senate shall convene at least one hearing not later than July 1 of each year on the subject of the Plan; and be it further

RESOLVED, That copies of this Resolution be sent to the Governor, the Secretary of Human Services, the Director of the Governor's Office of Management and Budget, and all members of the

General Assembly.

Senator Schoenberg offered the following Senate Joint Resolution, which was referred to the Committee on Assignments:

SENATE JOINT RESOLUTION NO. 31

WHEREAS, The State of Illinois' children, mothers, families and individuals are experiencing economic hardships, increasing stress in their personal and family lives; and

WHEREAS, The loss of jobs, homes, and charitable and government funded services adds to the incidence and severity of mental illness and substance abuse, resulting in increased burdens on law enforcement services and hospital emergency rooms and suffering of children and the families who bear the burden of dealing with those suffering from mental illness and substance abuse; and

WHEREAS, The State of Illinois is in an historic fiscal crisis affecting its ability to maintain support of safety net community care for mental and substance use disorders; and

WHEREAS, The Illinois General Assembly in its wisdom and through the appropriation of both federal and State funds has historically supported community based care provided by community care mental health and substance misuse treatment providers; and

WHEREAS, The Illinois General Assembly's wisdom and prudent appropriations from the Health and Human Services Medicaid Trust Fund have resulted in a significant current balance in this dedicated fund; and

WHEREAS, The Illinois General Assembly in its wisdom has directed additional deposits into the Health and Human Services Medicaid Trust Fund for State fiscal years 2009 through 2013; and

WHEREAS, The recent increase in the Federal Medical Assistance Percentage, also known as FMAP, affords the State of Illinois the ability to pay its financial obligations in a timely fashion, helping to maintain community care provided by mental health and substance misuse treatment community providers; and

WHEREAS, The recently approved Federal Medical Assistance Percentage, also known as FMAP, increase will result in increased deposits into the Community Mental Health Medicaid Trust Fund; and

WHEREAS, A prudent use of a combination of these existing funds would allow the State of Illinois to maintain its current commitments for Illinois children, mothers, families and individuals in need of care and treatment provided by mental health and substance misuse treatment community providers; and

WHEREAS, A prudent use of these existing funds would allow the State of Illinois to address the infrastructure needs of mental health and substance misuse treatment community providers; and

WHEREAS, The State of Illinois can rescue children, mothers, families and individuals in need of community care by using available funds from the increase in FMAP, the available funds in the Health and Human Services Medicaid Trust Fund, and the increased deposits into the Community Mental Health Medicaid Trust Fund, which can help maintain care and treatment and the community care infrastructure; therefore, be it

RESOLVED, BY THE SENATE OF THE NINETY-SIXTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE HOUSE OF REPRESENTATIVES CONCURRING HEREIN, that we do hereby encourage the Governor's Office of Management and Budget to utilize the funds available due to the increased Federal Medical Assistance Percentage, also known as FMAP, along with funds available in the Health and Human Services Medicaid Trust Fund and funds available in the Community Mental Health Medicaid Trust Fund, to maintain appropriation levels supporting current community care

provided by mental health and substance misuse treatment community providers and increase funding to pay the State's obligations in a timely fashion; and be it further

RESOLVED, That we do hereby encourage the Governor's Office of Management and Budget to utilize the funds available due to the increased Federal Medical Assistance Percentage, also known as FMAP, along with funds available in the Health and Human Services Medicaid Trust Fund and funds available in the Community Mental Health Medicaid Trust Fund, to ensure that all rates are sufficient to maintain current community care infrastructure provided by mental health and substance misuse treatment community providers; and be it further

RESOLVED, That copies of this resolution be sent to the Illinois General Assembly, the Office of the Governor, and the Director of the Governor's Office of Management and Budget.

Senator Hunter offered the following Senate Joint Resolution, which was referred to the Committee on Assignments:

SENATE JOINT RESOLUTION NO. 32

WHEREAS, CommunityHealth was founded in 1993 by Serafino Garella, M.D., a board-certified Internist and Nephrologist, as a direct response to the Chicago metro area community's lack of access to reliable health care; and

WHEREAS, CommunityHealth operates an innovative model supported by volunteerism and philanthropy, guiding it to be the leader that defines excellence in delivering comprehensive, patient-centered health care at no cost to low-income, uninsured individuals and families in need of a medical home; and

WHEREAS, CommunityHealth is dedicated to serving the uninsured and underserved in Chicago and surrounding communities, it has provided since its founding upwards of 170,000 medical and education visits for more than 30,000 uninsured men, women, and children; today, CommunityHealth provides medical and educational visits for more than 7,000 patients a year; and

WHEREAS, With more than 650 volunteers, including 285 physicians from Chicago's leading health care institutions, CommunityHealth represents a grassroots response to the needs of the uninsured; in 2008, its volunteers donated more than 42,000 hours of time; its innovative relationships with eight Chicagoland medical schools and residency programs have established CommunityHealth as an important medical-training center; and

WHEREAS, Of the 1.3 million uninsured who live in the Chicago metro area, like the vast majority of the uninsured, most of CommunityHealth's patients are from working families; specifically, 80% come from working families, all lack health insurance, all are living at or below 250% of the federal poverty level, 43% present one or more chronic health conditions, many are new immigrants and don't speak English, and several patients travel great distances to receive CommunityHealth's free care; and

WHEREAS, In the beginning the storefront clinic was open just a few hours per week, today after demand for services ballooned and the number of healthcare volunteers grew, CommunityHealth operates a clinic six days a week, including four evenings and Saturdays, providing a broad range of primary and specialty care, as well as education, health promotion and case management services; all examinations, lab services and medications are free; and

WHEREAS, Thanks to a successful capital campaign, CommunityHealth owns the building that houses its clinic at 2611 W. Chicago Avenue, which in 2005 was renamed the Lederman Family Health Center after CommunityHealth's friend and benefactor Sam Lederman; and

WHEREAS, CommunityHealth is also committed to being a voice for the uninsured and collaborates with local and national organizations that address the growing crisis of the uninsured; through these

efforts, it hopes to improve access to quality affordable health care; and

WHEREAS, CommunityHealth operates almost entirely dependent upon the private sector for support, with gifts and grants from individuals, foundations, and corporations accounting for more than 90% of our revenues; and

WHEREAS, CommunityHealth, through its comprehensive patient services and many institutional affiliations, has become a leader among free clinics nationwide; it offers an innovative model for providing compassionate and comprehensive medical care to the uninsured, and is the largest volunteer-staffed free medical facility in Illinois; therefore, be it

RESOLVED, BY THE SENATE OF THE NINETY-SIXTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE HOUSE OF REPRESENTATIVES CONCURRING HEREIN, that we applaud and honor CommunityHealth in its more than fifteen years of dedicated service to meeting the needs of the uninsured in Illinois; and be it further

RESOLVED, That we urge the Department of Public Health, in cooperation with the Departments of Healthcare and Family Services and Human Services, to identify public-private collaborative opportunities with CommunityHealth to continue its mission to serving the uninsured; and be it further

RESOLVED, That the Department of Public Health shall issue a report of identified collaborative opportunities to the Governor and General Assembly, as well as copies of the report sent to Directors of the Departments of Healthcare and Family Services and Human Services, no later than January 2, 2010; and be it further

RESOLVED, That copies of this resolution be delivered to the Governor, the Directors of the Departments of Public Health and Healthcare and Family Services, and to the Secretary of Human Services; and be it further

RESOLVED, That a suitable copy of this resolution be presented to CommunityHealth as a symbol of our respect and esteem.

By direction of the President in a message journalized February 18, 2009, at 3:01 o'clock p.m., the Senate convened in perfunctory session.
